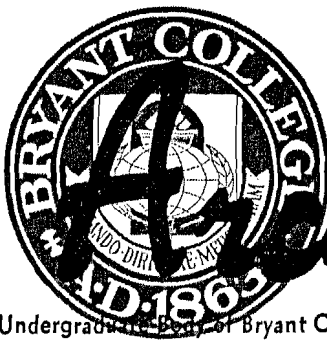

## Bryant College To Be Scene of Rhode Island Italian Festival Convocation

On Sunday, May 7, Bryant College will participate in Rhode Island's "Italian Festival" by holding a convocation on the South Hall Campus. Dr. E. Gardner Jacobs will confer the Honorary Degree of Doctor of Science in Business Administration on six local, national, and international business leaders. This honorary degree is the highest honor given by Bryant.

The six leaders selected to receive the degrees include Dr. Ugo Morabito, Commercial Minister of the Italian Embassy, Washington, D. C.; Gianluigi Gabetti, president of Olivetti Underwood Corporation, New York; Joseph E. Levine, president of Embassy Pictures, New York; Louis A. R. Pieri, president of Rhode Island Auditorium and the Providence Hockey Club; Harold E. Arcaro, Providence attorney and jurist; and Robert C. Laurelli, president, National Plumbing and Heating Supply Corporation of Providence.

Dr. Morabito will deliver the convocation address, "The Italian Economy Today." He is a graduate of the universities of Bologna and Florence. Dr. Morabito has also served as Commercial Counselor in New York, Paris, London, and Bonn.

Before joining Olivette in 1958, Gianluigi Gabetti served in managerial capacities with the Banca Commerciale Italiana in Turin.

Joseph E. Levine has been awarded the Order of Commendatore of the Italian Government, the highest honor the Italian Republic can confer on a foreigner. Mr. Levine, president of Embassy Pictures, has attained international prominence as an importer, distributor, and producer of films.

Louis A. R. Pieri, who received his undergraduate and graduate degrees at Brown University, has been a long-time secretary of Ice Capades, Inc., and was half owner and president of the Boston Celtics.

Harold C. Arcaro was born in Italy and received his law degree from Northeastern University. He has been associated in the practice of law with Senator John O. Pastore. Mr. Arcaro later became a judge of the Providence Police Court, Rhode Island Director of Business Regulations, and a well-known business executive.

Robert C. Laurelli also obtained his law degree at Northeastern University. A founder of the corporation of which he is now president, he is past director of the American Institute of Supply Associations in Washington.

Bryant College has invited nearly two thousand local, national, and international dignitaries to the Italian Festival Convocation. Immediately following the convocation, an "Italian Festa" reception will take place in the auditorium.

Mr. Fernandes was born in the Madeira Islands in Portugal and is a graduate of Norton High School and Boston University, College of Business Administration.

As President and Treasurer, he supervises 17 stores and a 42-million dollar business. He is also Treasurer of a number of Realty Corporations including

To this must be added that he is the co-founder and Chairman of the Board of Staff Foods, a 380-million dollar business. As Special Food Consultant to the International Basic Economy Corporation, he has worked for Nelson Rockefeller since 1958.

Mr. Fernandes is on the Board of Directors of the First Machinists National Bank of Taunton; Manufacturers National Bank of North Attleboro, Massachusetts; Blue Shield; Fall River Line Pier, Inc.; and Goodwill Industries of Boston.

Also he has the title of Vice President of Super Markets Management Association of Massachusetts; he is a member of the Public Relations Committee of the National Association of Food Chains; Norton Lions Club; Lt. Healy American Legion Post 222; Veterans of Foreign Wars; a member of the

Clinic Advisory Committee of the Attleboro Mental Health Clinic; Director of the Bristol County Health Association; trustee of the United Fund; a member of the Norton School Committee; the Chairman of the Norton Library Building Fund Campaign. It was in 1962 that Mr. Fernandes served as Special Consultant Representative to the U.S. State Department concerning the Alliance for Progress. He is also Chairman of the Portuguese-American Federation of the U.S. and Canada.

Mr. Fernandes has received the Knight of St. Gregory the great form from Pope John the XXIII; the man of the year award by the National Conference of Christians and Jews; and an honorary Degree of Doctor of Commercial Science from Stonehill College.

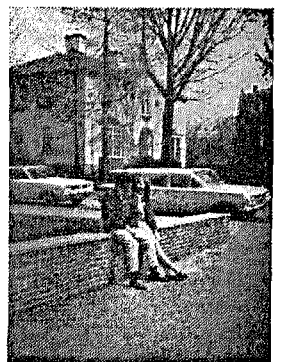
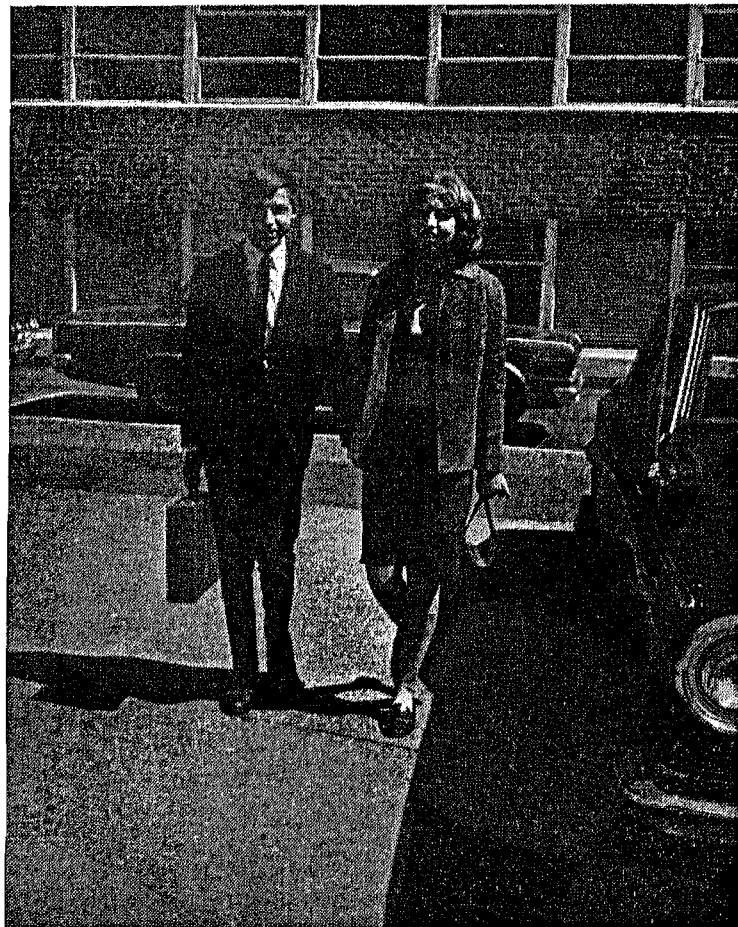

ion, is a trustee of St. Mary's Church, member of the Attleboro District Serra Club, Special Gifts Chairman for the Bishop Feehan Memorial School Appeal, and former Lay Chairman of the Fall River Diocese for Catholic Charities.

Without question Mr. Fernandes has an enormous background of public service; he is just as enormous in the business world, being well versed in economics, management, and accounting. Since 23% of all income is spent on food, it is therefore, the largest industry in the world. Statesmen fail to see the food-for-peace angle of any food program to foreign countries. Success depends on one's being there at the right time and knowing the right people. Timing is important as well and recognizing opportunities as they exist. 35% of our meals are consumed away from home, meaning that institutions are playing a bigger part in the industry. The grocery business hinges on rendering the right service at the right price to the consumer and the consumer's knowing what he is paying for. An eight-step plan was presented by Mr. Fernandes as a formula. (1) Have an objective. (2) Plan and develop strategy. (3) Organization. (4) Staff. (5) Operation. (6) Feedback. (7) Control. (8) Reappraisal to see if you're on target. These steps are really the process of management. The above were his opening remarks before the question-and-answer period. He wanted to answer questions.

What would you say the biggest problem in the industry is? It is excessive competition or over competition. This raises an interesting question. Does competition really benefit the consumer? In practice, after a while all these businesses say why fight each other, and they merge. Then the consumer loses out.

A & P is planning to stop giving out stamps. This took everyone by surprise because there has been no such announcement in the papers. Mr. Fernandes said that "the housewife does pay for the stamps—she must". How much waste is there in the business? Waste usually is concerned with meats and produce or improper price marking. Stolen goods amount to only .0025% or \$200,000 a year. Percent wise losses are 1% on grocery, 3% on produce, and 4% on meats. This is enormously low compared to the same condition in any other country you might like to mention. 40% of the food raised in Brazil never gets to the market. A combination of poor transportation, storing facilities, and market conditions is the cause of this.

Everyone knew that milk prices would be raised, and they were. Consumers are not angry at the markets, but they have no one else to blame. Higher prices are already paid in Vermont and New Hampshire than in the Mid West. Thus, markets

here buy from the Mid West. Personally Mr. Fernandes felt it "morally wrong to throw food away." This milk problem might indicate that there is something wrong with our marketing system. Production of food is the cheapest in the world, and many dollars could be earned if we went into full production and exported all excess. A fair profit could be had. An example in point, tomatoes were allowed to rot because there was no one to pick them. This was caused by the new law not permitting Mexicans to work in the U. S. Frozen foods was the next topic and it was found that frozen foods are cheap to buy but expensive to store—twice as expensive, to use actual figures.

The profit margin is found to be the lowest in New England of any industry, slightly higher in the South and Mid West—1.2% after taxes, meaning that a mistake of 1% in figuring means an \$850,000 loss. Switching to Staff foods, Mr. Fernandes talked about private labels. By using such a label you can sell the same quality but cheaper. All are packed by name brand producers, such as Heinz, etc. Additional costs come from national advertising. By having a private label, a customer loyalty is established, meaning returning customers. What about the labor problems? Fernandes Markets has 1850 employees belonging to an independent union. Pay is good for both skilled and semi-skilled with meat cutters getting \$150, managers \$180 and stock clerks \$135 a week. Extracting what the firm has to offer would be in the form of a staff position instead of working in a local level. Such places promote from within.

International Basic Economy Corporation was started by the Rockefellers because Nelson did not have a job. It was so formed to help emerging nations with food problems. Proving that our system of government can work to other countries has been a main objective. This group sets up markets and trains the people to run them. When they're going concerns, they are sold to local residents. What effect does extracurricular activities have? It is important when first starting out but later on such activities should be selected with care. Some must be turned down. It should be determined whether or not these activities would interfere with business and if they must be dropped.

Such interesting problems arise in figuring what future trends will be and how to meet them. Food discounting is a fine idea and is effective in reducing costs, but if everyone does the same all are on the same level. Corner groceries are growing, but can only grow in a limited market. Most success comes in highly populated areas. Since they fit a need, they should expand and usually work on a franchise principle even being run by a family. High profit items include mostly impulse items. If a husband goes shop-
