Dr. Stanley J. Kozikowski, Dean of Undergraduate Faculty, has announced the appointment of the following new faculty members:

ACCOUNTING

DAVID J. BEAUSEJOUR, INSTRUCTOR OF ACCOUNTING.

Mr. Beausejour holds a B.S. in Business Administration *summa cum laude* from Bryant College, an M.S.T. from Bryant College, and a C.P.A. from the State of Rhode Island. Since graduating in 1979 and until 1983, Mr. Beausejour served as a member of the tax staff at Ernst & Whinney. More recently he has served as a supervisor with Laventhol & Horwath. He has also taught as an adjunctive faculty member at Bryant College. His areas of specialization include taxes, intermediate accounting, accounting theory, and advanced accounting. Mr. Beausejour plans to enroll in a law school program this academic year.

LORRAINE ROBIDOUX, INSTRUCTOR OF ACCOUNTING.

Lorraine Robidoux has been appointed for one year in place of Mr. Marcel Hebert, who is on sabbatical leave. Mrs. Robidoux will teach Managerial and Intermediate-level Accounting. Holding a B.A. degree *summa cum laude* from the College of St. Elizabeth and an M.B.A. with honors from Bryant College, she is presently enrolled in the M.S.T. program at Bryant. Mrs. Robidoux holds a C.P.A. from Rhode Island and serves as owner and manager of an accounting services firm in Woonsocket, RI. In addition, she has taught as an adjunctive faculty member at Fisher Junior College and the Community College of Rhode Island, and recently served as an instructor at Bryant.

Parents' Weekend begins Friday at 9 p.m. with entertainment in three locations. "Shamus and Eileen," a duo, will sing Irish folk music in the Koffler Center. On Saturday afternoon a small group of artists will sketch portraits in the Rotunda at 12:30 p.m., followed by a Karate demonstration at 2 p.m. and a Dance Club demonstration at 3:30 p.m. In the auditorium beginning at noon, Bryant Players will present two one-act mysteries. At 1 p.m. at the Koffler Center, the Student-Alumni Association will sponsor a Jarts tournament.

Saturday evening entertainment begins at 8 p.m. with impressionist John Roarke in the gymnasium. Then at 9:30 p.m., the MAC will host "Girls Night Out," a celebration of '50s and '60s female group songs; the dining hall will host the John Paine Orchestra, a swing band, and Koffler will host a performance by student singer Kelly Parkins. At 10 p.m., Keith Berger, a mime, will perform in the auditorium.

KATHLEEN SIMONS, INSTRUCTOR OF ACCOUNTING.

Ms. Simons holds a B.A. from Edinboro State College, an M.S. from Eastern Connecticut State University, and an M.S.T. from Bryant College. She holds a C.P.A., and is currently enrolled in the doctoral program in Accounting at Boston University. Prior to joining Bryant College, she served as an adjunct faculty member at Quinnebaug Valley Community College and as an instructor at various locations throughout Central Massachusetts and Rhode Island with the Lambers CPA Review program. She has served as a tax consultant on a part-time basis with Arthur Young & Co., and previously served as a staff accountant with Piccerelli & Gilstein. Also, from 1972 until 1983 she served as a full-time elementary school teacher in the town of Putnam, Connecticut. Her areas of special teaching interest include Introductory II Accounting and Intermediate Accounting.

FINANCE

DR. TERRY JOHNSON, PROFESSOR OF FINANCE.

Dr. Johnson holds a B.S. in accounting and an M.B.A. in accounting from Florida State University. His Ph.D., which he received from Louisiana State University in 1970 is in Finance. Professor Johnson has taught at the University of Tennessee, Memphis State, St. Louis University, and more recently, the University of Manitoba. He served as a visiting professor at New South Wales Institute of Technology in Sydney, Australia from 1973 to 1975. His areas of research and teaching include managerial finance, investments, and business statistics. He has authored numerous refereed articles in journals, and has presented many conference papers. He has been named an Outstanding Educator by student groups at Manitoba and Memphis State.

INSTITUTIONAL MANAGEMENT

EUGENE A. PETERMAN, INSTRUCTOR OF HOTEL AND INSTITUTIONAL MANAGEMENT.

Mr. Peterman received a B.S. in Hotel and Restaurant Administration from Cornell University, an M.B.A. in Management from Bryant College, and is presently enrolled in the doctoral program in business at Clark University. He has worked extensively in medical services and food services for the U.S. Navy and with ARA Services, Inc. He served as the medical administrative officer of the U.S.S.

Enterprise from 1971 until 1973. More recently he served as the district manager for ARA Services working over ten different facilities. He has taught at the Community College of Rhode Island and Johnson & Wales College in a variety of subjects related to the hospitality field.

ECONOMICS

SAM MIRMIRANI, INSTRUCTOR OF ECONOMICS.

Mr. Mirmirani earned a B.S. in Economics from the National University of Iran, an M.S. in Business Administration from the University of Dallas, an M.A. in Economics from Clark University, and is currently a Ph.D. candidate in Economics at Clark University. Professor Mirmirani is writing his doctoral dissertation on the Economics of Hospital Management. His areas of specialization include economic theory, the economics of health and medical care, public finance, and international economics. In addition to teaching at Bryant College, Professor Mirmirani taught at Clark University and Anna Maria College.

ENGLISH

DR. JAMES D. MARSDEN, ASSISTANT PROFESSOR OF ENGLISH.

Dr. Marsden has been appointed for one year in place of Dr. Norma Bains, who is on leave of absence. Dr. Marsden holds a B.A. in English from Southeastern Massachusetts University and a Ph.D. in English from Brown University. His doctoral dissertation is on the philosophical influences of certain contemporary American writers. Professor Marsden has served as an Assistant Professor at the University of Puerto Rico and is a researcher and writer with the Center for Research and Writing at Brown University. He also taught on a part-time basis at Brown University and Bryant College. He served on active duty with the U.S. Air Force from 1963 until 1966. He has been involved in a number of writing and editing projects ranging from working on a grammar manual to authoring a newsletter.

MATHEMATICS

KRISTIN BROZ, INSTRUCTOR IN MATHEMATICS.

Mrs. Broz has joined the faculty in an ongoing capacity as a member of the Department of Mathematics. A doctoral student in Applied Mathematics at the University of Rhode Island, Mrs. Broz holds a B.A. from Manhattanville College, an M.S. in Education from Georgia Southern College, and an M.S. in Computer Science from Brown University. Mrs. Broz has taught in a succession of assignments at Bryant College and Georgia Southern College. She is a member of the Phi Kappa Phi National Honor Society.

Radley has been employed in Vienna, Austria as the Assistant Director of Befrienders International, a suicide prevention/crisis intervention telephone service; at St. Paul's School in Concord, N.H. as a teacher of music and religion; and as Assistant Minister at the Central Presbyterian Church in Summit, N.J.

The Rev. Radley lives in Lincoln with her husband, who is rector of St. Paul's Episcopal Church in Pawtucket, and her two children. She leads the Protestant service on Sundays at 11 a.m., and can be reached at the Center for Student Development on Mondays and Thursdays from 10 a.m. to 2 p.m.
