## 709 FRESHMEN ARRIVE TO SWELL ENROLLMENT

A new Freshman class of 709 young men and women began classes on September 8, as Bryant College began its 96th year as an institution.

Newly arrived dormitory Freshmen were guests of the Faculty and Administration on Wednesday, September 3, for a luncheon and bus tour of the State. Four bus loads of students visited at the Quonset Point Naval Air Station, where they saw President Eisenhower's plane, the Columbine, and were escorted through the Dixie Kiefer Memorial Chapel. Other points of interest shown to the new students were the State House, the Mall, Warwick Musical Theatre, the First Baptist Meeting House in America, and the downtown shopping area of Providence.

It is anticipated that this tour of the State will become an annual event during Freshman Orientation activities.

Dean Nelson J. Gulski and Dean Lionel H. Mercier presided at academic orientation assemblies held in the Auditorium for new students in the Business Administration, Secretarial, and Teacher-Training Divisions.

Miss Priscilla Moulton, Assistant to the President, welcomed the new students in the Secretarial School at a special assembly during which President of the College, Henry L. Jacobs, spoke briefly to them.

Later in the week, the Student Senate sponsored an extra-curricular activities orientation assembly to acquaint the Freshmen with the organizations available to them for leisure-time participation.

### PROFESSOR VINAL

He was co-author of two economics books and was the author of a mathematics book entitled, "Mathematics for Accounting and Finance". He had graduated from Harvard in 1904, and received his M.A. Degree from Harvard Graduate School in 1906.

## BRYANT'S FIRST BLIND STUDENT OBSERVES 40th YEAR AS B-I-F EMPLOYEE

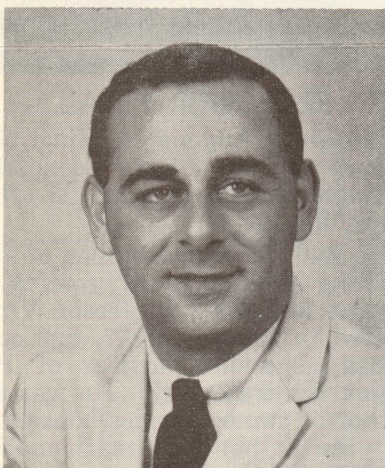
Miss Rose Gadbois, '18, 31 Willow Street, Providence, is surely one of Bryant's most unique alumna. Totally blind since birth, she observed her fortieth year as a stenographer at B-I-F Industries in Providence in August. She has been the recipient of national citations for accuracy in dictation and typing on technical subjects.

In 1917 the then head of B-I-F Industries offered Miss Gadbois a position if she could type from a dictaphone. She said she needed some practice. Several schools turned down her application, but Dr. Henry L. Jacobs, then head of the Bryant and Stratton Commercial School offered to experiment by accepting its first blind student . . . Miss Gadbois.

Because the early transcription machines were not the best, and the regular Braille shorthand had not come into general use, Miss Gadbois perfected her own brand of Braille shorthand. At the office of B-I-F Miss Gadbois is known as an accurate typist, and is often asked to instruct new employees in the use of dictaphones.

Her hobbies are music and reading, and she enjoys opera, Chopin and Rodgers and Hammerstein. She reads books in Braille or listens to them on talking book records, preferring love stories to murder mysteries. Miss Gadbois describes the radio as her "best friend".

### EX-GI, AT 46, RECEIVES HIS DEGREE

At Commencement Exercises, August 1, a graduating senior known as "Cap" to many of his 450 fellow graduates received a bachelor of science degree in business administration. His given name—Edo G. Venditti, 24 Beatrice Ave., Warwick, R. I. The name, "Cap", was a tribute to his retiring rank of captain when he left the Army after 23 years' active duty in 1955.

He joined the Army at 19 and began his duty in anti-aircraft artillery in the Panama Canal Zone. During his career he was in North Africa, Italy, Texas, the White Sands proving grounds in New Mexico, and Japan.

"Cap" recalls that the first question asked at a job interview after he left the Army was from what college he had graduated.

Then he made up his mind that this would be the start of a second career—college. He entered Bryant in the fall of 1955. Many students often took him for a professor.

Now he is seeking a position in the management field, his major study area at Bryant. He was one of the few graduates who brought his own cheering section to Commencement Exercises. In the audience were his wife, Catherine T., (Monti) '34, and his children, Barbara, 2; Elaine, 8; Mary, 10; and Eddie, 12.
