GARDNER HALL DEDICATION DRAWS MANY ALUMNI AND FRIENDS OF THE COLLEGE

HOMECOMING — JUNE 9-10 PLANS ALL SET



Miss Elizabeth Neilan, Chairman of the 1961 Homecoming celebration has announced that all of the committees have met and will make their reports at a meeting scheduled for early February.

This will be the reunion anniversary year for the Classes of 1896 and each fifth year thereafter. It will be the silver anniversary for the Class of 1936 and the golden anniversary for the Class of 1911. The Homecoming Committee is trying extra hard to get in touch with as many members as possible from these classes.

Special guests of the National Alumni Council will be all alumni who graduated over fifty years ago, and particular recognition will be given to members of the Class of 1911. Last year many of these classes, from 1889 to 1910, were represented at the Homecoming luncheon and the Committee hopes to increase the class representation this year.

BROWN UNIVERSITY PRESIDENT BARNABY C. KEENEY DELIVERS DEDICATION ADDRESS

Attendance December 3 exceeded 300 in the Lounge of the newly completed men's dormitory as Brown University President Barnaby C. Keeney spoke to alumni, faculty, and friends of the College.

Secretary of the College, R. Lucien Appleby, presided following the invocation given by The Reverend Robert J. Slavin, O.P., President of Providence College. Vice President E. Gardner Jacobs, for whom the dormitory was named, brought greetings from the College, and spoke briefly of the ongoing development program. He also brought greetings from President Henry L. Jacobs, who is convalescing at home from his recent illness.

The key to the building was presented to Vice President Jacobs by Mr. Harry V. Collins, Sr., the contractor, and Mr. Lloyd Kent, the architect. Doctor Ernest I. Kilcup of the Board of Trustees named the building in recognition of the dedicated work of Mr. E. Gardner Jacobs, College Vice President and administration officer for twenty-seven years.

SIMILAR GOALS

In his dedicatory remarks, President Keeney directed the attention of the assembly to the several colleges on College Hill and their ultimate goals. Brown University, Pembroke College, Rhode Island School of Design, and Bryant College all share a physical part of the Hill and strive to stimulate their students to similar, yet quite different goals. Bryant College is the only one of the group to place emphasis on the technical, professional business training that will integrate its graduates quickly into their chosen field. The other colleges on the Hill place their primary emphasis on a liberal arts program, with professional and specialized study on the graduate level.

All of these institutions are now actively engaged in development and building programs. Curriculum is constantly under revision and is being brought up to high standards.

THE THREE-YEAR COLLEGE

Of particular interest to Bryant alumni are President Keeney's remarks concerning the three-year college. He stated that with the rising costs of education, many colleges and universities must consider this as a solution to increased tuition, utilization of physical plants, and development plans.

The benediction was given by The Reverend Doctor Lawrence I. Durgin, Pastor of the Central Congregational Church in Providence.

A buffet luncheon following the dedicatory exercises was held in the College Dining Hall.

WORK ON NEW CLASSROOM BUILDING COMMENCES



"And the walls came tumbling down..." next to the Administration Building as the former Samways residence was demolished to make way for the new classroom building described briefly in the October *Bulletin*.

H. V. Collins Company, the contractors for Gardner Hall, will construct this new building and expect to have it completed in the Fall.

It will house five typewriting rooms and a biology laboratory for the Secretarial Department. Business Administration students will also use it for office machines classes. The classrooms adjacent to the Henry L. Jacobs Library will be used to expand reading room space and stack area for the library.

Vice President Jacobs has also announced that the Administration Building will be expanded and renovated to provide a new office with an interview area for the Dean of Admissions, a new office for the Bursar, a Multilith room, and a reception room. These improvements in our facilities will be completed by June of this year.

This is the fourth step in the development plans outlined to alumni by Vice President E. Gardner Jacobs at several recent alumni meetings.

You are invited, whenever you are near the College, to stop and see the many changes in the campus and the College facilities.

Placement Office Serves as Effective Lead to Job Placement for Alumni as Well as Graduating Seniors

Alumni are finding the Placement Bureau and its Director, Stanley Shuman, an effective source of leads to new positions and promotion. Seniors have been successfully placed with major companies through on-campus interviews with their field representatives.

Included among the General News in each issue of the *Bulletin* are many alumni placements. Since August 1960 the Placement Bureau has received over 75 requests from men and women who are alumni of the College for job placement. Of these requests, 50 have been filled and the applicant is now on the job. Many of these placements were advancements for the applicants.

Full time staff was added to the Placement Office about a year ago to give more thorough and effective service to our alumni, as well as the graduating seniors. Since last Fall, many of the larger industries who had not previously had a field representative visit the campus sent representatives to interview both seniors and alumni.

"WHAT SHALL I BE?"

PROVIDENCE EVENING BULLETIN SPOTLIGHTS BRYANT ALUMNAE

Since November of last year, the Providence Evening Bulletin has been carrying a weekly feature entitled "What Shall I Be?" in its Women's News Section.

Edited and brightly written by feature writer Miss Marilyn R. Giese, the column has spotlighted several occupational areas in which young women in Rhode Island find interesting, rewarding, and challenging positions. Included in the series were the women's branch of the military service; social workers; secretaries—private, legal, and medical; girls in white—x-ray technicians, nurses, and dental technicians; merchandising; communications—radio and television; public relations; teaching; and air line stewardess work.

Miss Giese, an East Providence High School and Boston University College of Liberal Arts alumna, interviewed young

women in each of these categories for the series. Beginning in November, the last of the ten articles in the series appeared at the end of January. Although the women who were interviewed in each field were chosen at random, six of the ten articles have inadvertently highlighted Bryant alumnae.

Interviewing each of the alumnae pictured on this page, Miss Giese reported they all felt a "confidence" in their work as a result of their training. Several mentioned how their Bryant background had "opened doors" to promotions and post-graduate study. It can be seen from the brief biographies below each picture that the Bryant curriculum formed the foundation for their success in their present occupations; however, it has not limited them in their interests.
