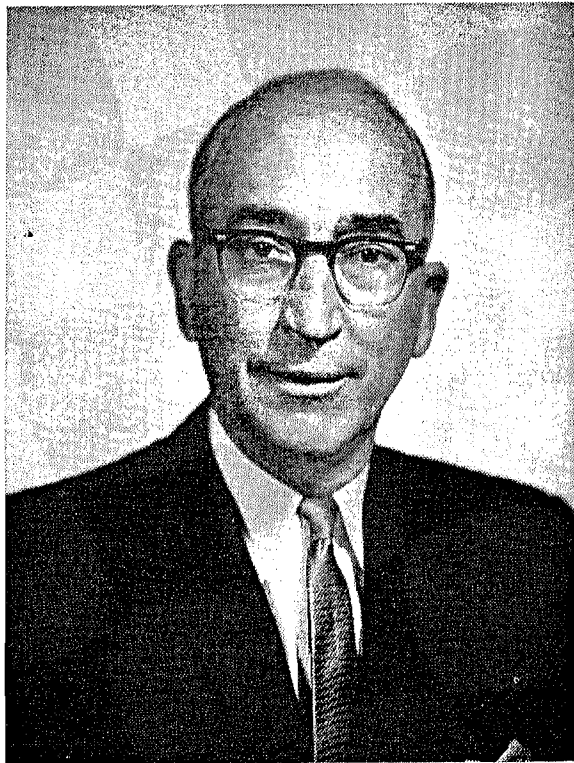

## Dr. Ray L. Heffner, President of Brown University and Bryant Honorary Degree Recipient, will Address Graduates at 1967 Commencement Exercises

Dr. Ray L. Heffner, President of Brown University, will deliver the Commencement Address at the 104th Commencement Exercises of Bryant College to be held at 10:00 a.m. in the Meehan Auditorium, Hope Street, at the corner of Lloyd Avenue in Providence. The Commencement Celebration begins with Class Day held on the previous day, Friday, July 28 at 2 p.m.

Dr. Heffner and two other college presidents will receive the honorary degrees of Doctor of Science in Business Administration. The other college presidents are Dr. Howard W. Johnson, President of Massachusetts Institute of Technology in Boston, Massachusetts, and Dr. Robert E. L. Strider, president of Colby College in Waterville, Maine. The honorary degree of Doctor of Science in Business Education will be conferred upon Dr. Asa S. Knowles, President of Northeastern University in Boston, Massachusetts.

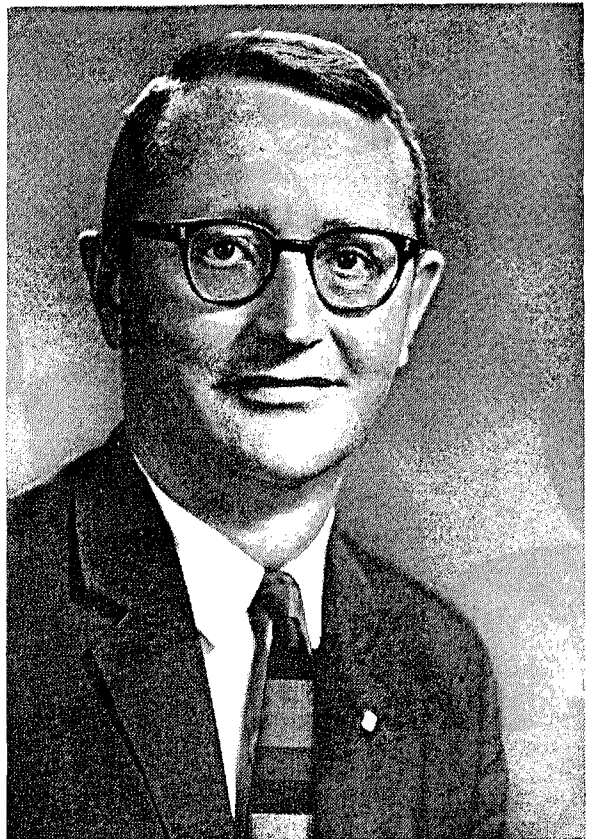

The Class Day Flag Bearers, all members of the Lettermen's Club, are Richard B. Pettee, James R. Squadrito, and Peter F. Sullivan.

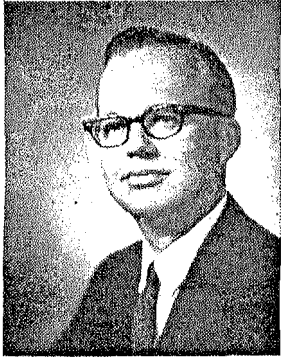
Nancy Edith Finegan of Del-

# Eight Honorary Degrees To Be



Dr. Howard Johnson

**HOWARD W. JOHNSON**  
President, Massachusetts  
Institute of Technology  
Honorary Degree: Doctor of  
Science in Business Admin-  
istration

The twelfth President of the Massachusetts Institute of Technology, Mr. Johnson first came to this school as Associate Professor of Industrial Management and Director of the Sloan Fellowship Program. In 1958 he became Associate Dean and then Dean in 1959.

Mr. Johnson had agreed to become Executive Vice President at Federated Department Stores, Inc., in Cincinnati in December of 1965, when he was recalled to be M.I.T.'s President.

Born in Chicago, Mr. Johnson received his undergraduate degree from Central College in Chicago in 1943 and then served in the Infantry and in military government in Europe and Africa.

After study at the University of Glasgow, Scotland, he became a graduate student at the University of Chicago where he received the M.A. in Economics. He conducted research in the Industrial Relations Center and was Director of Management Programs and Assistant Professor of Industrial Relations and Business Administration in the School of Business and the Division of Social Sciences, a position he held until he went to M.I.T.

Mr. Johnson is the author of a number of professional papers on management and education. He is a former editor for Harper & Row. He is a member of the President's Advisory Committee on Labor-Management Policy.

A fellow of the American Academy of Arts and Sciences and the American Association for the Advancement of Science, Mr. Johnson is a member of the Council on Foreign Relations, the Academy of Management and the American Economic Association.

Mr. Johnson and his wife, the former Elizabeth Weed, of Wilmette, Illinois, have three children.

## CITATION

Yours has been a distinguished career in the advancement of knowledge in the field of business administration. As an associate professor of industrial management and later

as Dean; as director of the Sloan Fellowship Program, and now as President of the Massachusetts Institute of Technology, you have brought renown to yourself and this great educational institution through imaginative development of advanced management programs, not only in this country, but also abroad. You have been personally responsible for expansion of the scope and depth in education and research at M.I.T. You also give your time to serve as a member of the President's Advisory Committee on Labor-Management Policy, as a member of the board of the Federal Reserve Bank of Boston, and several corporate boards. You are a Fellow of the American Academy of Arts and Sciences and the American Association for the Advancement of Science; and you serve as a member of the Council on Foreign Relations, the Academy of Management, the American Economic Association and the Industrial Relations Research Association. Bryant College is pleased to honor your accomplishments by conferring upon you the degree of Doctor of Science in Business Administration, *honoris causa*.

Educated in the schools of Providence, the Venerable Canon William L. Kite was graduated from Nashotah College, joined the Richfield Oil Corporation and rose to Superintendent before he entered the ministry.

He was ordained Deacon at the Cathedral of St. John in 1948 and the same Year was ordained a Priest at St. Mary's Church, Warwick Neck, where he served as Deacon-in-Charge. He was Rector of this church and also of Christ Church in Westerly.

In 1958, he was appointed Archdeacon of Rhode Island by the Rt. Reverend John S. Higgins, Bishop of Rhode Island.

Elected five times as Deputy to the National Church's General Convention, he served as Chairman of the Committee on the Admission of New Dioceses and was a member of the Committee on the State of the Church.

Archdeacon Kite is a trustee of the Lenox School in Lenox, Massachusetts, and represented the Diocese of Rhode Island in 1963 as Delegate to the Anglican Congress in Toronto, Canada. He was President of the Standing Committee of the Diocese and Supervisor of the Missionary Program.

As a member of the Building Committee he was responsible for the new Cathedral House, the renovation of the Cathedral, the restoration of the colonial houses on Benefit Street, and the fifty-one-bed Nursing Home still to be erected.

Archdeacon Kite was awarded the Carnegie Medal for life-saving.

He is married to the former Marjorie Thompson Crowther. They have three children, a son and two daughters.

Educator, administrator, civic leader, your accomplishments in the field of religion as well as in the community you serve have brought you distinction. You have been chairman or a member of numerous committees in this country and Canada dealing with finance and general extension of the Church you represent. Within your Diocese of Rhode Island you have been responsible for administering and arranging financing for a new nursing home, and for planning the new Cathedral House and for renovation of the Cathedral of St. John, and you have held high office in other work of the Diocese. You have served in these posts well, finding time also to add to the culture of Providence by assuming the responsibility for restoring six colonial houses on Benefit Street. Among your many distinctions you also have been awarded the Carnegie Medal for life-saving. Bryant College is proud to recognize your service to Rhode Island by conferring upon you the degree of Doctor of Humane Letters, *honoris causa*.

Born in Kentucky, Mr. Gifford attended the Peckskill Military Academy of New York State

and received his college degree at Brown University.

He began his career in business in New York City, leaving his first position with the C. H. Gifford Real Estate Company to go into the Navy where he became a Lieutenant and did staff personnel work. Returning to the business world, he became associated with G. H. Walker Investments. Following this, Mr. Gifford was appointed Vice President of the Phenix National Bank which was purchased by the Rhode Island Hospital Trust Company, Rising from the position of Vice President he became President of the bank in 1963.

Mr. Gifford's business affiliations include that of member of the Executive Council of the American Banker's Association; Chairman of the Stockholders Advisory Committee of the Federal Reserve Bank of Boston; Director of the Pacific National Bank of Nantucket, Massachusetts; Technical Systems Ltd. of London, England, Trustee of the Providence Preservation Society, and many others.

He is a corporation member of the Butler Hospital, a life member of the Miriam Hospital and holds memberships in the Rhode Island Hospital, the Providence Child Guidance Clinic and the Rhode Island Association for the Blind among many others.

A former Director of the American Cancer Society, Rhode Island Division, he also served as 1964 Chairman of the Episcopal Charities of Rhode Island, and Fund Drive Chairman of the National Conference of Christians and Jews. Mr. Gifford is a Director and Member of the Executive Committee of the Rhode Island Association for Retarded Children and is the 1967 General Chairman of the United Fund, Inc.

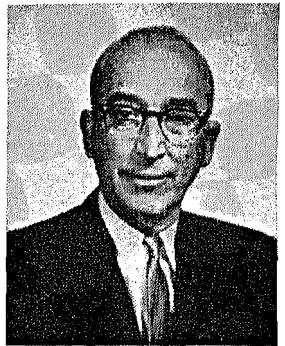

A Professor of Accounting at Bryant for more than thirty years, R. Lucien Appleby interrupted his teaching career when he was appointed Assistant to the Budget Director and Comptroller of Rhode Island, and in 1937-40 served as a State Auditor. He became Secretary and Assistant Treasurer of Bryant College in 1956. In that same year he was elected a member of the College Board of Trustees.

A member of the Scholarship Committee for the National Office Managers Association of Providence, Mr. Appleby is a former Director of the National Association of Cost Accountants.

He served as Chairman of the Red Cross Campaign of West Warwick and was recently a member of the Executive Budget Committee of the United Fund.

For the past two years, Bryant College has lent its efforts to the Dominican Republic in Santo Domingo in establishing a Junior College of Business Administration, the first in that country. Mr. Appleby is the College Coordinator for this project.

Mr. Appleby lectures to civic and religious organizations and for radio and television. He is a member of the Eastern Business Teachers Association, the Rhode Island Teachers Institute, and the Administrative Management Society.

He resides with his wife, the former Mary Thornton, who was head of the Music Department of the Rhode Island College of Education, in Warwick, Rhode Island.

He began his career in teaching at Jefferson Junior High School and after holding several positions in business adminis-

tration, including that of accountant for the Eastman, Kodak Company, Manager of Radio Station WHEC, Announcer Manager, Rochester Chamber of Commerce, he joined the Rochester Business Institute in 1928 as General Manager and became President in 1934.

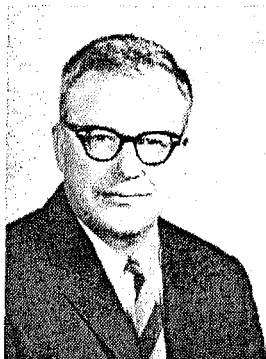
Dr. Veigel has remained a teacher throughout his administrative years and still teaches a class in "Investments."

In 1960, Dr. Strider became the seventeenth President of Colby College, Waterville,

Maine. He was formerly on the faculty of Connecticut College, New London, Connecticut, where he was a member of the English Department until 1957 when he was appointed Dean of the Faculty at Colby. He was graduated from Harvard in 1939, received his A.M. in 1940, and his Ph.D. from the University in 1950.

A native of Wheeling, West Virginia, Dr. Strider served as a lieutenant in Naval Communications. Prior to military service, he was assistant in undergraduate courses at Harvard. His academic specialty is the seventeenth century. He is the author of Robert Greville, Lord Brooke, a seventeenth century writer and public figure, published by the Harvard University Press.

Dr. Strider is a Fellow, American Academy of Arts and Sciences; immediate past President, New England Association of Colleges and Secondary Schools; Chairman, Commission on Liberal Learning, Association of American Colleges; member, Council of the Federation of Regional Accrediting Commissions on Higher Education; Vice Chairman, Maine Advisory Committee, U. S. Commission on Civil Rights; former member of the Advisory Council of the Danforth Foundation and the New England Colleges Fund; Trustee of the General Theological Seminary in New York, and a Director of the Maine Citizen's Association for Cooperative Planning.

He is married to the former Helen Ball. The Striders have two sons and two daughters.

President of one of New England's leading colleges, accomplished educator, academic authority on the Seventeenth Century, author and civic leader, you are renowned in the field of education. You have served as assistant in undergraduate courses at Radcliffe and at Harvard University, your alma mater, as a member of the faculty of Connecticut College, as Dean of the Faculty at Colby College, and since 1960 as President of that institution. You are a Fellow of the American Academy of Arts and Sciences and you have filled leading offices in numerous commissions on higher education nationally and in New England. Recognizing your abilities as an educator and administrator, Concord College, Nasson College and the University of Maine have conferred upon you honorary doctorates. President of Northeastern University

Honorary Degree: Doctor of Science in Business Education

President of Northeastern University since 1959, Dr. Knowles began his career there as Assistant Professor of Industrial Management in 1931, becoming in turn Associate Professor of Industrial Engineering and Dean of the College of Business Administration.

In 1942 he was appointed Dean of the School of Business Administration and Director of General College Extension at the University of Rhode Island where he was recently awarded the honorary degree of Doctor of Business Administration.

Dr. Knowles was President of the Associated Colleges of Upper New York until 1948 when he accepted the position of Vice President of University Development at Cornell University. He left the presidency of the University of Toledo in 1958 to head Northeastern University.

Born in Northeast Harbor, Maine, Dr. Knowles was educated at Thayer Academy, Bowdoin, and did his graduate studies at the Harvard Business School and Boston University.

A former member of the Board of the Regional Community Colleges, he serves on the Board of Directors of the National Shawmut Bank of Boston and as Corporator of the Provident Institution for Savings. He is a member of the Higher Education Facilities Commission of the Commonwealth of Massachusetts; Chairman of the Commission on Institutions of Higher Education of the New England Association of Colleges and Secondary Schools, Inc., and of their Council of Federation of Regional Accreditation.

Dr. Knowles holds the Taylor Key for Contribution to Management by the Society for Advancement of Management. He was awarded the U. S. Army Distinguished Civilian Service Medal and Citation and is a member of many scholastic and fraternal honor associations.

Rare, indeed, are accomplishments such as yours in the field of education.
