HONORARY ALUMNUS PARTICIPATES IN SALE OF EMPIRE STATE BUILDING

An honorary degree recipient this past July, Dr. Louis R. Menagh, President of the Prudential Insurance Company, was a participant in the recent sale of a New York City landmark, the Empire State Building, by Colonel Henry Crown of

Chicago to the Company.

The sale of the property for 65 million dollars is the largest single sales trans-action involving a single building ever completed. Participating in the sale were 34 principals at Prudential's headquarters in Newark, New Jersey. The transaction took over 100 attorneys, a 400-page contract, and four hours to complete. The principals followed the closing transaction with a 26-page agenda to facilitate proceedings.

To minimize confusion, some of the special consultants retained by the Company had held eight "dress rehearsals" during the two weeks prior to the closing.

Although the Prudential Insurance Company is the owner of the Empire State Building, the operating control is publicly held.

JULY 1961 CLASS OFFICERS ANNOUNCE SCHOLARSHIP LOAN RECIPIENT

Officers of the July 1961 graduating class have notified the College that the balance of money remaining from their fund-raising activities has been awarded to a member of their class, Ambrose J. McNamara.

He is presently attending Boston University Graduate School and will com-

plete his degree work in 1963.

The sum of \$350. is on loan to "A.J." and is to be repaid, with interest, within five years after completion of his degree work. It is hoped that the money will then be again made available to a graduate student on a loan basis.

C. H. RYAN NAMED DEPUTY TO POSTMASTER GENERAL

A member of the evening division from 1937 to 1938, Charles H. Ryan, was named deputy assistant postmaster general for operations on January 5.

Mr. Ryan joined the Post Office Department in January 1961 after serving for six years as a staff member to United States Senator Theodore Francis Green. For the past year he was a special assistant to Mr. Frederick C. Belen, assistant postmaster general for operations.

In his new position, Mr. Ryan will be deputy to Mr. Belen and will be the second ranking officer in the Post Office Department's Bureau of Operations, which oversees the day-to-day operation of the 36,000 post offices in the United States.

There are six deputy assistant post-masters general. An assistant postmaster general heads each of the department's five bureaus and each has a deputy except Mr. Belen, who has two.

The selection of Mr. Ryan for this position was "a result of the outstanding job he has done" as assistant to Mr. Belen during the past year, said Mr. James F. Kelleher, special assistant to the postmaster general.

Before joining Senator Green's staff in 1955, Mr. Ryan was employed by the United States Immigration and Naturalization Service. He was associated with the Navy at Quonset Point from 1945 to 1949, and during World War II served with the United States Army as an artillery sergeant.

He is married to the former Miss Henriette Cote of Warren, Rhode Island, and they have five children. The Ryans reside in Fairfax, Virginia.

From the President's Office...

A significant step was realized in December when the application of Bryant College was given consideration at the annual meeting of the New England Association of Colleges and Secondary Schools.

The Visiting Committee presented a unanimous report in favor of accreditation of Bryant College as a specialized institution. This report was a result of a study made by the Committee on campus. All areas of administration, programs of study, and social activities were investigated.

The Standing Committee for Institutions of Higher Education, which gives final approval to membership applications, placed weight upon other factors, however, and voted not to approve our application for membership at this time. They have made several recommendations upon which the College is taking immediate action.

The fulfillment of these suggestions will permit the College to resubmit its application for membership in the Association at its next meeting.

VARSITY BASKETBALL RETURNS

After an absence of eight years, the "Indians" of Bryant are once again flying the flag of varsity competition. We will be represented this year in basketball and baseball.

The basketball season has been under way for some two months under the tutorage of coach Charles Vermette. Vermette formerly played for Providence College, has coached several local teams to championships, and is a member of the Rhode Island Basketball Officials Association.

The team, playing without the benefit of one scholarship player, is comprised of what amounts to an all-star group from the fraternity league, all members being ineligible for frat competition. The Indians are using the Hope High School gym as their home court.

Lacking experience in varsity play the team has started slowly, as might be expected. Their present record of one win and five losses is not as bad as it sounds. The club lacks height, a serious disadvantage which was obvious when they lost a well-played contest to the taller and more experienced Davisville Seabees by 12 points.

Early in December, the Indians journeyed to Babson Park, Massachusetts, for the Babson Invitational Tourney. In the opening game, behind the heads-up play making and shooting of guard Dave Barber, the Indians leading scorer with a twenty plus average, Bryant eliminated favored host team Babson. Breaking open a close game in the first ten minutes of the second half by a superb fast break, the Indians held off a late Babson rally to win.

In the semi-finals on the following day, the Indians lack of height and experience was pointed up as a slick and rangy University of Hartford five eliminated them without much trouble.

The Indians played their first home game before an enthusiastic crowd at Hope High, losing to New Haven College by two points in the dying seconds of the game. Gerhard, Barber, and guard Everett Chadwick led the team in a contest that could have gone either way right down to the final buzzer.

Just before the Christmas recess the Indians were faced with their most severe test of the season when they met the highly rated Providence College Freshmen. Bryant made a good game of it for three-quarters of the first half before succumbing to the tall and speedy Friarlets. P. C., incidentally, started two men in the game that were bigger than the tallest Indian, Neil Gerhard, who is 6'4". The type of play shown by P. C. that night can be measured best, perhaps, by the talent their freshman squads have sent up to the varsity in the last few seasons.

The team is being led in scoring by guard Dave Barber, a brother of Phi Sigma Nu. This agile senior from Hudson Falls, New York, has performed well, with several of his efforts bordering on the brilliant. He has been ably assisted

in the back court by another senior representing Chi Gamma Iota, Everett Chadwick, from Providence. Chadwick has also had some nifty nights at finding the hoop.

Neil Gerhard, the big man on the squad, hails from Hillsdale, New Jersey, and is also a Chi Gam brother. In every game thus far Gerhard has been up against at least two men as tall as he, and in most instances, taller. The other starters, Buddy Westcott and Howie Coleman, have shown great efforts off the boards, but lack the height. Capable performances from reserve players have been turned in by Dave Christensen and Howie Redstone, along with Bill stanton. Of these three, Stanton, a junior, shows the most promise for next year.

Varsity competition has been warmly received by the student body, faculty, and administration. The long road back must be travelled slowly, but everyone here at the College is looking forward to a great deal of success from the Indian camp in the future.
