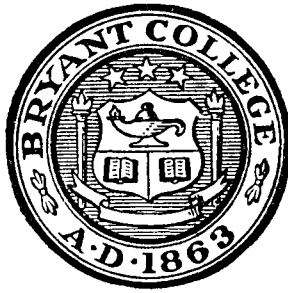

DOCTOR OF HUMANE LETTERS (L.H.D.)

ABRAHAM A. RIBICOFF

United States Secretary of Health, Education, and Welfare

Twenty years of public service preceded Mr. Ribicoff's appointment by President Kennedy to his Cabinet post on January 20, 1961. He was twice elected Governor of Connecticut and twice elected a Connecticut Representative in the United States Congress. He served two terms as Judge of the Hartford Police Court, and was twice elected a member of the Connecticut Legislature, the first time at the age of 28. In his first term he was elected the "most able legislator" in the poll taken by newsmen covering the State capitol. During his term as U. S. Congressman, he served on the Foreign Affairs Committee.

Major divisions of the Department he heads are, The Social Security Administration, The Public Health Service, The Office of Education, The Food and Drug Administration, the Office of Vocational Rehabilitation.

Born in New Britain Connecticut in 1910, he attended the public schools of this city and upon graduation from high school went to work in a hardware factory to save for a college education. After attending New York University for one year, he was sent by this firm to open an office with the understanding that he could also attend the University. A 1933 cum laude graduate from the University of Chicago Law School, he was an editor of the Law Review and a member of the Order of the Coif, national legal honor society. He and his wife consider Hartford, Connecticut, their permanent residence. The couple have two children, Peter, a teacher in a high school at Alameda, California and a daughter, Jane, in college.



DOCTOR OF SCIENCE (D.S.)

ERNEST I. KILCUP

President, The Davol Rubber Company

Dr. Kilcup died on Monday, July 10. His posthumous degree will be received by his lifelong friend, Dr. William D. Fales, Dean of Men, Bryant College

Upon the death of Charles J. Davol, Mr. Kilcup became President and Treasurer of the Davol Rubber Company, thereby assuring the organization continuity of managerial policies due to his long business friendship with Mr. Davol.

Mr. Kilcup was born in Providence, and attended the City's public schools and Brown University. After three years in the employ of the Davol Rubber Company, he was made Credit Manager. He rose to Assistant Secretary-Treasurer, a Director, and in 1932 became Managing Executive.

Initiating many employee benefits, he was first to establish Blue Cross and Retirement Plans. His work in the pharmaceutical fields was recognized by an Honorary Degree from the Rhode Island College of Pharmacy in 1937.

He taught Economics, Marketing, Merchandising and Financial Management at Northeastern University and was awarded a Master of Science in Business Administration Degree by Bryant College in 1937.

Mr. Kilcup was a member of the Board of Trustees of Bryant College, Director of the Citizen's Savings Bank, the Automobile Mutual Insurance Company of America, the Phoenix Division, Rhode Island Hospital Trust Company, and the Factory Mutual Liability Insurance Company of America. He was a member of the Board of Trustees of the Osteopathic General Hospital of Rhode Island, and recently retired as a Director of the Emma Pendleton Bradley Home, which cited him for his services to that organization.



DOCTOR OF LAWS (LL.D.)

LOUIS R. MENAGH

President, The Prudential Insurance Company of America

The first president of the Prudential to have worked his way to the top. Mr. Menagh began his career clerking in the firm's actuarial department during a summer vacation while a student at Rutgers's University. Upon his graduation from college, he joined as a full-time employee.

He became Assistant Actuary after working and studying in this field. After this he branched out into other company activities until he was appointed Assistant Comptroller in 1939 and shortly thereafter Comptroller. He was elected Vice President in 1947.

Working closely with the president, he was designated executive vice-president in 1957 and now is President.

A fellow of the Society of Actuaries, he is a former president of the Insurance Accounting and Statistical Society and the founder of the New York Accountant's Club. Chairman of the Newark Council of Rutgers, he works for the interests of his Alma Mater. For more than two decades he has served on the insurance industry's Federal Income Tax Committee and in this capacity worked closely with Washington officials to maintain an equitable income tax formula for the life insurance industry.

Mr. Menagh was born in Brooklyn, New York. He has resided in New Jersey since early childhood and he attended the public schools of Jersey City.

DOCTOR OF SCIENCE IN EDUCATION (D.S. in Ed.)

FRANCIS H. HORN

President of the University of Rhode Island

Toledo, Ohio, is the birthplace of Dr. Horn, who also attended the public schools of that city. He was graduated from Dartmouth with honors in English and earned the degrees of Master of Arts from the University of Virginia and Master of Arts and Doctor of Philosophy from Yale University. He has received Honorary Degrees in Law, Letters, Humane Letters and Civil Law.

He taught at the American University in Cairo, Egypt from 1930-33 and later became head of the Junior College of Commerce now Quinnipiac College in New Haven, Conn. From 1942 to 1946 he served in the army, rising from First Lieutenant to Lieutenant Colonel. His decorations include the Legion of Merit and the Army Commendation Ribbon with cluster.

His last Army assignment was as assistant dean of Biarritz American University, the U. S. Army University in France. He became Associate Professor of Education at Johns Hopkins in 1947 and dean of the evening division and the summer session.

After serving as Executive Secretary of the Association for Higher Education in Washington, D.C., he became President of Pratt Institute in New York. He came to the University of Rhode Island in 1958 after serving as Distinguished Visiting Professor of Higher Education at Southern Illinois University.

The author of many articles and reviews in the field of education, he has edited "Current Issues in Higher Education," "Literary Masterpieces of the Western World" and was at one time editor of the College and University Bulletin. He is a member of Phi Beta Kappa and other honorary educational and professional organizations.



DOCTOR OF SCIENCE IN BUSINESS ADMINISTRATION (D.S. in B.A.)

EDMUND COOPER MAYO

Chairman of the Board, The Gorham Corporation

Born in Old Point Comfort, Virginia, Mr. Mayo attended Washington, D. C., public schools. He was graduated from the University of Maryland with the degree of Mechanical Engineer and received the honorary degree of Doctor of Engineering from his Alma Mater.

He began his career in industry with the Newport News Shipbuilding Company as a machinist's helper. Following this he became assistant to the superintendent of the American Locomotive Company of Richmond, Virginia, and later general manager of the Cameron-Tennant Machine Works. After serving as Vice President and General Manager of the Viaduct Electric Company of Maryland, he came to New England as General Manager of the Worcester Pressed Steel Company, engaged in manufacturing munitions during World War I. From 1919 to 1924 he was President and General Manager of the American Tube and Stamping Company.

In 1924 he joined the Gorham Manufacturing Company in Providence as Vice President and General Manager, becoming President in 1925, a position to which was added the Presidency of the Alvin Corporation and which he held until 1959.

He was Chairman of the Jamestown Ferry Authority from 1954 to 1956 and Chairman of the Advisory Council of the Rhode Island Development Corporation from 1952-1955.

Mr. Mayo is a director of the Manufacturer's Mutual Fire Insurance Company, the Industrial National Bank, the Providence Journal Company, Liberty Mutual Insurance Company, and Davol Rubber Company.

Mr. Mayo was a term member of the Corporation of the Massachusetts Institute of Technology. He is presently a trustee and Vice President of the Rhode Island Hospital. He is a former trustee of the Rhode Island School of Design, a member of the American Society of Mechanical Engineers, the American Iron and Steel Institute, the Newcomen Society and Tau Beta Pi, a national honorary engineering fraternity.

DOCTOR OF SCIENCE IN BUSINESS ADMINISTRATION (D.S. in B.A.)

JACKSON MARTINDELL

Chairman of the Board, American Institute of Management

A native of Texas, Mr. Martindell received his college education at the University of Colorado and Columbia University. He began his career as Public Utilities Editor of the Magazine of Wall Street and later as Chief Statistician for Stone & Webster. In 1932 he became president of the Fiduciary Counsel Inc., an investment concern.

He formed the American Institute of Management in 1948, a non-profit research foundation for the advancement of management. He has been Chairman of the Board and Chief Executive Officer of this organization since April, 1957. He has also directed many other business organizations and civic welfare groups.

The author of "The Scientific Appraisal of Management" published by Harper & Bros., he has written many articles and lectured on this subject.

As Chairman of the Board of Marquis "Who's Who" Inc., he also Controls "Who's Who In America," "Who's Who In Commerce and Industry," and all "Who's Who" publications.

Mr. Martindell has received honorary degrees in Law and Science from other institutions of higher education.



MASTER OF SCIENCE IN BUSINESS ADMINISTRATION (M.S. in B.A.)

HECTOR A. GILMAN

Vice President, Industrial National Bank

A graduate of the West Warwick High School, Mr. Gilman was graduated from Bryant College, studied law at Northeastern University, and various courses at the American Institute of Banking.

After several years as a teacher at Bryant College, he became a Cost Accountant of the Gorham Manufacturing Company. He resumed his relationship with his Alma Mater in 1928 when he became Business Manager of the College. Following a position as Manager of the Arctic Office of the Union Trust Company, he continued his career in banking with the Industrial National Bank rising to his present position as vice president and member of the Board of Managers of several branch offices.

He is the director of several corporations including the Columbia Amusement Company and affiliates, the Champlin Lumber Co. and others. He is also the Director-Treasurer of the West Warwick Chamber of Commerce.

Incorporator for the West Warwick Library, Inc., he is also a Director of the Pawtuxet Valley Nursing Association. He is a Charter Member of the West Warwick Lions Club, a member of the American Institute of Banking and other Professional and Civic organizations. A Trustee of the Kent County Memorial Hospital, he is also Chairman of its Building Committee and a member of the Finance Committee.
