## "The Status of Women in America"

### A Symposium and Convocation November 18

ON OCTOBER 11 President John F. Kennedy will receive a report culminating two years of study by a Commission on The Status of Women in America, and on November 18 Bryant College will devote its major Centennial Convocation to the same subject. The chairman of the President's Commission, Mrs. Esther Peterson, Assistant Secretary of Labor, will preside over a symposium and panel discussion on the topic in our auditorium. The panel of women will represent business, politics, education, civic groups, religion, and medicine.

When President E. Gardner Jacobs opens the symposium on November 18 at 9 a.m., he will begin the first major national event to honor the achievements of women following The Status of Women in America report. Excitement among community committees is running high, as it well might.

Miss Marion Stephenson, Vice President of the National Broadcasting Company, is general chairman for the Symposium and Convocation, and will preside at the Convocation. As you may remember, she is the first woman vice president of N. B. C., and received an honorary degree at our commencement in July.

Mrs. Margaret Ackroyd, Commissioner of Minimum Wage for Rhode Island, is chairman of the Women's Symposium Committee. This committee was invited by the College to assist in planning the event and consists of prominent women in the community.

Miss Claire Ernstof '29 and Dr. Grace Glynn '62H are members of the Symposium Committee. Claire is office manager of Cadillac Textiles, Inc., in Cumberland. Dr. Glynn is Rhode Island Associate Commissioner of Education.

The degree of Doctor of Science in Business Administration, honoris causa, will be conferred upon Assistant Secretary Peterson at the convocation in the afternoon.

U. S. Senator John E. Fogarty '59H will be the principal speaker at the convocation. In the capacity of chairman of the House Committee on Health, Education, and Welfare, Mr. Fogarty plays an influential role with regard to legislation affecting women.

An academic procession, preceding the convening of the convocation at 4 p.m., will include representatives from many area colleges, faculty, and distinguished guests.

**A** lively group of students will gather at the home of faculty member Wallace Camper this month to recapture some of the nostalgia, local flavor, and what-have-you of their recent 41-day business-study tour of Europe.

Our description will content itself with the highlights of the tour.

Tour guide Camper spent the winter briefing these young people through the use of slides, talks, and language prac-

tice and continued his orientation on the S. S. France as the group sailed from New York City on July 26.

A week later, and a shipboard ping-pong championship for Camper, Paris unfolded her charms to them. Aside from visiting tourist attractions in the City of Light, they toured Ricard & Company, wine merchants, and were guests of Monsieur Ricard for dinner at his chateau, "La Vocine", in Clairefontaine, about 45 miles outside Paris.

The overnight train ride to Geneva, Switzerland, brought picture-book scenery to life and a chance to swim in Lake Geneva. From this time on until they left Oostende, Belgium, four weeks later, this happy group would share a bus with a Swiss driver named Robert Pflander.

Following an overnight stay in Zermatt at the foot of the Matterhorn, they travelled to Milan, Italy. In Metonopoli, outside Milan, they observed a self-contained city for 10,000 employees, the administrative offices and laboratories of the government created E. N. I., the Italian State Corporation for oil and natural gas.

In Florence, Italy, noted for its leather goods and cultural sights, and in Rome, the Eternal City, they captured the feeling of the traditions and culture that inspire everyone who visits. As guests of the Italian government, they visited the Leonardo da Vinci International Airport, the third busiest airport in the world and a busy center of commerce and trade.

Dr. Paolucci de Calboli of the Ministry of Foreign Affairs lectured to them one

evening about the relationship of Italy to the Common Market. It was his general feeling that Italy considers it wise to do business with Communist nations, even though politically she is not aligned with the communist bloc, and does not feel that she will become dependent upon this trade.

Several motor scooter rides later, the group left for Pizzaro on the Adriatic Sea, a coastal town that offered excellent bathing and beach facilities.

In Venice—more than 100,000 other tourists were there this particular week—they toured a glass factory just off

San Marco Square. Swimming at Lido Beach, reached by motor launch from Venice, was thoroughly enjoyable and refreshing.

Travelling through the Brenner Pass, with an overnight stop at Innsbruck, the group welcomed the sight of the picturesque scenery of Germany. Outside Munich, a visit to the Linderhof Castle recalled the splendor of former years of rule under the Bismarcks.

The following day in Stuttgart, Germany, the Daimler-Benz Corporation permitted them to see their plant, from raw material to finished product, followed by lunch in the executive dining room.

When the group arrived in Dusseldorf for sightseeing, they were met by a group of German students who acted as their guides and escorts for a night on the town. Here was an opportunity and challenge to exchange ideas and to meet the German people. Challenge accepted.

During the canal ride around the harbor of Amsterdam, they were able to see the home of Anne Frank and later visited a diamond factory. U. S. Deputy Commissioner William Hamilton met them in Brussels and lectured about the United States' relationship to the Common Market.

Going on to Oostende in Belgium, then by steamer across the English Channel, they caught their first glimpse of the white Cliffs of Dover. From Dover to

London's Victoria Station by boat train left them almost a week to tour the National Museum, Buckingham Palace, take in some plays, and do a great deal of shopping.

A visit to the International Division of Midland Bank, one of England's largest, prompted a discussion on France's refusal to allow England into the Common Market. The British Federation of Trade & Industry also provided a representative to tell of the state of industry in England.

Just a week before the new school year began, they returned on the S. S. France to New York City.
