## HONORARY DEGREE RECIPIENTS



Lisa Churchville Honorary Doctor of Humane Letters

Lisa Churchville, president and general manager of NBC 10 Providence/New Bedford, winner of an Edward R. Murrow Award for Excellence in local news this year, will give the keynote address at Commencement exercises for the Graduate School of Business. Churchville came to NBC 10 in Providence in 1997 from WCAU-TV in Philadelphia, Pa., where she was vice

president of sales. Prior to that, she served in several key positions at WMAQ-TV in Chicago, Ill. She began her career in 1986 at NBC in New York and also worked in advertising sales for ABC and WABC-TV in New York City. Churchville's academic involvement includes serving on Brown University's Civic Leadership Council and the Providence College President's Council. She has taught or been a guest lecturer or speaker at colleges and conferences throughout the United States and abroad. She currently serves as Chair of the Board of Trustees of the Providence Public Library, is a board member of Women & Infants Hospital, and has served as Chair of the Board of the Rhode Island Philharmonic Orchestra and Music School, the Greater Providence Chamber of Commerce, and the Arts & Business Council. Churchville holds a bachelor's degree from Columbia University: Barnard College and a Master of Business Administration degree from Harvard University.



Ernest A. Almonte '78, '85 MST Honorary Doctor of Business Administration

Ernest "Ernie" Almonte '78, '85 MST, has more than 30 years of experience in the accounting profession. He has been Auditor General for the State of Rhode Island since 1994. Almonte is responsible for the auditing of the \$7 billion State Comprehensive Annual Financial Report, the \$3 billion Federal Single Audit, Municipal Oversight, Performance Audits, Fraud Audits, and

oversight of quasi-public agencies. From 1982-1994 he owned his own CPA firm in Smithfield, R.I. The recipient of many distinguished national awards, including The Department of the Army Outstanding Civilian Service Medal, Almonte was named one of the Top 100 Most Influential People in the Accounting Profession by Accounting Today in 2005 and 2008. He served on the Bryant Board of Trustees from 1993 to 2002 and is past chair of Bryant's National Alumni Council. He currently serves as chairman of the American Institute of Certified Public Accountants. He holds a Bachelor of Science in Business Administration and a Master of Science in Taxation from Bryant University.

#### THE HARRIET E. JACOBS MEMORIAL MACE

The University Mace is carried at Commencement exercises and at other University celebrations. Crowned in gold, the mace has two dominant emblems: the seal of the State of Rhode Island and the seal of Bryant University.

#### THE PRESIDENT'S CHAIR

The President's Chair, a gift to the University from Priscilla Angelo and her husband, John Eng-Wong, is used on ceremonial occasions. It is a Victorian-style gent's chair rendered in walnut and copied from an original French design from the period of the University's founding in 1863. The carved crest top includes the Bryant University bronze seal.

#### **BRYANT MEDALLION**

The Bryant Medallion is worn by the president during academic ceremonies such as Commencement, Convocation, and the bestowing of honorary degrees. One side of the medallion bears a likeness of the University seal, the other, the names of all Bryant University presidents. The formal installation of a president is marked by the presentation of the medallion to the president by the chair of the Board of Trustees.

#### THE BRYANT SEAL

The Bryant Seal represents the educational mission of the University and its worldwide implications. The central symbol is an ellipsoid globe with quills on each side to signify the traditional emblem of communication in business. In the center, behind the globe, is a torch symbolizing liberty, the spirit of free inquiry, academic freedom, and learning. The Archway, forming the background for the globe, torch, and quills, is a University landmark affectionately remembered by thousands of alumni. The Latin motto expresses the purpose of the University: "Cognitio. Virtus. Successus." – Knowledge. Character. Success.

#### ACADEMIC HERALDRY

The history of academic dress worn today dates back to the universities of the Middle Ages. A statute in 1321 required the wearing of gowns by all scholars and clerics. Probably, the warm gown and hood were practical in the unheated buildings.

Students at most American universities wore caps and gowns daily while in residence until after the Civil War. These varied in design until they were standardized by the American Intercollegiate Commission in 1895. While the academic costume code has been modified over the years, the general characteristics of the initial requirements still prevail. The uniform system of academic heraldry serves to indicate the level of degree, the field of study in which it was earned, and the institution by which it was granted. The gown for the bachelor's degree has pointed sleeves and is designed to be worn closed. The gown for the master's degree has an oblong sleeve and can be worn open or closed. The gown for the doctoral degree has bell-shaped sleeves with black velvet facing down the front and three bars of the same across the sleeves. However, these facings and crossbars may be in the color distinctive of the subject to which the degree pertains. At Bryant University, the president and the honorary degree recipients wear gowns specially designed and trimmed in the University color of gold.

The academic hoods are lined with the color of the university granting the degree. The length of the hood varies slightly for bachelor's, master's, and doctoral degrees. It is often the tradition of the candidates for degrees to wear the mortarboard tassel on the right front side before the degree is conferred and to shift it to the left when the degree is awarded.
