Are you a Bryant alumnus or alumna who has been away from school for a "few years" and would welcome the opportunity to come back?

Or, are you the parent of a student and willing to take on some of the course material you've heard so much about?

#### NELSON J. GULSKI '28 HONORED WITH DEGREE

He will receive the degree of Doctor of Commercial Science, honoris causa, and recognized for his outstanding educational service at Bryant College and as professor and dean.

#### RECENT GRANTS

The United States Office of Education has allotted \$1,188 to Bryant College for a college work-study program under the Economic Opportunity Act.

An unrestricted grant of \$200 has also been received from the Johns-Manville Program for Financial Aid to Higher Education. This program provides financial aid to privately supported colleges and universities in the U.S.

#### NEW DIRECTOR APPOINTED

President E. Gardner Jacobs has appointed Ralph Dean as Director of Continuing Education. Mr. Dean, who resides in East Greenwich, was formerly in sales capacities with the General Electric Company in Bridgeport, Connecticut; Chicago, Illinois; and most recently in Providence.

Mr. Dean has been stimulating the interest of area industry in existing Evening Division courses and will work with management to set up special programs at the College.

On March 29 an eight-week course entitled "Service Station Management Program for Petroleum Dealers and Service Station Operators" began, co-sponsored by Bryant College and the Small Business Administration. Lecturers include representatives of the petroleum industry, as well as Dr. Charles Goulston and Joseph Santos of our own faculty. Participants in the course represent service stations and oil distributors from eleven major oil companies, from the Automobile Club of America, and from the B. F. Goodrich Company.

Anthony Stasio '50, head of the SBA in Providence, has indicated that this is the first program of its type in the nation, initiated to train station managers and to reduce the number of service station failures.

#### Indians Win Naismith Intercollegiate Basketball Conference

It was welcome news when Bryant became a charter member of the James A. Naismith Intercollegiate Basketball Conference last fall.

Since then the Indians have come up with a 7 win 1 loss conference record to win the league "mythical" championship trophy and recorded a 16 win 6 loss season record. Six times during the season the team scored more than 100 points, with a high single game total of 134 points against Babson. Tom Smile '68 carried off college honors with a high single score of 48 points.

Since the League will not be in full operation until the 65-66 season, it was decided to award a "mythical" league trophy, which was awarded to Bryant at the annual basketball awards dinner March 29 at the Wayland Manor. The conference win came against Nasson as the Indians piled up a 108-69 win. Point total for the Indians for the season was 2,069 (94.1 game average) against 1,892 (86.0 game average) for our opponents.

Student support of the team continues to build, although we sadly lack adequate gymnasium facilities of our own and use the Hope High School gym.

Dick Tellier '65, captain for 64-65, will be the only varsity squad member graduating, which will leave a squad of sophomores and juniors returning in the fall.

Thirty-six men have turned out for track and cross country trials. Bryant will enter competition with small colleges in New England and has accepted an invitation to the Southern New England Invitational Track Meet to be held at Bridgewater State College in May.

Volleyball and basketball have completely engulfed the scheduling of time in the gym.
