Just a year ago our 1966 General Chairman for the Fund, Hector A. Gilman '21, spoke to a gathering of class workers and entitled his brief remarks "The Alumnus—The Key Man".

It's true!

Advance Giving to December 15 totals \$1,082.50 and there is every reason to believe that the 1967 Fund will exceed its predecessor.

With an extensive budget, coordinated through the Development Office, last year's number of alumni donors and dollars was increased considerably. Non-alumni sources of funds were also tapped by a special gifts committee headed by Robert Radican '57.

This year, after considerable discussion by the Alumni Council during its fall meetings, and in consultation with Roy D. Welch, Director of Development, Dr. Jacobs, and Ken Cedergren, Director of Alumni Affairs, it was felt that the Alumni Annual Giving Program should be returned to the Alumni Office.

Your gift to the College through the Fund has made many things possible for the students . . . equipment for the science lab, library books, and especially scholarships. The amount received last year has been spent as follows:

Scottish National Basketball Team Will Meet Bryant Indians January 24

The first Scottish national basketball team to visit the United States will meet Bryant's Indians in a game January 24 at the Pilgrim High School in Warwick.

The Indians have in their lineup a freshman, Don Gray, who travelled with a R. I. all-star team last summer on a People-to-People program to Scotland, Finland, and Greenland.

According to the coaches of the R. I. team that toured Scotland last summer, basketball is not a big sport in Scotland but it's growing rapidly. The amateur spirit is so strong that players, coaches, and officials all contribute to a fund to support the national federation responsible for promoting the game. Scottish gyms are few in number and small in size, but the spread of intense interest and enthusiasm may lead to new facilities in the not too distant future.

During the tour, the Scottish lads hope to benefit from their experiences against U. S. competition, and their coaches, Danny Kay and Ken Johnston, who is also president of the national basketball federation, expect to add to their store of knowledge by observations and contact with coaches here.

PROJECT COPE

Under a Federal grant and at the direction of the Superintendent of Schools for Providence, Charles O'Connor, Bryant College has agreed to enter a study called Project COPE . . . Co-operative Planning For Excellence.

They will review the business education curriculum and make recommendations for modernizing content, equipment, and teaching techniques to conform to latest research findings and to meet the needs of modern business.

Stonier Graduate School Graduate Thesis Accepted for Library

Miss Elizabeth A. Neilan '43, assistant vice president of Plantations Bank of Rhode Island, has been honored to have her thesis chosen for library circulation. The Stonier Graduate School of Banking chose 26 theses from 374 submitted by the class of 1966.

The Library Thesis Committee cited Elizabeth's paper: "Financing Foreign Trade in Small and Medium-sized Banks—Potential" as being of outstanding merit and requested that it be added to the permanent collections of three libraries. These libraries are located at the New York headquarters of The American Bankers Association, at Rutgers, The State University at New Brunswick, N. J., and Harvard University Graduate School of Business Administration at Cambridge, Mass.

AAUW Education Foundation Graduate Study Offer

Dean of Women Philomena B. Castrovano has received a memorandum from the American Association of University Women Educational Foundation that should be of interest to some of our alumnae.

In 1962 the Rockefeller Brothers Fund provided a three-year grant to begin the AAUW College Faculty Program, beginning in Southeastern United States. It is intended to provide additional excellent faculty members to meet the critical shortage in higher education and to offer to women graduates 35 or older preparation for a second career of their choice.

Since its beginning, 126 women have received awards for a year of graduate study. These women are now either teaching or continuing their study.

The Program was considered successful, and the AAUW has extended it to other states. Awards have been made for the first year in California, Illinois, Michigan, Minnesota, Ohio, Oregon, Texas, and Washington. The Program is just beginning in New Mexico, Nevada, Pennsylvania, and Virginia, and it is expected they will have award winners in graduate schools this fall.

It is possible that some of our alumnae will be interested in this program and could qualify for a grant if they reside in any of the states where the program is already underway.

Indian Cagers Topple Opponents Shoot for N.A.I.A. Tourney Bid

Led by seasoned tri-captains Ted Alsup, Tony DeQuattro, and Tom Smile, our varsity basketball squad has jumped off to an impressive 6-0 record. Statistics for the first six games show Bryant's cagers bombarding opponents at 98.1 points per game, while holding the opposition to 73 points per game.

Victories include a 123-72 shellacking of Nasson College in the season's opener and a cliff-hanging 78-76 win over Bridgeport's tough Sacred Heart University team.

Two newcomers to the Bryant schedule, The University of Maine (Portland) and Western New England College, were both welcomed in impressive style as the home cagers won 109-90 and 112-65. The other victories have come at the expense of Barrington College, 79-54, and St. Francis College (Maine) 88-81.

With Tom Smile, third highest small college scorer in the nation last year with an average of 33.4 points per game, the quintet is a potent scoring power. Smile, who has already poured in 180 points this year to bring his varsity career total to 1,941 points, is currently clicking at a rate of 30 points per game.

Don Gray, a freshman and a Rogers High School (Newport) All-State product, is averaging 16.3 points per game while Tony DeQuattro is averaging 12.8.

Aiming to better last year's 17 and 8 record and retain the Naismith Conference Championship, the Indians are setting their sights on earning a bid to the National Association of Intercollegiate Athletics regional post-season play. Winning the regionals would mean a trip to Kansas City, Missouri, for the national championship.

New England college coaches ranked Bryant 12th in the United Press International's small colleges ratings on December 22, in a tie with Bentley and Wesleyan.

By December 29 the UPI ratings ranked us 9th, in a tie with Bentley and M.I.T.

Little Rhody's BIG Industrial Recovery

Since 1958 the economy of Rhode Island has been experiencing a virtual renaissance in industrial development. Struggling under the loss of 44,000 textile jobs and 4,000 custom jewelry jobs since World War II, unemployment stood close to 12% nine years ago. The national and New England unemployment rate was much less, 6.8% and 7.7% respectively, in the same period.

Due in large measure to a concerted effort by the State's business and government leaders to create a new industrial climate, a metamorphosis has taken place. Rhode Island was stricken from the Government's list of depressed areas beset with a chronic unemployment problem in 1965. Today the State's unemployment rate stands at 3.6% vs. the national average of 4%.

The key factor in Rhode Island's comeback has been its attraction to industrial expansion, either old or new. Old-line firms such as Brown and Sharpe, Fram, Leeson, Speidel, and Collyer Insulated Wire have built brand-new plants. World-wide firms like Raytheon, United Nuclear, Phelps Dodge, Puritan Aerosol, and Advanced Micro-Electronics have chosen Rhode Island for new plants.

Capital Investment

Capital investment in new plant and equipment continues to spotlight the industrial situation in Rhode Island. Between 1958 and 1966 about 350 million dollars has been invested in new plant facilities, putting Little Rhody in a better competitive position with the rest of the nation. It is estimated by the author from statistical research that the industrial base of the State has increased by 50% over the last five years vs. an estimated 40% gain for the nation as a whole.

In fact, 1966 may have smashed an all-time record for new industrial construction in the State with investment outlays during the first six months of the year exceeding those of 1965. For example, the Electrical Products Division of Kaiser Aluminum & Chemical Co. is building a half-million square foot plant, costing approximately five million dollars in Portsmouth. The Mossberg Pressed Steel Co., a new firm to Rhode Island, is erecting a \$1.25 million plant in Cumberland.

Growth Industries

Although there are ten industries that are responsible for the economic upsurge in Rhode Island, on the basis of value added in manufacture these are the five fastest growing industries: electrical machinery (mostly electronics), other machinery (all kinds except electrical), miscellaneous manufacture (controls, instruments, silverware, optical, etc.), chemical (inorganic), and primary metals (mainly wire).

Instead of using plant and equipment as a yardstick, the value added approach

is a more fundamental method for measuring future economic growth. It is the difference between the cost of raw materials and the price of the finished products. This represents the money that remains in the State's economy to pay wages, and to carry the burden of further expansion into new factory facilities. The average compounded gain of these five growth industries from 1958 to 1963 has been about 9% per year on the basis of value added (1964 and 1965 figures are unavailable). This is about twice as fast as the growth of the national GNP during the same period. The big five in 1963 represent over 40% of the State's industrial power compared with only 33% in 1958.

A Five-Pronged Attack

This comeback story was not the result of natural, unplanned growth. Rather it was business and government leaders who instituted a planned program to attract new industry and to encourage existing industry to expand. The program was a five-pronged attack against high operating costs and included the following:

1. A 100% State guaranteed mortgage plan to finance new plant and equipment. (Rhode Island was first to pioneer it on a statewide basis).
2. Promotion of strategically located industrial parks with tax-exempt features.
3. An accelerated 300 million dollar highway program that is well along toward completion.
4. A merit rating system which rewards employers with stable employment records by reducing payroll taxes as much as 33%.
5. A new publicity program spearheaded by the Rhode Island Development Council. (This emphasized specifics such as boasting of the highest concentration of skilled labor in the Northeast).

Rhode Island has an industrial trade mark that reaches back 171 years. It is likely that industry will continue to find a warm welcome in Rhode Island in the future. Without a single major natural resource, Rhode Island must rely on business know-how and the skills of its citizens to make the State profitable for industry. It is not surprising therefore, that Rhode Island industry supports more people per square mile than any state in the nation, except New Jersey.

DEATHS

Nathan W. Whipple, Jr.

A patriarch, grain-mill operator and fire chief emeritus of Arnolds Mills, R. I., died October 2 in Woonsocket.

Nathan W. Whipple, Jr., was 86 years old and had graduated from Bryant in 1899.

In 1963 the old Sneece Pond Road in Arnolds Mills was renamed the Nate Whipple Highway. He is survived by a stepson, two grandchildren and one great-grandchild.

Astrid Elstad

Miss Elstad retired as office manager of the Merchants Cold Storage and Warehouse Company in Providence in 1959 and died on November 8. She resided in Cranston and was the sister of Miss Helga O. Elstad '08 and Ernest C. Elstad.

A graduate with the class of 1915, Miss Elstad was present for her 51st class reunion in May of 1966.

Stanley J. Daley

A retired officer of the Old Stone Bank in Providence, Mr. Daley died at his home in Uxbridge, Mass., on August 20. He graduated in 1917 and had been associated with the bank for 45½ years.
