At the October meeting of the Board of Trustees the installation of a computer on campus was unanimously approved. It is anticipated that the computer center will be fully operative by September.

Making the announcement to faculty and staff, President Schuyler Hoslett said the recommendation of a computer was approved: 1) to afford us the ability to extend our curriculum to include specialized training in this area; 2) to attract members to our faculty who will perform a more sophisticated teaching job because they will have access to this modern tool; 3) to better prepare our students for the modern business world in which the use of computers has become so important in decisions making; 4) to make Bryant College competitive with other colleges of business administration who have computers with which to attract qualified students; 5) to maintain our image as an outstanding and progressive college of business administration not only with prospective students, but also with the business community and other educational institutions as well; and 6) to greatly improve information flow throughout the College as well as to increase efficiency.

The varsity athletic program has really come into its own this past fall. Under the able leadership of Athletic Director Tom Foliard and his assistant, Bill Stein, the Indians had a full program.

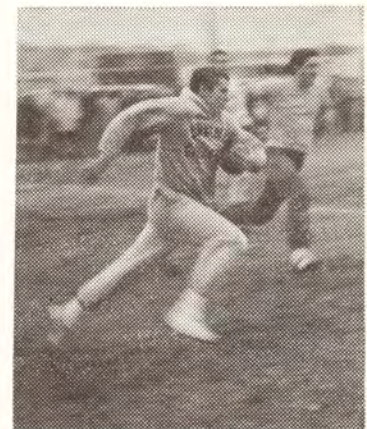
Soccer was re-introduced and tennis, golf, and cross-country teams played a full schedule. A review of all the fall sports and a preview of the basketball season follows:

Soccer—The decision to field a soccer team meant a search for a talented coach. That man was found in George Ford, a native of England. Coach Ford has been involved in soccer all of his life and coaching at Bryant permitted him to continue his interest in the sport at the college level in the United States.

Mr. Ford worked the team hard to get them into shape for their first game, against Providence College. A limited schedule of six games was played to include PC, Barrington, Rhode Island College, Holy Cross, New Haven, and Nathaniel Hawthorne College. The team's final record was 1-5 and they lost the five games by a total of only eleven goals.

The Holy Cross game was lost 1-0 on a penalty kick. Outstanding players included goalie Howie Reade '72, Alan Doughty '71, Gary Jacome '72, Ricardo Lechter '69, and Mark Cutler '70. There was great spirit on the team and a "never-give-up" attitude.

Cross-Country—Although the team did not fare too well in the meets it entered, under the able guidance of Coach Fred Reinhardt an outstanding runner was

developed, Roy Lapidus '72. Roy is from Fair Lawn, New Jersey. The cross-country team was the first to use the Tupper property as its home field on a course personally laid out by Coach Reinhardt. The future looks bright for this spring's track team and next year's cross-country team with several fine runners developing on the team.

Tennis—The team was a strong one, with the outlook for this spring being the best team Bryant has ever fielded. Coach Harry Robinson's team had a fall record of 3-2, the losses coming against URI and Brandeis. Team captain Tom Bass '69, Dave Hansen '69, Steve Murray '70, Omar Graddock '69, Jack Quebman '70, and John Prizio '69 all had prominent roles in a successful season. This spring's team has an outstanding chance to go to the NAIA Tournament.

Golf—Led by veteran Bill Kingsford '69 and coached by Arthur Boulet, the team had a very fine fall season. The outlook for spring is another very excellent team and another trip to the NAIA Tournament.

Basketball—There is more balance on this team than the team of two years ago when they went 22-0 in regular season play. Only three men were lost from last year's team, which was 15-7.

Leading the team will be co-captains Ben Billie '69, a 6' senior and Dave Greenblatt '69, a 6' 2" senior, both from Hartford, Conn. Last year Dave and Ben had scoring averages of 12.5 and 15.2 respectively. Ben was 26th in the nation last year for small college rebounding with 17.5 average per game.

The Indians are playing the toughest schedule in their history this year. Coach Folliard has added a trip to Florida in January to the season schedule. The Indians will play Biscayne College in Miami on January 27, Florida Institute of Technology in Melbourne on the 28th, and St. Leo College in St. Leo, Florida, on the 30th.

Florida alumni—mark your calendars!

There remains an excellent chance for the Indians to go to the NAIA Tournament for the third straight year. Another change for the Indians this year will be that they will play all but two of their home games at Marvel Gym.

Business Education Majors Have Internship Seminars

Richard Parmenter '58, vice president of P and B Office Machines of Rhode Island, Inc., returned to Bryant in November with a team of his service technicians to present a "how to" demonstration of business machine repair and maintenance. The meeting was arranged by Dr. Priscilla M. Phillips, Director and Supervisor of Student Teaching.

This was the second time Dick was invited to the campus to provide future typing teachers with a better understanding of the business machines they teach. This internship seminar for student teachers was held in the Student Activities Building Auditorium and included "How to make minor repairs", "How to clean the machine with inexpensive materials", and "Where to purchase certain maintenance supplies."

P and B was formed in 1964 when Dick and a veteran service technician, Carl Brackett, began their own service business for office machines. Their operation has grown in the past four years to the extent they now employ thirteen service technicians and have recently opened two branch offices. Besides their home office in West Warwick, R.
