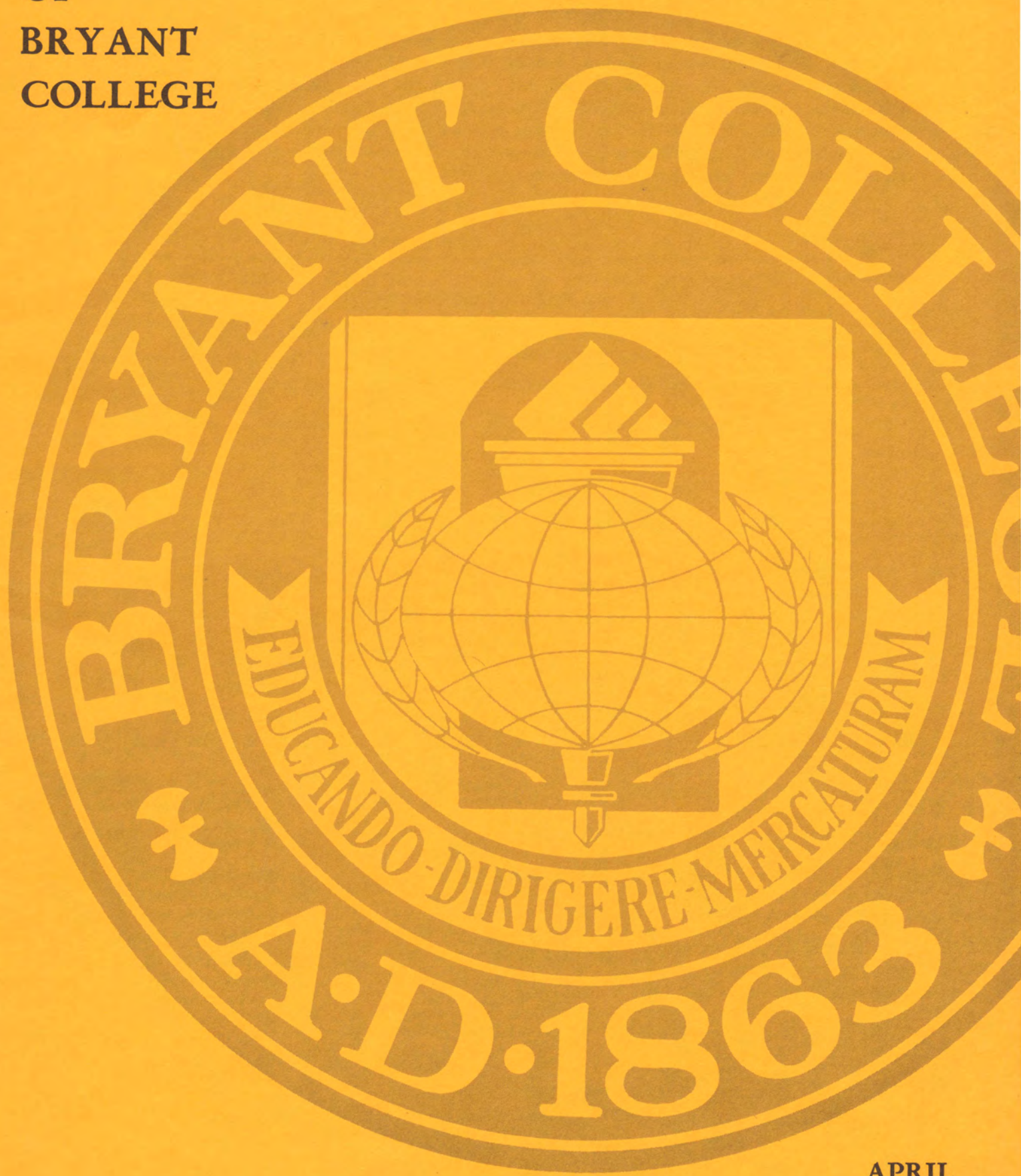

## FROM THE PRESIDENT

IT is a real pleasure to accept the Alumni Association's invitation to contribute an informal article on a regular basis to this quarterly publication. If a new President is part of Bryant's changing image as an emerging institution, so is a new format for its principal vehicle of communication with its alumni, and I wish the editor every success in this endeavor.

In spring, as the academic year draws to a close, a college president's fancy not so lightly turns to thoughts of things accomplished and things unfinished. As a "Freshman President" who took over from Gardner Jacobs last August, I look back on the past eight months with some satisfactions, a few regrets, and a great deal of hope.

Concerning my satisfactions, we have named a new Academic Vice President, Dr. Thomas Manion, who will be my right hand in achieving the kind of scholastic and faculty excellence that will place us among the foremost colleges of business administration in the country. In mentioning the new Vice President, I also want to pay tribute to Dr. Lionel Mercier, a long-time faculty member known to so many of you, who performed yeoman service as Acting Academic Vice President for over a year.

Also on the academic side, we have added a new major to the curriculum of the School of Business Administration, a field of study in economics. This change has been enthusiastically received, and the establishment of other major fields are presently under consideration along with the possibility of graduate study. Our faculty has been strengthened with the recruitment of new and promising teachers and through a program of encouraging the professional development of our present faculty.

My satisfactions also include our student body at Bryant. Students are the most important product of any college or university, and I am gratified to report that our student body continues to improve in quality and performance. We have so far avoided many of the difficulties other institutions have had in the area of student relations. I say this somewhat warily because I am too much of a realist to believe "It can't happen here," but I do believe we have a sound and sensible approach in this critical area. Our success to date can be attributed to five things: (1) the good work being done by William Smith, the Dean of Students, and his staff; (2) the fact that our curriculum is designed to expose students to their major area of career interest from the very beginning of their college experience; (3) the active participation of students on principal college policy-making committees such as financial aid, the library, curriculum, new campus planning, alumni affairs, and athletics; (4) an effective Student Senate which has made a number of useful recommendations which have been accepted; and (5) our emphasis on teaching rather than research or publication which allows for closer teacher-student relations.

I am also very satisfied with the effective manner in which our business affairs are being managed by Frank Delmonico, the College Treasurer, and the members of his department. These individuals are seldom in the spotlight, but without their efforts, it would be impossible for the College to function, and they deserve a lion's share of credit for efficient operation with limited financial resources. The business affairs department will also supervise the operation of a computer center to be opened here in the fall.



As for my regrets, thankfully they are few. They comprise mainly the frustrating experience of many college presidents in not being able to effect change faster, in dealing with the problem of more needs than we are able to afford, and in the growing pains of a college which is emerging to take its place among the outstanding schools of its kind in our country. With the help of my colleagues on the administration and faculty, with the continued cooperation on the part of the students, and with the interest and support of the alumni, we can solve our problems and move into the future with confidence.

My hopes for the future are very bright. As you will read in the articles to follow, the sale of our present campus to Brown and the plans for our new campus in Smithfield will make possible a substantial expansion of our current efforts in a drive toward that type of excellence which will truly provide a "Education for Business Leadership," the motto and goal of Bryant College.

There are many more things I would like to discuss with you in detail. Subsequent articles will afford me that opportunity, and I also look forward to seeing you personally in the challenging days ahead.

# Bryant Negotiates Sale of Property to Brown

**I**N anticipation of constructing a new campus on our 220-acre site in Smithfield, R. I., the Trustees of Bryant College have made a conditional agreement with Brown University to purchase its present land and buildings on the Providence East Side.

The formal announcement was made on March 20 by Dr. Schuyler Hoslett, President of Bryant, and Dr. Ray L. Heffner, President of Brown. This was followed by an afternoon news conference at which Joseph H. Hagan, Bryant Director of Development, and Malcolm S. Stevens, Vice President of Brown, answered questions from representatives of local newspapers, radio, and television.

The purchase price is \$4.3-million, plus Brown's assumption of a mortgage of approximately \$700,000, for a total of \$5-million. The sale is contingent on Bryant's ability to obtain favorable financing for its

new campus by July 31. The 26 buildings and 10.9 acres of land owned outright by Bryant are included in the proposed sale. Under a lease arrangement, Bryant would continue to use the campus until its move to Smithfield in 1971.

As most of us know, Bryant was founded in Providence in 1863 and has been granting degrees under authorization of the Rhode Island State Legislature since 1916. It became a non-profit institution operating under a Board of Trustees twenty years ago, in 1949. Nationally accredited, Bryant now has an enrollment of 1,900 students — 1,300 men and 600 women; and 1,400 evening division students. Twenty-six states and nine foreign countries are represented in its student body.

This sale is another milestone in the history of our alma mater.



## Planning for the New Bryant

IN October, 1967, Earl S. Tupper, the founder of Tupperware, Inc., presented Bryant College with his beautiful 220-acre estate in Smithfield, Rhode Island, for the expressed purpose of developing a new campus. Since the fall of last year, we have been busily preparing a detailed plan for the disposal of our East Side campus and the construction of a modern, efficient educational plant in Smithfield.

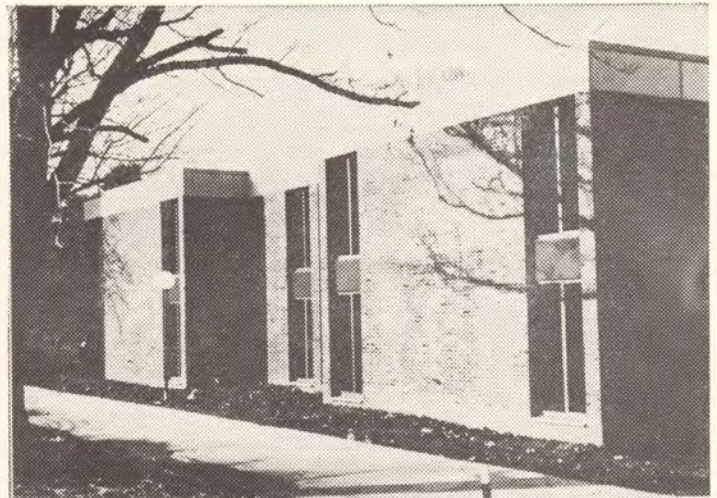
This February, the Board of Trustees selected the firm of J. Robert Hillier/Architect, of Princeton, New Jersey, to draw up a master plan for the new campus. Mr. Hillier's firm has to its credit the planning of buildings at Drew University, Fairleigh Dickinson University, and Rutgers University, among others. The firm has established a local headquarters in the Tupper homestead on the Smithfield site, and the planners are in daily contact with members of the Bryant community.

President Hoslett has created a Long-Range Campus Planning Committee composed of four members of the Board of Trustees, four representatives of the Administration, four faculty members, several ex-officio members, and five student advisors. The Hillier firm and the Long-Range Planning Committee are working in a close relationship to insure a truly representative and democratic consensus concerning the completed plan.

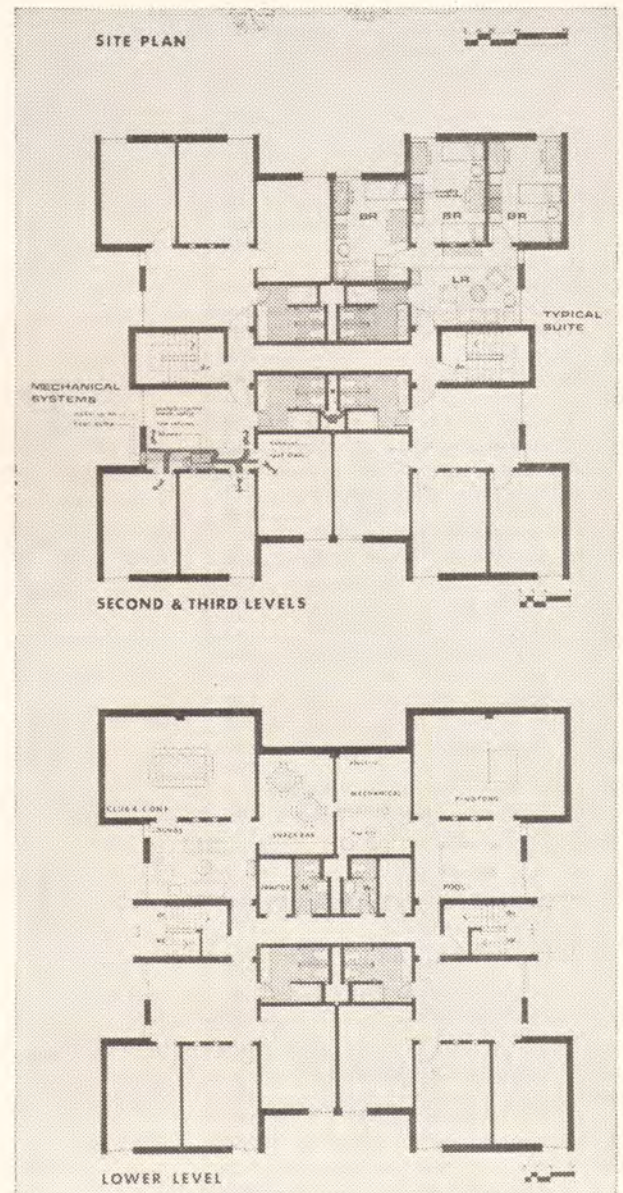
The master plan will be finished by fall and unveiled to the alumni and friends of the College. Now that we have agreed to sell our property to Brown, every effort is being made to assure completion and occupancy of the new site by the fall of 1971. This will take a tremendous amount of work, money, and cooperation on the part of the entire Bryant family—and we are hopeful of having the full and enthusiastic support of our alumni.

One of Mr. Hillier's basic proposals is to divide the campus into three general areas: live, learn, and play. While no plans have been finalized, it can be presumed that the new campus will include dormitories (conceivably of the "suite style" plan illustrated in the drawing accompanying this article), a dining hall-student center building, a classroom-lecture hall building with faculty offices, a gymnasium and spacious athletic fields, a library, and an administration building.

Exciting and trying days lie ahead. But we face the future with courage and confidence, believing that we can count on our alumni for a high degree of encouragement and assistance in making the "New Bryant" a reality.

### Varsity Basketball Team

THE INDIANS COMMENCED THE 1968-69 SEASON WITH A 61-65 WIN OVER S.M.T.I. The team continued a ten game winning streak until January 11th, when they were defeated by a strong Babson quintet, (79-61).

Following the examination period, the Indians returned to action on January 27 against Biscayne College, the first of three games in Florida. Biscayne won the contest by a 79-75 margin. On the next night Bryant defeated Florida Tech 87-82, making their record 11 and 2. The Indians then travelled to St. Leo College

to play a strong ball club, one that had defeated Fairfield University and U. S. Coast Guard Academy. The Indians held a 6 point (19-13) margin at one point, only to be outscored in the next three minutes 18 to 3. The half-time deficit of 9 points could not be overcome in the second half. Although the Indians were defeated (86-71) it was one of their best performances of the season.

The team, both on and off the courts, spread the name of Bryant College. People who became exposed to the players, either on the plane trip or at the

hotels, as well as area alumni, surprisingly showed up for the games. All in all, the Florida trip can be summed up in one word: "beneficial."

The Indians then ran up nine wins, only to have Babson stop them in overtime, 78-72. Bryant ended its season with 92-77 loss to New Hampshire College in the N.A.I.A. Playoffs.

The team could well be described as one of pure hustle, and a never-quit attitude. Fifteen of the 21 wins were the result of constant defensive pressure.

The loss of starters through graduation, Dave Greenblatt and Ben Billie, as well as reserves Ed McManus and Joe Goddard, will be difficult replacements for the 1969-70 squad.

William "Billy" Stein furnished us with this sports copy. He is assistant varsity basketball coach and has recently been named varsity baseball coach.

### Freshman Basketball Team

The Bryant College freshman basketball team ended their season with a record of 9 wins and 10 losses. The team was more impressive than the final record indicates. Only three of the ten losses came at the hands of other freshman squads. The majority of losses were dealt by junior colleges, prep schools, and a three-year college.

The young men listed below should be assets to the 1969-70 varsity basketball

Tom Asselin—6'5" averaged 20.7 points per game, had high games of 47 and 39

points, and 13.3 rebounds per game.

Tom Burns—6'1" averaged 15.7 points, had high games of 27 and 26 points and led team in assists with 6.5 per game.

Bob Passano—6'3" average 17.1, had high games of 31 and 30 points, and led team in rebounds with 14.2 per game.

John Westman—6'5" average 10.1 points, had high games of 22 and 16, was the most improved player, best defensive player, and averaged 11.7 rebounds per game.

Paul Savader — 6'1" averaged 11.3 points, is a good outside shot.

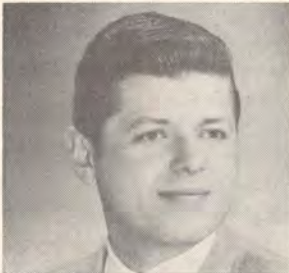

## Student Government Has New Constitution

Former members of the Bryant College Student Senate and the Greek Letter Council will be interested to know that a new constitution has been adopted that combines both groups into one.

The new constitution became effective on January 29 and was previously approved by the Student Activities Committee, the Student Senate, and the Student Body.

Membership in the Student Senate now consists of two branches: an Executive Council and a Legislative Council. All members of both Councils are known as Senators.

The Executive Council consists of:

- 4 Officers (President, Vice-President, Secretary, and Treasurer) elected at large from and by the full-time day student body
- 4 Class officers
- 1 Men's dormitory representative
- 1 Women's dormitory representative
- 1 Greek Letter Council President
- 1 Representative from the Senate-sponsored clubs on campus to be elected by vote of Club Presidents only
- 1 President of the Bryant College Interfaith Council

The Legislative Council at present consists of:

- 17 Presidents of Clubs
- 17 Greek Letter Council Presidents
- 16 Dormitory Presidents
- 3 Religious Organizations Representatives
- 12 Vice-President, Treasurer, and Secretary of each of the four classes.

The Executive Council meets weekly and the Legislative Council meets twice each month.

Nominations for an advisor to the Student Senate are made by the Executive Council for each College year, for a one-year term.

With such broad representation within the student body, questions and comments of various importance can be handled quickly and efficiently. Acceptance of this new constitution was by Robert W.
