Abraham A. Ribicoff, United States Secretary of Health, Education and Welfare, and six other distinguished Americans will receive Honorary Degrees at the Ninety-eighth Commencement of Bryant College of Business Administration, Providence, Rhode Island, on Friday, July 28, 1961, at the Veterans Memorial Auditorium (10:00 a. m.). Secretary Ribicoff will deliver the Commencement Address.

The Honorary Degree of Doctor of Humane Letters (L.H.D.) will be conferred upon the Secretary. Honorary Degrees will also go to Ernest I. Kilcup, President, The Davol Rubber Company, Providence, R. I., Doctor of Science (D.S.); Louis R. Menagh, President, The Prudential Insurance Company of America, Newark, New Jersey, Doctor of Laws (LL.D.); Dr. Francis H. Horn, President University of Rhode Island, Doctor of Science in Education (D.S. in Ed.); Edmund Cooper Mayo, Chairman of the Board, The Gorham Corporation, Providence, Rhode Island, Doctor of Science in Business Administration (D.S. in B.A.); Jackson Martindell, Chairman of the Board, American Institute of Management, New York, New York, Doctor of Science in Business Administration (D.S. in B.A.); Hector A. Gilman, Vice Pres-

ident, Industrial National Bank of Rhode Island, Master of Science in Business Administration (M.S. in B.A.). These degrees will be conferred by Dr. E. Gardner Jacobs, Acting President of Bryant College, who will preside at these Graduation Exercises.

Bachelor Degrees will be conferred upon 409 men and women graduates, representing 26 states and 5 foreign countries. Dr. Michael F. Walsh, Rhode Island Commissioner of Education, will present teaching certificates to 27 graduates who have completed the four-year Business Teacher-Education program.

State and City Greetings will be presented by the Honorable John A. Notte, Governor of the State of Rhode Island, and the Honorable Walter H. Reynolds, Mayor of the

City of Providence. Invocation will be given by Dr. Howard W. Ferrin, President of Barrington College, and the Benediction by the Very Reverend Vincent C. Dore, O.P., President of Providence College.

Commencement Activities officially begin on Thursday, July 27, 1961, at 10:00 a.m. with a Class Day program on the Campus Green. Nancy Ann Gencarella, '61, of Westerly, Rhode Island, and Jere St. Angelo, '61, of Providence, Rhode Island, are the Class Day Speakers. Doctor Jacobs will deliver the principal address entitled "The Golden Mean." He will also award Scholastic Honors and Prizes.

The Commencement Ball, on Friday evening (July 28), at 9:00 p.m. in the Sheraton-Biltmore Ballroom will bring the two-day graduation program to a close.

Doctor of Humane Letters (D.H.L.) Abraham Ribicoff United States Secretary of Health, Education and Welfare

Twenty years of public service preceded Mr. Ribicoff's appointment by President Kennedy to his Cabinet post on January 20, 1961. He was twice elected Governor of Connecticut and twice elected a Connecticut Representative in the United States Congress. He served two terms as Judge of the Hartford Police Court and was twice elected a member of the Connecticut Legislature, the first time at the age of 28. In his first term he was elected the "most able legislator" in the poll taken by newsmen covering the State Capitol. During his term as U. S. Congressman, he served on the Foreign Affairs Committee.

Major divisions of the Department he heads are The Social Security Administration, The Public Health Service, The Office of Education, The Food and Drug Administration, The Office of Vocational Rehabilitation.

Born in New Britain, Connecticut, in 1910, he attended the public schools of this city, and upon graduation from high school, went to work in a hardware factory to save for a college education. After attending New York University for one year, he was sent by this firm to open an office with the understanding that he could also attend the University. A 1933 cum laude graduate of the University of Chicago Law School, he was an editor of the Law Review and a member of the Order of the Coif, national legal honor society. He and his wife consider Hartford, Connecticut, their permanent residence. The couple have two children, Peter, a teacher in a high school at Alameda, California, and a daughter, Jane, in college.

Initiating many employee benefits, he was first to establish Blue Cross and Retirement Plans. His work in the pharmaceutical field was recognized by an Honorary Degree from the Rhode Island School of Pharmacy in 1937.

He taught Economics, Marketing, Merchandising and Financial Management at Northeastern University and was awarded a Master of Science in Business Administration Degree by Bryant College in 1937.

Mr. Kilcup is a Director of the Citizen's Savings Bank, the Automobile Mutual Insurance Company of America, the Phoenix Division, Rhode Island Hospital Trust Company, and the Factory Mutual Liability Insurance Company of America. He is a member of the Board of Trustees of the Osteopathic General Hospital of Rhode Island, and recently retired as a Director of the Emma Pendleton Bradley Home, which cited him for his services to that organization.

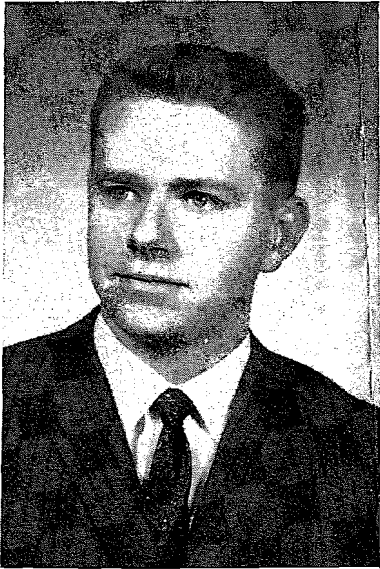

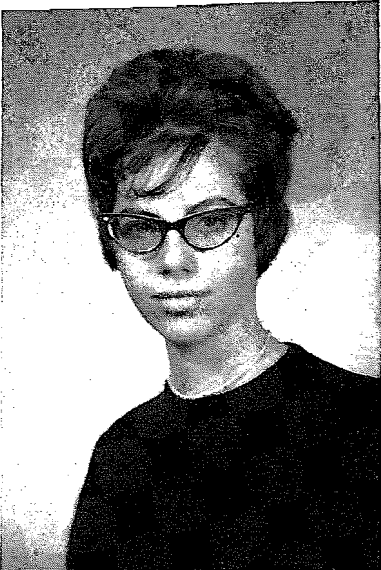

Roger W. Babson Award



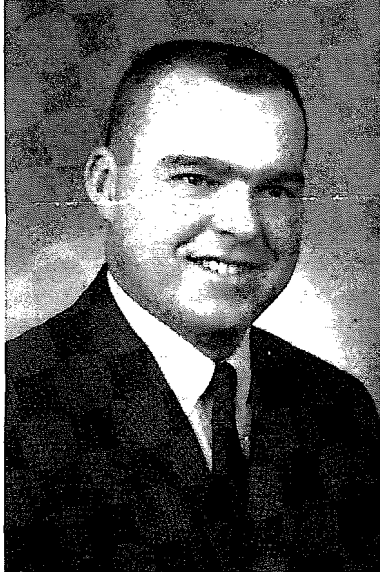

Classes are over; exams will follow shortly. In a few weeks you, the graduating class of 1961, will receive your degrees and diplomas as evidence of successfully completing your college education.

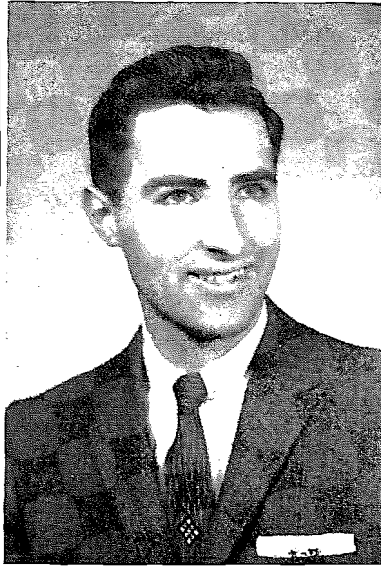
