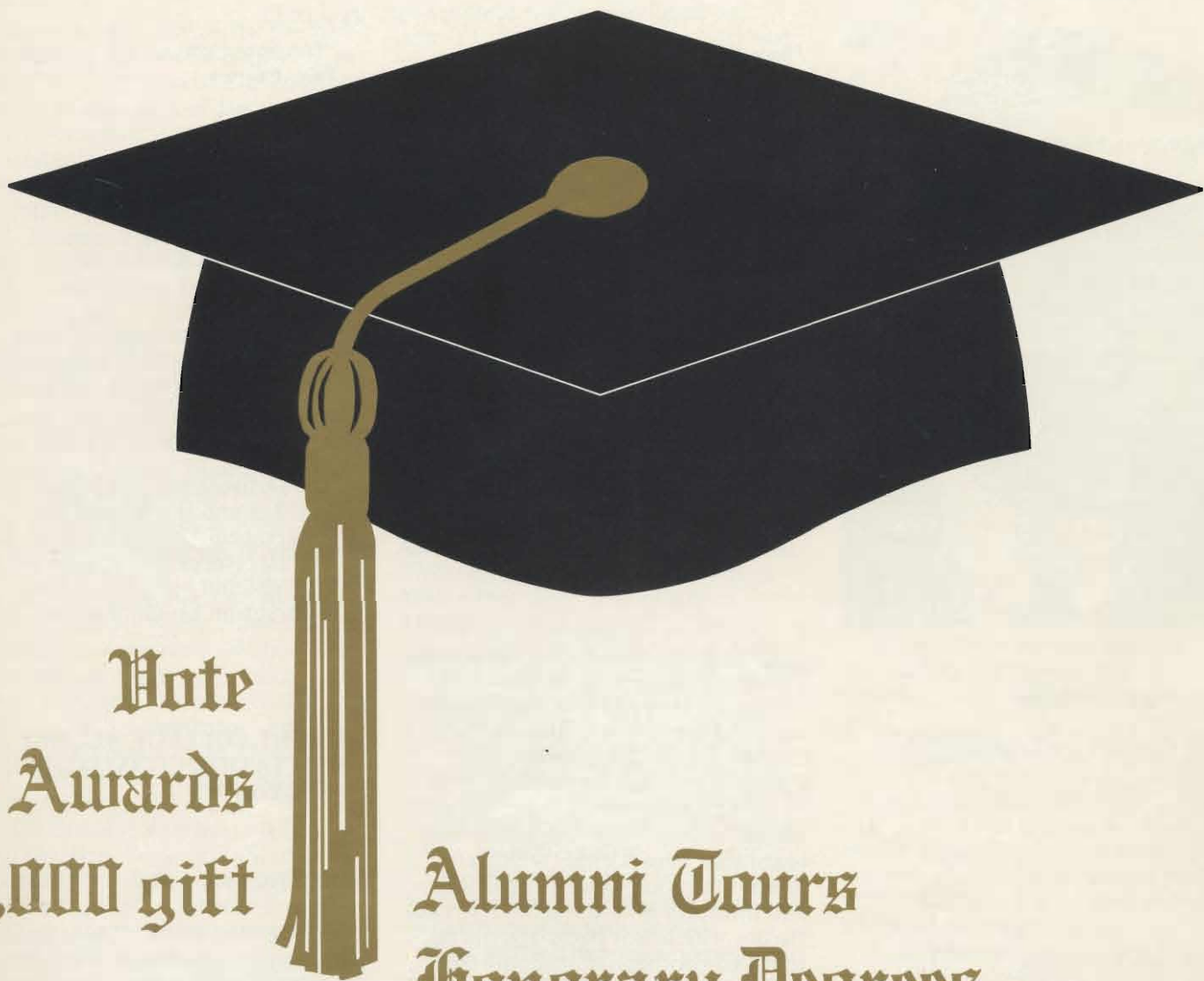

BRYANT COLLEGE ALUMNI ASSOCIATION CONSTITUTION AND BY-LAWS

AMENDMENT

At the May 8, 1975 meeting of the Alumni Association-Executive Council, a motion was made and it was voted: that there be an amendment to the Constitution and By-laws that "a representative of the Senior Class to be chosen by the Senior Student Senators, be appointed to the Executive Board, and that he or she, and the President of the Student Senate shall be voting members." The senior representative will replace the President of the Senior Class — a position which is no longer filled.

STATEMENT OF BRYANT COLLEGE BOARD OF TRUSTEES

The Board of Trustees of Bryant College, Smithfield, R.I. accepted the resignation of President Harry F. Evarts. The Board also decided to appoint a committee that was to report by June 9, 1975, recommending a minimum of three candidates for the position of Acting President. After the Acting President was appointed, President Evarts was placed on terminal sabbatical leave until the end of his contract.

The search committee for the Acting President had eleven members, including the Chairman of the Board of Trustees as chairman of the committee, two trustees, two faculty members, two students, two alumni, and two administrators. Trustee members, in addition to Mr. Gifford, were Frederick C. Tanner, Vice Chairman of the Board, and G. Russell LeBeau. Nominations were sought from the other constituencies.

Action on appointing a committee to search for a new permanent president was deferred until the Acting President was elected.

The Board accepted the report of the Student Center Committee. It was decided to authorize the building of a student center at a maximum of 1.9 million dollars, including equipment. It was further decided to appoint a building committee to proceed with the building plans, subject to the review and approval of the Finance Committee of the Board. George J. Kelley, a trustee, was named chairman of the building committee. Administrative members will be Thomas K. Scott, Vice President for Business Affairs; Barry A. Fullerton, Vice President for Student Affairs; and Raymond Quinlan, Superintendent of Grounds and Buildings. Nominations from the faculty and students are being sought for three representatives from each constituency.

In answer to another recommendation of the Special Study Committee, it was the consensus of the Board that conflict of interest does not exist. However, in order to avoid any misunderstanding, it was agreed to ask the Finance Committee to review periodically the investment performance of the trustee of the College endowment, a function formerly carried out by the College administration. It was further confirmed that all major contracts will be subject to

competitive bidding and reviewed by the Finance Committee.

In other action, the Board elected Walter C. Tillinghast to a two-year term as Trustee, fulfilling an earlier pledge to have an alumni Board mem-

ber selected by the alumni. The Board also re-elected Lowell C. Smith, Vice President for Academic Affairs; Barry A. Fullerton, Vice President for Student Affairs; and Thomas K. Scott, Vice President for Business Affairs.

DR. GULSKI NAMED ACTING PRESIDENT

At a special meeting of the Board of Trustees which concluded on June 17, 1975, Nelson J. Gulski was elected Acting President. Dr. Gulski, who served the College as Acting President during 1969-1970, was selected by the Trustees from a group of five candidates recommended by a special screening committee consisting of faculty, students, administrators, alumni, and trustees.

In selecting Dr. Gulski, the Board of Trustees was deciding upon a proven administrator who had earlier served the College as a faculty member, Dean, Vice President, and Acting President. He will assume the duties of his office on or about July 15, 1975.

Dr. Nelson J. Gulski has been with Bryant College for forty-eight years. During that time, he has served as Faculty Member, Dean of Business Administration, and from November 1969 to August 1970, he served as Acting President of the College. After retiring in June 1972, he returned to the College in September 1973 to serve as Acting Vice-President for Academic Affairs.

A Certified Public Accountant, Dr. Gulski has held prominent positions in State and National accounting associations. A past president of the Rhode Island Society of Certified Public Accountants, he is a member of the American Institute of Certified Public Accountants and the National Association of Accountants.

He is well known for his civic contributions in his hometown of North Attleboro, having served on that town's Finance Committee, School Committee, School Building Committee and By-Law Revision Committees. Presently, he is a chairman of the Town Capital Improvements Committee and the Industrial Development Commission.

For many years, he has been active in Junior Achievement of Rhode Island and the North Attleboro Scholarship Foundation.



In the world of business, Dr. Gulski is a director of Swank, Inc., and a Trustee of the Attleborough Savings Bank.

Among those recommended by the screening committee were a trustee, three administrators, and Dr. Gulski. Interviews were conducted by the Board during the 3-hour meeting. Individual trustees expressed pleasure at the interest, dedication, and quality of the five candidates.

In further action, the Board authorized the appointment of a committee to search for a new president and expressed hope that the assignment can be completed quickly. The committee will be appointed as soon as the trustees outline a plan of action including composition of the committee, operating procedures, and a timetable.

The trustees also passed a resolution complimenting outgoing President, Dr. Harry F. Evarts on the significant progress of the College during his five years of service.

What's Happening

ECONOMIC OUTLOOK FOR 1975

In each post war recession there have been different characteristics which have slowly changed the underlying structure for our economy. Our difficult inflation rate which is unique to this recession has contributed to the downturn in our economy and added to the financial strain.

Since November 1973, this extreme inflation has substantially reduced our take home income which further decimated our consumer expenditures. This inflation has also caused deterioration in business cash flows because accounting practices and tax laws which were designed to operate under much lower rates of inflation further reduced internal sources of funds. At the same time, external sources of funds to many businesses became either unavailable or very expensive. Lending by banks increased dramatically as firms required additional financing to support even slower economic activity at inflated prices.

There were a number of additional factors accounting for the rapid price increases in 1974 beyond the primary cause of inflation, which was the excessive monetary expansion in earlier years. These other factors included an oil embargo, poor agricultural output and, later as the recession fully developed, decreases in productivity resulting from low utilization of capital and labor.

This recession has purged double digit inflation out of the economy since the beginning of the year and as the inflation rate continues to fail this will provide a stimulus for economic recovery. The decline in consumer spending, especially in the higher priced durable goods items, such as automobiles, and appliances related to housing, and the later fall in investment spending, has resulted in inventory accumulation of unsold goods with the need for additional financing. Before production can increase, these large inventory levels must be reduced which in turn will absorb the growing labor force and lower the unemployment rate.

Our reduced inflation rate has reduced the private demand for credit. This has caused a sharp downturn in short-term interest rates and an

easing of long-term interest rates. These factors improve the environment for housing by making available more money to the mortgage market which in turn should help increase housing activity once consumer confidence has been restored.

In the long run, the economy calls for increased savings and investment, but as we all know, in the short run we need some additional spending to stimulate the economy in order to recover from the cyclical downturn. Our recent tax rebate will indeed help reverse this fall in real disposable income and rebuild consumer confidence, and finally total spending.

This economic environment which we have experienced since last summer has certainly changed the environment for banking. This inflation reduced increase in loans, has been offset by the weakness in the economy, causing a net reduction in loan demand. Sales forecast have been revised downward all year and actual sales fell below some of the earlier more dismal projections reducing the expansion of plant and equipment.

The outlook for a recovery this year hinges on how fast the rate of inflation falls and the stimulating effect of the tax reduction increases take home income. Our Federal Reserve system must carefully provide the correct amount of credit to sustain the economic recovery which we should see sometime later in the year and at the same time be careful not to create an excess supply of money in 1975 which would fuel inflation in late 1976 and beyond.

Looking further out, the economy has a basic need for a faster growth of real investment, and has been experienced in the recent years, if the economy is to provide productive unemployment for the growing labor force.

TODAY'S ECONOMY AND THE JEWELRY INDUSTRY

The jewelry manufacturing industry, mostly made up of small firms employing less than 100 employees, accounts for 150,000 jobs in the Providence and Attleboro areas. Despite the economic slump which has hit the nation and has brought the unem-

ployment figure in Rhode Island and Southeastern Massachusetts to the highest level in recent years, there are certain areas of the jewelry industry which are enjoying a boom. While the entire industry is not participating in this phenomenal prosperity, it is most fascinating to try and analyze why luxury items such as jewelry would be so appealing for women, while members of their family may be laid off from work or are facing the danger of curtailed hours resulting in a lower income.

Strangely enough, this increase in the sales of jewelry extends from inexpensive costume accessories through so called semi-precious gold filled and sterling silver items up to solid gold and platinum and the precious stone set category. Psychologists are not amazed at this strange trend. They feel that when the economy is depressed, women are interested in giving their morale a boost and at the same time buying something that is pretty and which has some stability to its value. It is most essential that during times like the present that people do not lose hope.

Better than 40% of the nation's output of semi-precious and precious jewelry is made in this area as well as 50% of the country's costume jewelry.

An unusual circumstance is the growth of the local industry at this time despite the continuing increase in imports of both precious as well as costume jewelry. Precious jewelry imports rose from \$20 million in 1968 to \$50 million in 1972. Figures for 1973 and 1974 show continued growth. Costume jewelry during the same period increased from \$36 million to \$51.5 million. Hong Kong and Japan are the largest exporters of these products. Increased production by areas such as Taiwan, Korea and other low wage countries will continue to plague the local manufacturers and alternate plans of action will be necessary if those manufacturers are to survive.

Precious stone set jewelry is enjoying a prosperity which is easier to understand because the market is being primed by wealthy people of both the U.S. as well as abroad. These people feel that buying precious stones represents an excellent invest-

ment at this time. Recession problems have not affected them in the same manner as the family which depends on income derived from salaries alone.

Sterling Silver has become more popular than any other time in history. Sales of sterling silver items continue despite the rise in the silver price from \$1.00/oz three years' ago to a recent high of \$6.00/oz. Gold which had been stabilized at \$35/oz since the 1930's, started rising about two years ago and reached a high of \$200/oz which has since leveled off at around \$165/oz.

The precious and costume jewelry industry is small by comparison to other industries. According to a series published in the *Jewelers Circular*, *Keystone*, an industrial publication, 1974 jewelry sales of both precious and costume jewelry amounted to 4 billion dollars compared to 3.3 billion dollars in 1973. Taking into consideration an increase for inflation, the gain is still very significant. Recent trade shows both in Providence and New York have set records for attendance and there was more optimism and buying action at the last show than what had been witnessed during previous non-recession years.

The answer in a nutshell is possibly the new car or household appliance is beyond an individual's budget, but a woman can still perk up her morale by spending \$2 — \$25 for a piece of costume jewelry instead of a more expensive dress she normally might have purchased.

SBANE — SMALL BUSINESS CLOUT

"Small business is sort of like motherhood, the flag, and apple pie. It's the kind of thing no one can be against for very long," according to Mr. Lewis Shattuck, Executive Vice President of the Smaller Business Association of New England, (SBANE). SBANE was established back in 1938 to provide a cohesive, multi-purpose organization through which all kinds of businesses could work toward common goals and have a single, unified voice in government. Many of the small businessman's problems relate to local situations and, of course, so many more reach beyond that and these problems can only be solved by having a sound voice in Washington.

The Annual Washington Presentation is one way in which the small

businessman can have his voice heard on such important subjects as OSHA, the surtax exemption, tax rate on corporate profits, EEOC, and government procurement among other things. This year's trip also includes other groups: The Smaller Manufacturers Council, Pittsburgh; The Council from Smaller Enterprises, Cleveland; and The Independent Business Association from Wisconsin, making this important presentation in Washington. Speaking about the surtax exemption, SBANE was instrumental in increasing the amount from \$25,000 to \$50,000 recently and is continuing to fight to have this raised to \$100,000.

SBANE originally was one of several associations organized to give business people throughout the country a voice in Washington; however, it is the only truly regional association still functioning today. Not only is it functioning but it is growing by leaps and bounds and, as of the last count, there were some 1,200 members in this organization. SBANE encompasses the six New England States and a wide variety of businesses such as manufacturers, retailers, service firms, wholesale distributors, lawyers, banks, accountants, consultants — you name it. There is a deep admiration and respect on the part of SBANE for small enterprises. There is something about the little guy that is woven into the traditional ethics of this country. His desire to be an entrepreneur, his attitude of independence, his enthusiasm to do his own thing. Along with these, of course, go the challenges he faces day to day, at the same time, he is not part of a huge impersonal operation. These are real individuals, or groups of individuals, expressing themselves through creative business enterprises and they are a diverse and widely scattered lot rooted in virtually every town and city in the United States. That seems to make them more truly American and that kind of image is what is helping them develop the kind of political constituency which is necessary in America.

In the past small businesses in this country have never really had their own political contingency, and they desperately need this type of representation. They are most vulnerable to the ups and downs of the economy, the most needy of legislative assistance, the most worthy of governmental attention. There are over 10,000,000 small businesses in this country which represents over 98 percent of the total number of private enterprises, and

they employ 50 percent of the work force. Certainly this deserves a greater attention from Washington to the problems of the smaller businessman.

Many of the laws which have been passed become law with good intentions but with little thought given to the effect that they might have on small business. SBANE proposed that a chief counsel for advocacy be appointed within the Small Business Administration to act as a liaison between small entrepreneurs and the Federal Government and to provide a constant presence in Washington for the cause of the small business community. This has been accepted and is now in effect today. Some of the other functions of SBANE are:

Three-day "Live-In" seminars are held on the campuses of the Harvard Business School and Dartmouth's Amos Tuck School. Professors from Harvard Business and Amos Tuck School present case studies and attendees come from all over the United States. During the last 16 years, these seminars have attracted roughly 1,500 smaller-business executives.

Monthly Breakfast Club Meetings are held in Massachusetts and Rhode Island and have covered topics such as: "The Entrepreneur," subjects on insurance, and other programs which are of interest to the small businessman. Past speakers have included Senator Edward Kennedy, Congressman Wilbur Mills, Dr. Donald Chun, William Vecck, Lewis Gilbert, members of SBANE, and others.

The Executive Dialogue program consists of several small groups (composed of 12 — 15 businessmen) with a different member acting as host each month. These group sessions are informal and the participants discuss mutual problems and situations within small business.

The Annual Meeting and Small Business Conference offers guest speakers and is capped by the banquet and the introduction of the new officers of SBANE.

The 50 x 50 seminars received the name as a result of the cost (\$50) and the maximum number of people allowed to attend (50). Instructors for these seminars come from all over the country and participation by those attending is encouraged. These educational programs are tailored to the small businessman in a very practical and valuable way. SBANE seminars have been held at Northeastern and Boston College in addition to several

other locations. The approximate number of attendees this year alone will be 500.

SBANE has answered many questions and solved many problems for the small businessman over the years.

TRUSTEES ELECT ALUMNI TRUSTEE



At its annual May meeting, the Bryant College Board of Trustees elected Mr. Walter C. Tillinghast '53 to membership on the Board. Mr. Tillinghast was nominated as Alumni Trustee by the Executive Board of the Alumni Association.

Mr. Tillinghast was born in Providence, Rhode Island. He was graduated from Aldrich High School and Bryant College in 1953. He began his career with the Horton-Noyes Agency and was President of the Hillsgrove Realty Company. He was also area chairman for the Episcopal Theological School Fund Drive and well known for his church activities in the Episcopal Diocese. He joined the Spaulding Company in 1968. He is First Vice-President and a member of the Board of Directors of the Smaller Business Association (SBANE). He is on the Bishop's Development Committee of the Episcopal Diocese of Massachusetts and is a Licensed Lay Reader. Mr. Tillinghast has served on the Bryant Alumni Council Executive Committee and as Chairman of the Long Range Planning Committee, as well as Chairman of the Alumni Magazine Committee. He is the President of the Spaulding Company, a microfilm engineering, printing and services company located in Randolph, Mass., Albany, N.Y. and in Philadelphia, Pa. He is a member of the Advisory Committee of the Walpole Hot Line where he resides on 3 Coach Road, Walpole, Mass. with his wife and four children.

Mr. Anthony A. Zompa of the Class of '66, MBA, '74 is presently employed as an accountant with Blue Cross. At Bryant, he was a member of AKO fraternity. The father of two children, he is married to the former Sandra Cardi, Class of '68.

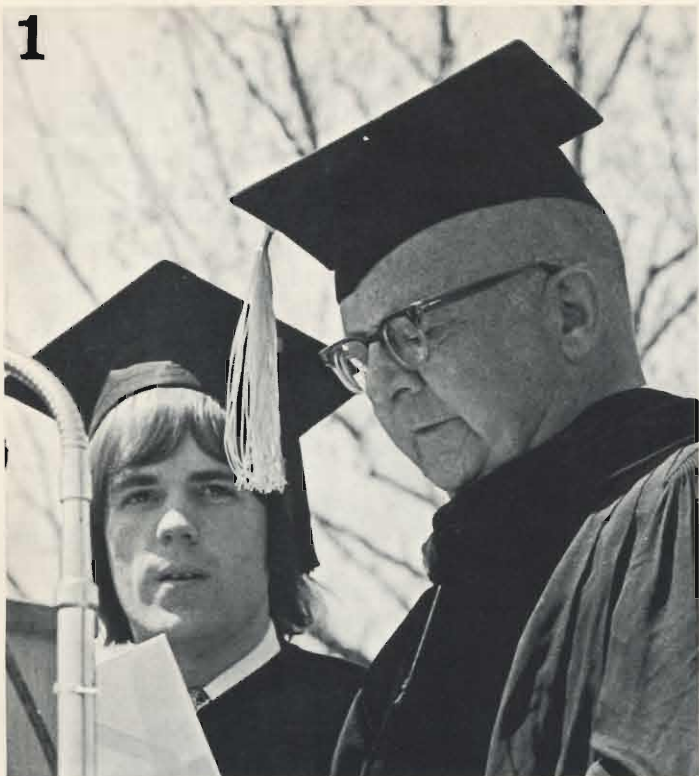
Approximately 685 candidates were presented Baccalaureate and Associate Degrees in course. This was the first class to have spent all of

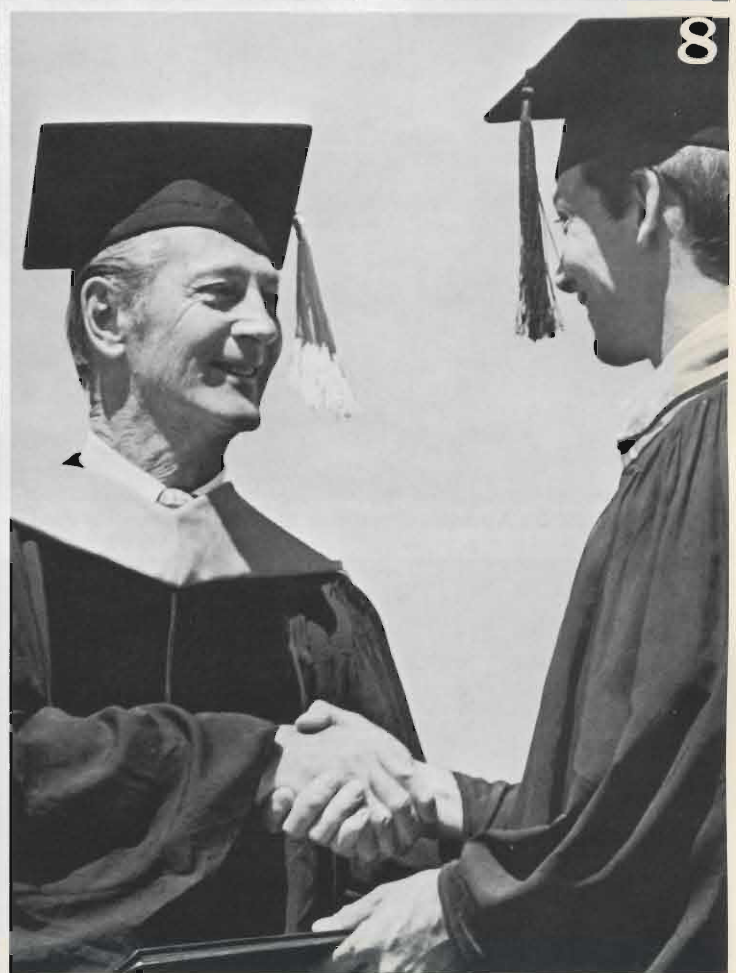
