*Mini Annual
Report*

Building on a solid base of support from alumni, parents, faculty, staff, friends, trustees, corporations, and foundations, which was developed over the past several years, the Bryant Fund experienced its most successful campaign year in history with a total of \$1,189,978 in cash and in-kind gifts

from 7,244 donors. This represents an increase of 14% in dollars over the highest previous amount. Including government grants, the grand total was \$1,718,341, an increase of 38% over the previous year. Individual alumni contributions of all types account for \$460,611 of this total or 38.7%.
