trumpeter, composer and bandleader Dizzy Gillespie, a casino night complete with piano player and black jack dealers in Civil War era costumes, and a dazzling fireworks display that lit up the Bryant skyline on Friday night.

A Bryant College professor and four graduates were honored at the reunion weekend awards ceremony on Friday evening, June 10.

Professor of Mathematics Alan D. Olinsky received the Distinguished Faculty Award in recognition of his inspirational devotion to teaching and his dedicated concern for all of his students. A member of the Bryant faculty since 1967, Olinsky holds BS and MS degrees from Hofstra University. He is currently working on a marketing study for Correctional Industries of Rhode Island under a grant from the National Institute of Corrections.

The Nelson Gulski Alumni Service Award was presented to Karl F. Ericson '58 for his unparalleled devotion and service to Bryant as a student, alumnus, trustee, and friend. A member of the Board of Trustees from 1980 to 1988, he served as chairman from 1983 to 1986. He is credited with the conceptualization and implementation of the college's Strategic Plan. Ericson's Bryant activities have included chairing the Bryant Fund, as well as membership on the Alumni Executive Board and a number of college committees. A partner with Peat, Marwick, Main in Providence, Ericson is past president of the Rhode Island Society of CPAs.

Distinguished Alumni Awards went to three outstanding Bryant graduates. Steven Crowley '70, Money Editor on ABC's *Good Morning America*, is head of Crowley Broadcasting in Fort Lauderdale, FL, which produces "Money/Pro News," a nationally syndicated news feature, and "Smart Money," half-hour specials on financial topics.

Biagio M. Maggiacomo '41 began his business career with Greater Providence Trust in 1948 as a branch manager, rising through the ranks to assume the presidency of the financial institution in 1960, a position he held until 1972. In 1973 and 1974, he capped off an impressive list of public service appointments when he was charged with establishing the Office of Auditor General of Rhode Island and the Rhode Island Lottery Commission.

Donald F. Walsh '51 is president of EQUIFAX Services Inc., an Atlanta-based corporation providing information services and systems to business, industry and government organizations throughout North America. He is also a director of the Affiliated Companies of Equifax, Inc. Walsh is a past chairman of the board of the Private Industry Council of Atlanta and serves as a director of Atlanta's Better Business Bureau.

*Restructuring of
Alumni
Organization
Aimed at
Increasing
Responsiveness*

The restructuring of Bryant's alumni association now underway is aimed at making the organization more responsive to the needs of alumni as well as to the needs of the college, according to vice president for institutional advancement Nena Thames Whittemore.

"The alumni need the association for business networking, career advancement, continuing education, and many other services," Whittemore says. "On the other hand, Bryant needs the expertise and support of its alumni in attracting new students, counseling current students about their careers, setting up more regional clubs, planning activities and reunions, as well as in fund raising."

Groups of alumni have been assisting the college in a variety of capacities over the years. Alumni volunteers have been working with the admissions office, career services, in development or serving on the graduate school advisory committee. Now all of these

separate groups will be tied into the Alumni Executive Board to simplify coordination and communication among the various groups and to make the board more task centered.

The college's alumni relations office is also being expanded as part of this revitalization effort. Melissa Walker, who was assistant director of alumni affairs for the past year, has been promoted to associate director. A search is currently underway for a new assistant director to complete the office staff.

"The purpose of these changes is to build a strong and vigorous alumni organization," according to Paula Iacono, director of alumni relations. "We're looking to expand the functions of the alumni association and to coordinate the efforts of the administrative staff as well as alumni, parents and friends, who are working for the benefit of Bryant. We believe the restructuring of the alumni association is an important step in this direction."

Wardyga Heads Alumni Board

Alan Wardyga '77, '84 MBA has been elected president of the Bryant College Alumni Association. An active member of the Graduate School Alumni Steering Committee for the past three years, Wardyga represented that group on the Alumni Executive Board last year.

The new president holds both undergraduate and graduate degrees from Bryant. He received his BS in accounting in 1977 and his MBA in 1984.

A group vice president at Eastland Bank, Wardyga heads up the asset based lending group in the bank's commercial lending department. Prior to joining Eastland in 1986, he was associated with Old Stone Bank for eight years.

Wardyga's wife, the former Diane Zordan, is

also a 1977 graduate of Bryant. The couple reside in North Smithfield with their two daughters, aged 5 and 3.

One of his first goals is to expand and reorganize the Executive Board. Under the new structure, individual board members will interface directly with administrative offices of the college and provide ongoing support, according to Wardyga.

"Certainly, one of the major responsibilities of the alumni association is to support the activities of the college," Wardyga says. "Bryant graduates also benefit from the alumni association in a variety of ways. For example, the association can continue to bring Bryant people together. It can provide an opportunity for business networking, and this is something alumni can use in their present careers."

New trustee hopes to bring alumni view to board

Former Alumni Executive Board president Daniel F. Schmitt '73 hopes to bring the alumni perspective to his new position as trustee. The accounting graduate will serve a three-year term as alumni representative on Bryant's governing board.

A partner with Peat, Marwick, Main in Providence, Schmitt has been involved in alumni affairs for a number of years. He served as vice president of the Alumni Executive Board from 1981 to 1982 and president from 1982 to 1983.

"In my new position, I hope to act as a liaison between the two boards," Schmitt says, "and bring the concerns of Bryant graduates to the Board of Trustees as well as communicate to the alumni the initiatives that are being considered by the trustees. It's an exciting prospect to be a conduit of

information between the two bodies. I think it should make it possible for both boards to benefit from each other."

The new alumni trustee believes that the college's major goals should be to pursue accreditation by the American Association of Colleges and Schools of Business and to continue improving Bryant's academic credentials and reputation.

"Our goal should be one of overall academic excellence," Schmitt says, "and I believe we're definitely moving in that direction. We should be putting out graduates that are immediate and positive additions to the business world. As a member of the business community and an officer of a major corporate employer, it is kind of exciting to have input into that."

President O'Hara

Five Bryant alumni have been named to the Presidential Search Committee formed recently to seek a successor to President William T. O'Hara, who has announced his resignation effective July 31, 1989.

John Renza, Jr. '70, a trustee, is vice-chairman of the Search Committee. Other alumni members are Karl Ericson '58, a former trustee, Jennifer Proud-Mearns '82, and two administrators who are also alumni, Director of Human Resources Janice Lewis '75 and Director of the Center for Management Development Timothy Sullivan '88 MBA.

Trustee Jonathan Farnum is chairman of the Presidential Search Committee. Professor Mary Lyons is serving as executive secretary. Other members of the committee responsible for conducting a nationwide search for a new president are trustees Monica Laurans and Charles Carey, faculty members Robert Farrar and Joseph Ilacqua, and students

Michael Howard '89 and Michelle Duprey '90.

President O'Hara, who guided Bryant through a period of extraordinary growth and development, announced his resignation September 20. During his tenure, he initiated the College's long-term strategic planning process, while paving the way for an expansion of the faculty and the construction of major new facilities. O'Hara said he was resigning "because the college has attained so many of the benchmarks I envisioned for it over a decade ago."

Chairman of the Board of Trustees Bruce M. Selya said he accepted President O'Hara's resignation with "deep and sincere regret." Selya remarked, "During Bill O'Hara's 13 years as president of Bryant, the College has attained an unprecedented level of excellence. Bryant is broader in scope and reputation due to Bill's vision, dedication, and experienced leadership."
