## The campaign to forbid the use of a single word stirs up controversy

*The 'Ban Bossy' movement*

The movement to ban the use of the word “bossy” in a derogatory context has been stirring up discussion in the media and across the United States. Led by Facebook executive, activist and author Sheryl Sandberg in conjunction with the Girl Scouts of America, the campaign is a powerful attempt to foster leadership in young girls. Chances are, if you keep up with social media or occasionally tune into the nightly news, you have heard of the operation; famous ambassadors including Beyoncé, Victoria Beckham, and Condoleezza Rice are also affiliates.

The premise of the attempt to ban the use of the word “bossy” is based upon the harsh reality that young girls are often discouraged from striving to attain leadership positions or from taking a stand as an initiating figure. This disinclination is built upon the fear that their peers will deem them “bossy.” The



target demographic of girls affected by the word are those at a vulnerable stage in social and intellectual development. When young boys of analogous age in a classroom setting are bossy, they are commonly admired by their classmates and are described as assertive, ambitious, and influential. Ridicule for becoming a leader at a young, volatile age is easily transferable to women's hesitancy in

assuming authoritative positions later on in life; such is the basis for why the movement is stirring up such discussion.

In a study conducted by Harold Koplewicz of the Child Mind Institute, it was revealed that elementary school children exhibit a higher preference of being liked and approved by their peers over being a leader. There is a correlation between low self-esteem in teen girls and mental health issues, which Koplewicz points out. However, girls, on average, perform better than their male counterparts in school and earn a higher number of degrees as a group. Why is it then that women compile only a fraction of top executive positions? The campaign attributes disparity to the word “bossy.”

On the contrary, critics argue that instead of banning the word, it would be more beneficial and sustainable to educate girls on how to combat verbal attacks aimed at their personal attributes. The movement

## My angry vagina speaks up

*The Vagina Monologues experience*

One year ago this week, I sat in the front row of chairs, closest to the stage in the old South and watched as a group of some of my best girl friends went up on stage. One by one they read words, words that I was almost too embarrassed to think, to a crowd of over one hundred people.

They read the Vagina Monologues—written by Eve Ensler—off little red cards, and the audience roared with laughter, gasps, and applause. The young women who spoke—Isindy, Heidi, Nastazia, to name a few—were my saviors as a first year student. I regretted that I was there in the audience immediately, but only because I would have rather been up on stage, dressed from head to toe in black and red, speaking out about the experience of being a woman.

In the days after the show I was quick to tell everyone about how amazing it was, about how it inspired me. I was met with

never be able to sit through that; I'd be way too uncomfortable.” I was horrified, but not surprised at how people perceived the show and my reaction to it. It's simply not discussed here. The only time I hear students (especially females) talking about “touchy subjects”—masturbation, assault, rape, gender discrimination, sexuality, vaginas—was in an educational context, and usually part of an assigned discussion in a class or designated workshop. I wanted to talk!

This year I took the leap and signed up. I was chosen to read “My Angry Vagina”—rather

wasn't until I started receiving those weird looks and awkward comments after signing up that I began to understand the anger behind the words.

My anger stemmed from the long hours spent trying to make my body look pretty, from the discomfort surrounding the discussions about being a woman, and the way every discussion I had with other girls was about boys or their own bad experiences. Most importantly, my anger came from this awful feeling deep down inside of me that I was simply not enough; that my body, my mind, my personality, my actions, were just not good enough. I was mad.

When I sat up on stage—this year in front of around two hundred people, including my

mom—I shouted the words I had been reciting in my head for too long. I didn't see any of the faces from where I sat, and I didn't hear the applause when I walked away from the microphone. My mind was at peace because all of that secrecy, discomfort, nervousness, anger, and silence was expelled.

I've been hearing nothing but good things from the people who attended, and nothing but regret from those who missed it. The Vagina Monologues are the conversation starter that this community needs. I encourage all female students to give it a try in their years here, for their own sake. I encourage everyone else to look forward to attending next year.

is subjected to question from a variety of angles because of its specific focus on a word that is not explicitly used in a damaging context. Furthermore, the quality of bossiness is not necessarily synonymous with leadership or success, as the campaign readily suggests. Opponents are firm in the belief that abolishing the word “bossy” is advocating that the characteristics associated with bossiness are flawed, such as taking initiative and being outspoken.

Outside of context, most words or actions can be misconstrued. How fair is it to ban a word that may or may not be attributed to reluctance of women to assume leadership? Sheryl Sandberg claims that the word is a potential killer of women in leadership. If one puts thought to it, there are several potential killers that exist in the world, including fast food, cigarettes, and radiation from electronics. As a civilization enthusiastically committed to freedom of choice and freedom of speech, both proponents and adversaries know the harsh truth: whether or not a certain behavior is condoned, there will always be those who refuse to conform to rules and regulations set forth in the supposed best interest of society. Whether or not one supports the Ban Bossy campaign, it is more or less agreeable to recognize that boys and girls, as well as men and women alike, face adversity through a variety of different channels. The controversial movement is the start of a conversation that will draw attention to this alleged social tribulation.

Humans of Bryant: Discovering the true campus

A picture speaks a thousand words. Perhaps it isn't enough to conclusively define a person, but it can offer a glimpse behind the curtain. This is the driving force behind Humans of Bryant, a photoblog created by Ben Heinemeyer and Rohan Vakil. Armed with a camera, they have made it their mission to give an honest and genuine face to the Bryant community. Inspired by Humans of New York by Brandon Stanton, Humans of Bryant features short interviews accompanied by a photo shot of the individual. Sometimes quotes consist of ten lines, sometimes only one. But no matter the length, each new profile helps paint a more detailed picture of the everyday people at Bryant.

The unexpected mother figure.  
The quirky cook who thinks butter is magic.  
Or maybe just your regular college student trying to make it.  
“We liked the energy of Humans of New York,” explained Vakil. “It’s funny, it’s insightful, you learn a lot from people that are there and just reading what they have to say”.  
Heinemeyer continued, “If you go to a University’s page, it’s scripted and they are telling you certain things. But what is everyday life like? Do I want to be a part of that community? I think that is important”.  
“Everybody is sort of programmed so its about getting past that programmed response to something more human and personal.”

**HONEST BEGINNINGS**  
The product of their partnership has already attracted 320 Facebook followers and 80 profiles, with its popularity being traced back to their simple but sincere approach to photojournalism.  
Naturally, they seemed proud but humble about their accomplishments; so when asked about what got them

started. They stretched their arms across the sofa and began describing their own story.  
“My sister went to see Brandon [Stanton] do his book talk and brought back a sign copied of his book,” Heinemeyer said. I was actually in the hospital with my grandfather who wasn’t doing so well at the time, and we would go through the book.”  
“Him and I were both reading and laughing, and it was just kind of ... timeless. It appeals to everyone”.  
With a smile, he looked over to Vakil and continued, “Rohan started taking pictures of everybody. He got obsessed with photography ... it was kind of annoying.”  
“So one night, we were just hanging out and I suggested this idea ... most of the time, we throw out crazy ideas but then the next morning, Rohan texted me and said “Let’s do it!”.”  
Vakil, thinking back to Stanton’s Humans of New York and what has motivated him to pursue the project, said, “The one that really sticks out for me ... they interviewed an Indian man and asked him what was his greatest investment. He said “My children”. I literally asked my parents the same thing and they said exact same thing. You relate it so closely to your life and sometimes hearing it from another source makes an impact”.  
“Sometimes it is so unexpected. I have been shocked by what some people say immediately,” Rohan said describing the interviews. “Conversations [would] go so deep so quickly.

**FUTURE AND CHANGES**  
“What is your greatest fear?”  
“Graduation.”  
That was Heinemeyer’s response to his own Humans of Bryant interview. While these Bryant seniors remain committed to their site, the inevitable is slowly coming and their future with the site remains unclear.  
“If we can find someone who is interested in carrying the site on, has a good enough camera, dedicated to interview people, and someone with solid interest in

photography, then we would highly encourage them to take it on.”  
But as they tried to explain their situation, the reality that they have yet to think of future steps seemed to weigh on them.  
Because it wasn’t about advertising or future ventures for them. They were too busy enjoying the present; meeting the highly diverse Bryant community and sharing their stories with others. It is that sort of dedication and passion that has many readers constantly curious about their next interview.  
But as if to prepare us, with a bittersweet taste on his tongue, Heinemeyer may have summed it up the best in his interview:  
“I think it’s taboo to say you don’t like change ... it coincides with being human. It’s inevitable. Change is inevitable”.

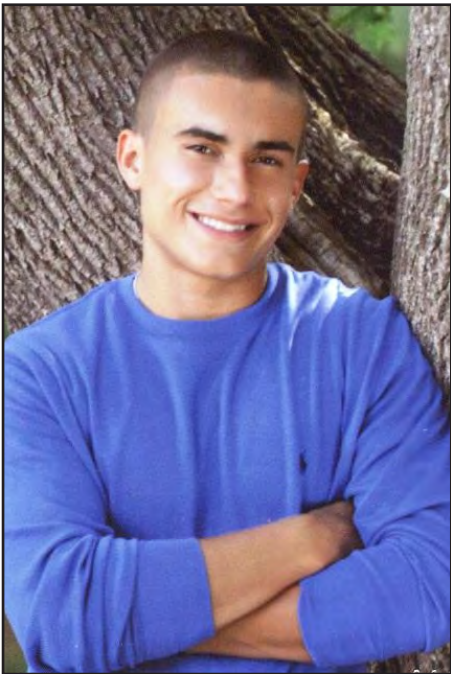

# Ethanol: good or bad?

Due to the increasing limited availability of fossil fuels, alternative and renewable sources of energy have grown in importance over the past decade. There is a high need for sustainable sources of energy that will provide energy for our future generations. Although, renewable sources of energy establish a much cleaner environment, every energy source has pros and cons. In the United States of America, scientists use starch in corn kernels to produce ethanol as fuel. Ethanol production may seem like a great solution to the world’s energy crisis, but commercial production of ethanol from corn kernels causes many problems such as using large amounts of fertile land and not fully replacing the world’s current consumption of fossil fuels.

According to an article by Michael Sojka from Stanford University, “Fuel ethanol uses around 12 million acres of land for corn, about 15% of the current acreage used for corn production.” As the earth’s fossil fuel supply depletes, the world’s reliance on alternative fuels and bio fuels will increase thus increasing the amount of land used for ethanol production from corn. Corn is used in many food products and 70% of corn is used as food for livestock. Using more corn for ethanol production will greatly decrease the world food supply. Approximately 13% of the world’s population goes hungry every year, and substantially decreasing corn supplies worldwide will cause millions more to starve.



Secondly, for ethanol production from corn to truly be feasible, ethanol production must increase substantially to meet the world’s current demand for energy from fossil fuels. For example, in 2009, the United States of America would have had to produce 240 billion gallons of ethanol to equal the same amount of gasoline consumed. However, the United States of America only

produced 8.9 billion gallons of ethanol. With the current available technology, ethanol production from corn does not present a feasible technology to replace the world’s consumption of fossil fuels.

Our world truly needs renewable sources of energy before a tipping point of no return is reached. Using bio-fuels such as corn as an alternative and renewable energy source can be proven effective if world governments use bio-fuels in an energy efficient manner. More advanced research in the fields of alternative energies is needed to make renewable energy sources economically feasible in the near future. Without the assurance of a stable economy, governments will never switch over to renewable energy sources before it is too late. Lastly, the world’s perception that scientists will discover a perfect energy source with zero cons needs to change. There is no perfect energy source or “Mr. Good Energy,” but the world’s energy crisis can be solved through increased diversification of alternative energy sources. Through the use of many different sustainable energy sources such as solar power, bio-fuels, hydropower and backup generators powered by fossil fuels, countries will have long lasting and more sustainable energy supplies. By using this method, our world will have energy sources for future generations.

# Kelsie’s Korner Cinnamon Scones

What a wake-up call! If the smell of cinnamon wafting under your nose doesn’t get you out of bed, I don’t know what will. These cinnamon scones will make you push your cereal bowl aside, never to go back to those boring oatmeal mornings. One scone in your stomach and I guarantee a 100% better day ahead of you. You may not even need that early morning coffee after the sugar rush these scones will provide. Loaded with sweet, cinnamon flavor delicately balanced for a light and moist taste, these scones will make a Monday seem like Friday. Yes, you can stop at a nearby café and buy a scone, but your wallet will be happier if you made these instead. After you put them in the oven, you are sure to say, “That’s it? That’s all the work I had to do?” If you ever need something quick and delicious to whip up, impress the guests, and turn your home into a cozy breakfast nook, this is your go-to recipe.

- Ingredients:**
- Scone Batter
    - 1 3/4 cups (8 3/4 ounces or 235 grams) all-purpose flour
    - 3 tablespoons granulated sugar
    - 1 tablespoon baking powder
    - 1/2 teaspoon salt
    - 8 tablespoons (4 ounces or 115 grams) unsalted butter, cold, cut into 1/2-inch cubes
    - 1/4 cup (60 mL) half-and-half, cold
    - 1 large egg
  - Filling
    - 2 tablespoons granulated sugar
    - 2 teaspoons cinnamon
    - 1 tablespoon granulated sugar to sprinkle on top



- Directions:**
- Place an oven rack in the middle position. Preheat the oven to 375°F (190°C). Line a sheet pan with parchment paper.
  - To make the batter:
    - 1.in a large bowl, combine the flour, sugar, baking powder, and salt.
    - 2.Cut the butter into the dry mixture until it resembles coarse cornmeal but is not clumping up. Stir in the half-and-half and egg until combined.
  - To make the filling:
    3. Roll out the dough on a lightly floured surface to a 10 x 6-inch rectangle.
    4. Sprinkle 1 tablespoon sugar and 1 teaspoon cinnamon over half of the rectangle, and then fold it in half.
    5. Roll the dough out again into an 8- x 6-inch rectangle. Sprinkle the remaining tablespoon of sugar and teaspoon of cinnamon over half of the rectangle, then fold in half.
    6. Pat the dough into a 6-inch circle, and cut into 6 wedges.
    7. Evenly space the wedges on the pan, sprinkle with sugar, and bake until golden and just firm, about 15 to 17 minutes.
    8. Let the scones cool on the pan for 5 minutes. Then transfer to a wire rack to cool. Serve warm or at room temperature.

## Facebook Acquires Oculus VR

Virtual reality: the pinnacle of entertainment and every gamers dream. Over the past two years, Oculus VR, with founder Palmer Luckey at the helm, has been working to make virtual reality the future of gaming. Their main product, the Oculus Rift, received an incredibly favorable response after a demonstration at E3 in 2012 and went on to receive over \$2.4 million via crowd funding.

So just what exactly was Mark Zuckerberg thinking when he announced the acquisition of Oculus VR for \$2 billion by Facebook on March 25? Gamers as well as investors are still stumped at the social media site's purchase, and many more are worried about what will become of the device that was once touted as the future of virtual reality and gaming.

Facebook's acquisition of Oculus VR raises a lot of

questions at first glance, but when looking at the bigger picture, Facebook's strategy comes into focus. As Forbes contributor Gordon Kelly points out, Facebook is no longer just a social media giant; its acquisitions in recent years have positioned it to become a conglomerate within the technology industry. Often in technology acquisitions, the purchased company is stripped down to its core value and that aspect is used to complement the purchasing company. Facebook's acquisition strategy as a conglomerate appears to be much different.

Zuckerberg's own Facebook post stated "Oculus will continue operating independently within Facebook," assuring the public that its value will not be lost. Other acquisitions by Facebook, including Instagram and WhatsApp, have utilized similar strategies, continuing to operate independently but utilizing Facebook's assets and market power to ensure their continued success. Facebook's emergence as a conglomerate comes as a surprise, but its ability to continuously generate revenue means it can continue to fund its acquisitions.

The online backlash from Facebook's unexpected purchase has been swift and harsh. Many

early supporters of Oculus VR from its Kickstarter days were quick to criticize Oculus for their apparent "sellout" and betrayal of the indie and community-focused business model to which they were originally committed. Palmer Luckey doesn't see it this way however, heading to Reddit to say that he sees it as an opportunity to "execute on some of our most creative ideas and take risks that were otherwise impossible."

While the vision may stay the same, the question over creative control undoubtedly crosses the mind of those anticipating the release of the Oculus Rift. In his announcement, Zuckerberg stated that gaming would continue to be the focus of the project, and that other applications for the classroom and communication would be secondary.

However, with Facebook's reliance on ad revenue, it seems likely that Facebook's management team will exercise some control to integrate Facebook into the Oculus Rift in order to expand its social media reach as well as bolster ad revenue, a fact that gamers and tech junkies everywhere fear will soon become a reality.

## Pay packages of top Google Execs

This past year Google paid its co-founders, Larry Page and Sergey Brin, their usual \$1 salaries while Executive Chairman Eric Schmidt's compensation more than doubled to \$19.3 million. A significant portion of Schmidt's raise was on behalf of stock grant valued at \$11.4 million. According to regulatory documents filed Friday, the grants were issued by Google to make up for an administrative error that occurred in February 2011 while handling another large award given to Schmidt. Without the mix-up, Schmidt's most recent pay package would have risen 4 percent from the \$7.6 million he received in 2012.

Since Google Inc. went public nearly a decade ago, Page, Google's CEO, and Brin, another top executive, have insisted on capping their salaries at \$1 annually. They joined a group of numerous Silicon Valley executives in this symbolic gesture; they have accumulated large fortunes through stock ownership in their respective companies. Brin, 40, and Page, 41, both currently own Google stock worth about \$26 billion. Not to be overlooked, Schmidt, 58, has also amassed wealth estimated at \$9 billion by Forbes magazine. He also limited his salary to \$1 annually while he was CEO.

Since Schmidt turned over his CEO position to Page three years ago, the pay scale has changed dramatically. In 2011, Schmidt received compensation valued at \$101 million, with most of

the money coming from restricted stock which was designed to keep him working at Google. Recently, Google disclosed that Schmidt is receiving another stock award valued at \$100 million this year.

In his new role, as Google's executive chairman, Schmidt primarily handles government relationships, regulatory issues, and company acquisitions. As a token of appreciation for a job well done, The Mountain View, California company paid Schmidt his maximum cash bonus of \$6 million in addition to his \$1.25 million salary. He was the only employee who qualified for their maximum bonus last year.

Google and its stockholders fared well last year as well. The company's earnings rose 20 percent from the previous year to \$12.9 billion and its stock price gained 58 percent. Standard & Poor's 500 index increased by 30 percent last year. This provokes the debate topic of whether top corporate executives are compensated too greatly. Critics believe that the work they do does not warrant their astronomical pay packages, while supporters believe the revenue they help generate for the company is far beyond what they are paid.



## Keep your options open

When we create teams in the workplace, we often find ourselves frustrated with the results. We anticipate that the whole will be greater than the sum of the parts, yet the team does not always achieve this potential. When a team falters, we should examine several potential causes: bad leadership, poor team design, flawed team process, and a climate in which people do not feel safe speaking up. Leadership, design, process, and climate are key enablers of high team performance.

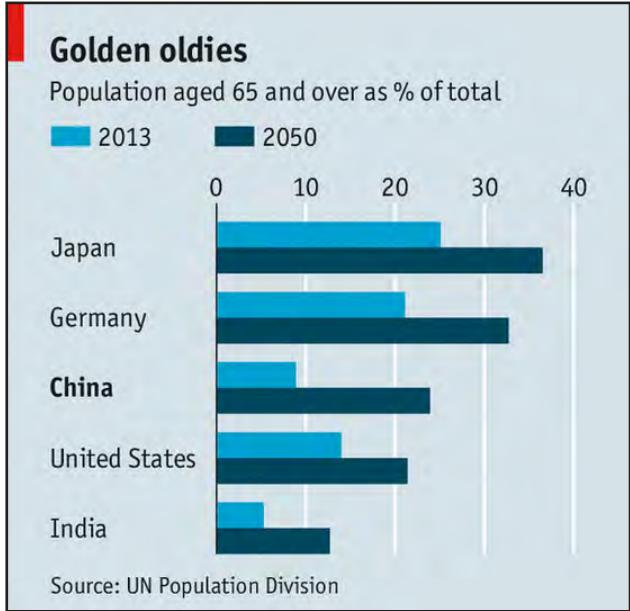
Let's take a look at team design for a moment. What are some of the classic design mistakes that organizations make?

1. Leaders build teams that are too big. In a story in the Wall Street Journal, Apple engineer Greg Christie describes how the original iPhone development team was "shockingly small." In this great blog post by Stanford Professor Bob Sutton, he explains that the optimal number for most teams is seven, plus or minus two. In my latest book, I talk about Intuit's "two-pizza" rule - build teams that can be fed with two large pizzas. The "two-pizza" rule fits pretty nicely with Sutton's guidance, which is based on research by scholars such as the late Richard Hackman.

2. Leaders create teams with "invisible" homogeneity. Many leaders focus on gender, racial, and ethnic diversity when building a team. Can a "diverse" team along these dimensions still be considered quite homogenous along other important dimensions? YES! Many teams with "visible" diversity have "invisible" homogeneity. In other words, many members come from the same educational institutions, have the same functional backgrounds, and have worked in the same company or industry for years. Homogeneity along these teams mean that the team members think alike in many ways and do not bring fresh alternative perspectives to the table.

3. Leaders build teams in which members do not have a clear commitment to making the team's work a high priority. In many cases, people serve on multiple committees or task forces at work. They are serving on a team in their "spare time" at work. The team's task is not a focus of their attention. If too many members fall into this camp, the result will not be successful. Leaders need to think carefully about how team members are selected, as well as how many teams a particular individual is serving on simultaneously. In an odd way, the star performers in an organization can become the problem here. They are often assigned to many teams and task forces because they are so smart and effective. However, they can easily find themselves spread too thin. As such, they become a liability to certain teams on which they serve, because they cannot provide the group enough attention and effort.

## Dreams Conn-quired: Uconn wins thriller over Kentucky to capture NCAA championship

After what has been one of the most surprising tournaments in years, it came down to two "Cinderella Stories" to see who would be college basketball's champion. With each team facing some adversity and controversy, the stars were aligned, and two of college basketball's best teams were set to fight for the ultimate crown.

Uconn defeated the University of Kentucky, 60-54, to cap off what was a phenomenal tournament, giving Uconn its fourth National Championship in the last sixteen seasons. The seventh seeded Huskies completed what was an improbable journey to the title, beating teams like Florida, Villanova, and Michigan State to get to the final championship game. It gave the Wildcats a boost and some momentum heading into the later half of the game. After some big plays from Randle and Poythress, Kentucky was able to cut the lead to just four with just over three minutes remaining. However, in these moments big players make big plays, and this was Napier's time to win the big game. He made great plays down the stretch, including a contested midrange shot to secure the final victory for UConn, 60-54 in what was a great game for both teams.

Despite the loss, Kentucky has a foundation set to be competitive again. They were the first team to play seven freshman in a National Championship game and should return some of their players next season. Uconn - although Napier is leaving - should have some of its important players return and could make another run yet again. So after an exciting wrap up of what was a wild March Madness, congratulations to UConn, and it will be exciting to see what they will do to stay competitive next year.

# Durant gone wild: Kevin Durant proving he is NBA’s best player in chase of first MVP

# Bad boys of the league: Jackson’s release reminds us of troubling athletes that are in sports

The recent cutting of superstar wide receiver Desean Jackson by the Philadelphia Eagles reflects a new strategy for dealing with a decades old issue in the NFL. One prominent theory on the move states that Jackson was cut from the team due to the WR’s alleged affiliation with gang members.

Although he didn’t directly take part, in the past few years DJax’s name has come up in relation to two separate murders in Los Angeles. Both murders involved the Crips, a nationwide gang with an estimated 55,000 members. Jackson’s friend was arrested for the first murder, the shooting of a 14 year old boy.

Shortly after the arrest the receiver posted a picture of the man, Theron Shakir, on Instagram with the caption, “Free Trezzy #Real1 #Jaccpot”. Jaccpot is Jackson’s record label that Theron is signed on as a rapper. The second murder happened after a party, outside of a building that turned out to be leased or owned by one of Jackson’s family members. None of this evidence implicates Desean in any crimes but it is still very concerning to the parties invested in the receiver financially. Organizations with a direct stake in Djax and his

behavior/reputation are the NFL, his team, and any sponsors he is signed on with. Keeping in mind that these character concerns are not uncommon in today’s NFL, that doesn’t mean they should go overlooked. Teams are being more mindful and proactive about players’ off the field activities since the heavily

publicized murder investigation and subsequent arrest of ex-Patriots tight end Aaron Hernandez. Another even more recent example is the bullying scandal between Richie Incognito and Jonathan Martin of the Miami Dolphins. In that case, Martin effectively quit the team after he claimed he was bullied by

Incognito and others on the team to the point of a mental breakdown. This situation occurred in the middle of the Fins’ season and was covered nationally on TV, radio and in print for months. The incident served as a damaging distraction to the Dolphins team during their run to make the playoffs. It’s easy to think that players

are employees and what they do “off the clock” should be held in a separate light than what they do on the field but that is absolutely not true. Desean Jackson or any other pro’s actions, negative or positive, reflect on the image of the aforementioned parties with a stake in him. 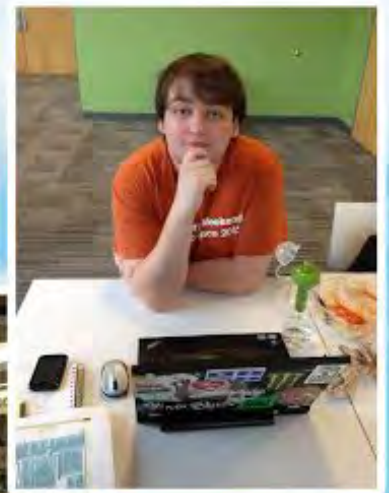

## The sentencing of death row

In all of the United States, there is a place that you never want to be, and it stretches across several states. This place is commonly referred to as Death Row. It is an exclusive place, for the most dangerous of criminals (mostly rapists and murderers). There are people that argue, not only do they deserve it, but that it prevents future crimes. Others argue that it is wrong for people against murder to believe that you can justifiably kill a person. So the question is, which one of these groups has the moral high ground?

This sounds like it is almost no contest. At least most people do not want to live in a world where murderers and rapists can be unpunished. This is because, that would indicate that this behavior is acceptable, so punishment is justifiable. But now I ask, what kind of punishment is justifiable? Is death truly the one that is best for society at large?

Let's start with a closer examination of the arguments in support of the death

penalty. According to a presentation given at the University of Richmond, they stem from the belief that nothing is more sacred to an individual than their life, therefore losing it is the ultimate punishment. Again, this appears to be common sense. Supporters go on to argue that murder rates are lower in states that have the death penalty because of its deterrence, and that the more executions there are the less murders there are. As with all hypotheses, the ones just mentioned require testing.

In the same University of Richmond presentation, the murder rates of states with the death penalty were compared to those of states without the death penalty. For the first hypothesis, they compared Texas (a death penalty state) to Michigan (a non-death penalty state). Recall that this difference should cause Texas to have a lower crime rate than Michigan. But, according to this presentation, from the year 1970 to the year 2000 it was Texas having more crimes, except for the year 2000 (by only .8 per 100,000). And when Texas was higher in murder rates than Michigan, it was by much more significant margins, reaching 6.7 more per 100,000 at one point.

But, one could argue that this would not be a good sample for fifty states, so there was another test. This one was between Virginia (a death penalty state) and Massachusetts (a non-death penalty state). This went further in disproving the first hypothesis, as Virginia's murder rate stayed consistently, and significantly, above that of Massachusetts.

But what about between states that have a death penalty? The second hy-

pothesis states that the states that use this punishment more aggressively will have less crimes punishable by death. Take for example, Missouri and Montana both of which have the death penalty, with Missouri being the more aggressive with it. Like the first hypothesis, the second one does not appear to hold, because Missouri had significantly higher murder rates than Montana from 1976-2004. Now let's give hypothesis 2 the same sampling as for hypothesis 1, and see the results from another pair of states, for instance Oklahoma vs. Pennsylvania. Again, both of these states have the death penalty, and Oklahoma has had a larger number of executions from 1976-2004. According to the hypothesis therefore, Oklahoma should have a lower rate of murder than Pennsylvania. Even though this test has closer results than the Missouri vs. Montana test, Oklahoma still had a higher rate of murder than Pennsylvania from 1976-2004, which goes toward disproving the second hypothesis.

To recap, the two fundamental hypotheses to support the use of the death penalty as a way to improve society have been disproven on two occasions each. Can it be said that the higher rates are 100% attributable to the death penalty with 100% certainty? I doubt that, but these tests still prove

to me that the death penalty cannot be declared as absolute a remedy as much as supporters believe it could. In addition to these tests, on a personal note, with the inclusion of DNA evidence, we have revisited some crimes far in the past, crimes for which people had been executed. As it turned out, these people were innocent and it is way too late to repair the damage. As opposed to other punishments, once the death penalty has been carried out, nothing can be done.

These constitute the issues I have with the death penalty, it does not work for society, and if somebody is wrongly convicted of a capital crime, not only is the real offender still out there, but now the legal system itself would soon kill an innocent person. There is no doubt that murderers and rapists should be punished, but now I ask should we do it with murder? A well-respected wise man once said, "an eye for an eye will make the whole world blind."



## Miley Cyrus: bad influence or hero to feminism?

*Miley may be different than she was in her past, but her beliefs remain the same and have some positives*

Whether you love her or hate her, it is impossible to deny the fact that Miley Cyrus has made a huge impact on pop culture and the media in the past year. Miley's Bangerz tour made a local stop last Wednesday, April 2 when she performed at TD Garden in Boston. The class is entitled "The Sociology of Miley Cyrus: Race, Class, Gender and Media," and the professor who will be teaching the course, Carolyn Chernoff, said that it will focus on role of race and

gender in pop culture. It will also examine the media's reaction and influence in Miley's career and pop culture in general.

Miley began working on her new image when she chopped off her long hair in favor of a short, platinum blonde pixie cut in August of 2012. Fans and critics were all shocked at the new look that seemed not to fit the Miley we all knew. Of course, this was just the first of many radical changes coming up in Miley's life. Next came her split from fiancé Liam Hemsworth in September 2013 after months of breakup rumors. This had a major impact on her music, and seems to have pushed her towards her new image.

Miley was onstage "twerking" beside Blurred Lines singer Robin Thicke, dressed in nude colored underwear. However, one fan said that "She actually makes me feel good about my body and appearance. A lot of people think she's gross or disgusting because she usually is in various states of undress. However this is actually empowering for me, I'm glad



to see another woman who's comfortable in her own skin and knows her body isn't taboo."

Our society certainly has many taboos when it comes to the body. Whether you have modest or liberal values, it is easy to see that the female body is highly constricted with rules about what is and is not appropriate. In many public schools, there are dress policies that forbid shorts that do not reach beyond your fingertips, shirts that reveal girls' shoulders, and even yoga pants and leggings. There are almost no dress code

restrictions placed on men.

It is more of the same in the media. During the 2014 Super Bowl halftime show, Anthony Kiedis, lead singer of the Red Hot Chili Peppers, performed shirtless beside Bruno Mars. Lil' Wayne performed shirtless at the 2012 VMAs. Justin Bieber performs shirtless at almost all of his concerts. For some reason, it is socially acceptable for these men to take their shirts off onstage without anyone giving it a second thought.

# Total lunar eclipse to take place on April 15

Is this time of the year a little too “taxing” for everyone? Well, I’ve got the perfect astronomical event to help you relax. On April 15, stargazers here in Southern New England will have an opportunity to observe a total lunar eclipse. Though the Moon will set before the eclipse completes, we will be able to watch this celestial event from the beginning until just after the outgoing partial phase ends.

For some of you this lunar eclipse will be challenging to observe. Not technically challenging mind you – temporally so. It occurs on a Tuesday morning

between midnight and dawn. A workday for most. A schoolday for many others. However, if the weather cooperates, you can catch some shut eye during the previous evening, and then set an alarm clock for the specific phases of the eclipse you’d like to observe. A full schedule of the eclipse can be found at the conclusion of this column. Use it to plan out your morning.

While I encourage more dedicated Moon observers to watch the eclipse from start to finish, many casual stargazers may consider that decision sheer lunacy! Why not at least try to observe all of totality? This guide will provide all the details you’ll need to understand and enjoy the event. All times are EDT (Eastern Daylight Time), also known as DST (Daylight Saving Time).

A total lunar eclipse occurs at Full Moon when the Sun, Earth and Moon are in a straight line. With the Earth positioned in the middle of this celestial configuration, its shadow is projected onto the lunar surface.

The eclipse technically begins at 12:53:37 a.m. when the Moon, nestled among the stars of Virgo, slides eastward into the Earth’s light penumbral shadow. This dim initial phase is undetectable. Only as the Moon slides deeper into the penumbral shadow will a keen-eyed observer see a subtle shading of the lunar surface from left to right. It is just prior to the Moon entering the Earth’s dark umbral shadow that one notices that the moonlight looks somewhat subdued.

When the Moon first encounters the dark umbral shadow at 1:58:19 a.m., the partial phase of the eclipse begins. For one hour and eight minutes the Moon will move deeper and deeper into the dark shadow, generally from left to right. Then at 3:06:47 a.m. the Moon will be completely immersed in the Earth’s dark umbral shadow and totality begins. Will the Moon completely disappear from the sky during totality? It all depends upon how much dust is in the Earth’s atmosphere at eclipse time. We’ll know by mid-totality at around 3:45:40 a.m. Totality will

last until 4:24:35 a.m. for a total duration of one hour and eighteen minutes.

During totality please take careful note of the various hues of color on the lunar surface. Enhance your view with binoculars or a small telescope if you have them. The lunar landscape often looks ashen during totality, with subtle copper, orange or red tones scattered about. And the colors often change as totality progresses. So watch carefully. It is truly a beautiful sight to observe.

In addition, throughout the eclipse carefully scan the limb (edge) of the lunar disk using a telescope. This region of space is star-rich, so you’ll notice stars being covered on the left limb and uncovered on the right limb as the Moon moves eastward through the star fields.

Totality ends at 4:24:35 a.m. when the Moon begins to leave the dark shadow and sunlight returns to its surface. For one hour and eight minutes the partial phase will continue until the entire Moon is completely illuminated once again at 5:33:04 a.m. For a while the Moon’s light will still look somewhat subdued as the Moon will remain within the light

penumbral shadow until 6:37:37 a.m. when the eclipse ends. Usually in a dark sky you would be able to detect this shadow soon after the partial phase completes. However, Sun rise is at approximately 6:05 a.m., so bright twilight will most definitely spoil the view. Also, the Moon sets locally around 6:12 a.m., and unless you have an unobstructed west-southwestern horizon you’ll lose sight of the Moon before then anyway.

Throughout the eclipse I want you to notice the bright object below the Moon. It is Virgo’s brightest star Spica. Also, above and to the right about 7.5 degrees away you’ll see reddish Mars. Before the eclipse begins only a few bright stars will be seen since the Moon is full. As the eclipse progresses and the sky becomes darker, watch as the fainter stars emerge into visibility. Afterwards the dimmer stars will “disappear” when the lunar illumination returns.

I hope the weather will cooperate on the morning of April 15 for stargazers of every interest level to take advantage of the magnificent circumstances which produce the beauty of a total lunar eclipse. If you miss this one for

any reason we will have another total lunar eclipse opportunity on October 8. However, once again that one will also occur during the early morning hours. And regrettably, we will see only the partial phase before totality and only 31 minutes of totality here in Rhode Island before the Moon sets.

A chart of the important phases of the April 15 total lunar eclipse is provided. All times are Eastern Daylight Time.

Good luck, keep your eyes to the skies, and many happy returns!

In conclusion, please remember that the local observatories are open for your viewing pleasure. Visit their respective websites for public observing schedules. Seagrave Memorial Observatory ([www.theskyscrapers.org](http://www.theskyscrapers.org)) in North Scituate is open every clear Saturday night. Ladd Observatory in Providence is open every Tuesday night. Frosty Drew Observatory in Charlestown is open every clear Friday night.

Seagrave and Ladd will not be open for this total lunar eclipse. Frosty Drew plans on opening for the entire event. See their website for updates.

Tapping into your psychic abilities can be of some benefit, however. Being in touch with your supernatural side can help you maintain balance and control

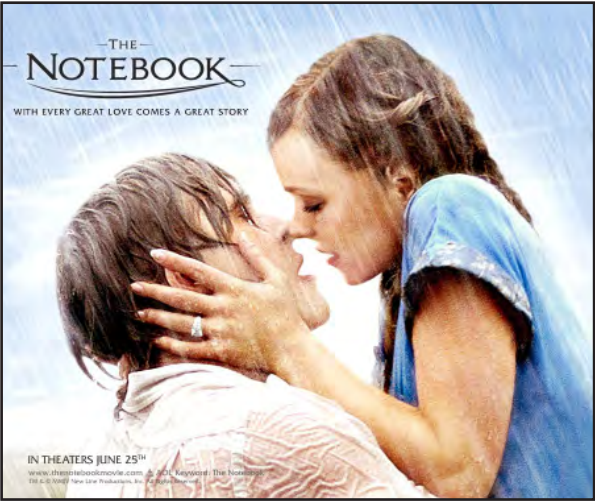

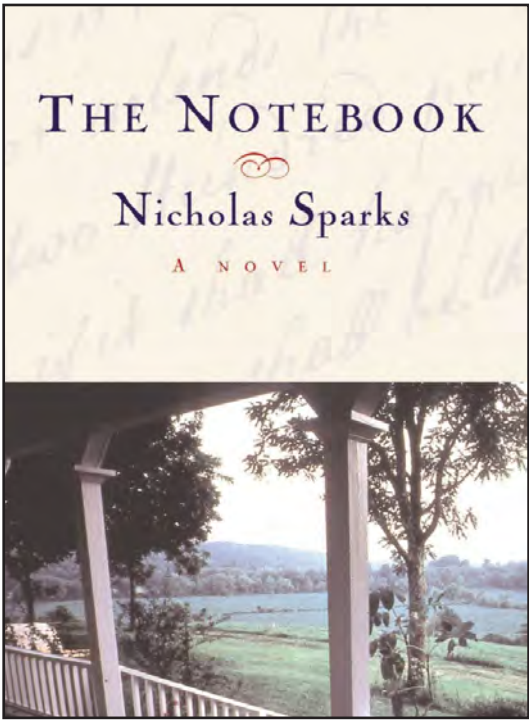

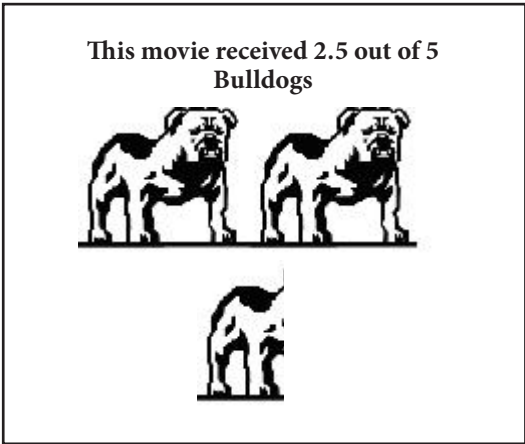

The last attempt at a movie about Jack Frost was in *The Santa Clause 3: The Escape Clause*, which was enjoyable, yet easily dismissible. Now, we’re introduced Frost in a new light, as a fun-loving and often overlooked magical figure, bringing snow days and blizzards to the world, wanting nothing but acknowledgment in return. In the wake of the re-emergence of the Boogeyman, Jack is called to join Santa, the Tooth Fairy, the Easter Bunny and the Sandman as a Guardian to protect kids from fear and to keep belief in their hearts.

The Boogeyman (referred to in the film as Pitch Black, Pitch for short) is tired of being forgotten and unnoticed, and plans to eradicate the Guardians’ existence by making the world forget about them, specifically by bringing nightmares to overpower Sandman’s dreams and sabotaging the Tooth Fairy’s nightly collections, and reinstate fear. Because of this, kids start to lose their faith, and the Guardians become weaker as Pitch gets stronger. Early on in the film, Jack brings a snow day to a young boy named Jamie and his friends. Jamie is the embodiment of innocence. Even though every single child in the world eventually stops believing, he doesn’t.

What really makes this movie such a standout is the original take on the characters. The Easter Bunny could’ve been a disgruntled mercenary or police chief in another life. Santa is a buff, tattooed guy with a Russian accent, and his elves are very similar to the minions in *Despicable Me* with their behaviors. Sandman is mime-like, and his

nonverbal communication comes off hilariously to the audience. Tooth Fairy doesn’t have a distinctly different character, but the idea of her having thousands of “Baby Tooth” fairies doing her job for her was a clever idea.

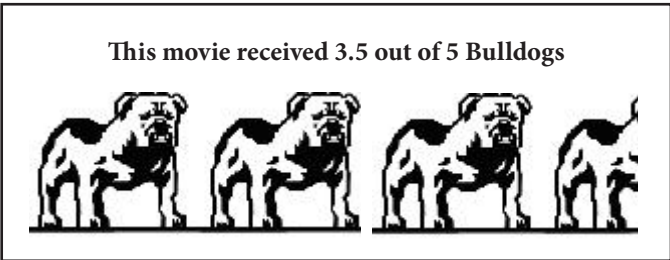

In a technical sense, this film also succeeds. An animated film has never won the Oscar for Best Production Design, but this might break the streak. There was a chunk in the movie that focused completely on the guardians, with no exposure to Jamie whatsoever. I get why they did this. This was Jack’s story, not Jamie’s. I loved Jamie’s character though, and given enough attention in a future installment could potentially make him as landmark a child character from an animated movie as Andy from *Toy Story*. A more in depth character study on him is something I would eagerly see.

This movie is a blend of *Despicable Me* and *The Avengers*. While I did enjoy *Despicable Me* more than this, and I didn’t get to see as much from the character Jamie as I would’ve hoped, I highly recommend this movie. It was definitely a film made for children, but I applaud it for its smart dialogue, original take on characters, and refusal to dumb down for its demographic. ## Gay and Greek: The push for ‘active acceptant’

As fraternity rush concludes its first week and sorority rush approaches, the challenges surrounding rush may be particularly accentuated – given the stereotypically heteronormative culture structuring Greek life – for members of Stanford’s LGBTQ community, some of whom enter the process with reservations about whether or not they will be accepted.

“I definitely had some initial hesitation and reservations about the whole process because of the fact that I am gay and because it is so traditionally heteronormative,” said Brandon Caruso ’16, a member of Sigma Nu. “Overall, there are definitely a couple of frats that I didn’t even consider, because of my personality maybe, but [also] I didn’t think I could see any gay guys going there and that kind of added to the feeling of being uncomfortable with it.” When Rob Franklin ’15, another openly gay member of the Greek community, went through fraternity rush, he limited his choices to just two fraternities.

“The decision to rush those two was probably somewhat affected by my ideas as a freshman on which fraternities were gay-friendly,” Franklin said.

Franklin reflected that thought process might have been misguided.

“I think more of them are more gay-friendly than I would have thought as a freshman,” Franklin explained. “I have gay friends in other fraternities as well who have had completely great experiences and I don’t think that I would have thought that as a freshman.”

However, Franklin’s perspective is not uncommon, especially with regards to rush. The Panhellenic system across America is no stranger to allegations of discrimination, and the traditional gender segregation of fraternities and sororities can make them seem especially unwelcome to queer-identifying students.

Franklin stressed that despite his own positive experience, the Greek community does seem closed off to students in general – intentionally or unintentionally – and particularly to minorities.

“I think that all of the Greek organizations just need to be more cognizant of how their reputation – knowing that their reputation may be completely flawed to what the actual community is like – looks like to the average Stanford student,” Franklin said. “And if they care about that and want to change that reputation then there are ways to show that they are more welcoming communities.”
