

On November 30th, I was given the pleasure to interview the United States, Senator Sheldon Whitehouse. It is always great to speak with Senator Whitehouse and I would like to thank the Whitehouse staff and Senator Whitehouse for helping to get this to happen.

Matthew Carvalho: I would like to thank you again for taking a few minutes to speak with me today. So, I do want to ask you a few questions about the upcoming legislative credibility with a lot of Americans, and in





I hope the effect of it will be the Saudis realize that despite the president's unexplainable attitude about them, they cannot just take America for granted and behave in this casual murderous fashion and expect no serious consequence.


Carvalho: Also, another thing that was recently passed by the US Senate was a measure to strongly condemn Russia's attack on the Ukrainian Navy. I also want to get your thoughts on this and how it will affect our ties with Russia as well.

Whitehouse: I think it's a little bit of a similar situation. I think we need to send a message to the other nations of the world that when they behave in despicable and unjustified ways, there will be a price for that. From everything that I have heard, the Russian Navy attack on Ukrainian vessels was hostile, unprovoked, lethal, and there have been no apologies or amends made. So, when you look at the history thereof the Russian little green men coming in and invading Ukraine and ceasing a lot of it for Russia, it's hard not to see this in the context of a continued Russian effort to destabilize the sovereign nation of Ukraine.

Carvalho: Going on to the upcoming legislative session, my first question on that is: what are your thoughts on the new Senate that will be starting up this next year in 2019 and your thoughts on the new members of the Senate?

Whitehouse: Well it's going to make it a lot easier for sketchy nominees to get through the Senate. We just stopped a judicial nominee, who had been directly involved in voter suppression schemes that federal account courts held were targeted at black voters with what the courts call "surgical precision". But we were only able to defeat that nominee by one vote because two Republicans were willing to vote against him. So, in the next Senate, those two Republicans could vote against an equally offensive nominee and he would be confirmed because their numbers grow in the Senate and they would still, with two Republicans objecting, have adequate votes to confirm this individual. So, there's a really hands-on example of what that difference is.

Carvalho: Could I ask who that nominee was?

are the minority party, and the agenda of the Senate is largely dictated by the majority party. So, I would open with that one caution. I do note that because the house is now in Democratic hands, the leadership in the Senate, on the Democratic side, has the ability to work with the Speaker and her team in the house to help make sure that legislation that the house passes is [put] in a way that gives us the best chance of passage in a Republican Senate. So, I think the Democratic priorities in Congress are going to be infrastructure. We're long overdue for a major infrastructure bill. I think student loans would be an important priority; we're long overdue for relieving folks of the terrible student loan debt that is carried right now. I hope an expect that we will be able to pull together, with any luck, a bipartisan coalition to do a serious climate bill. We need to root out the dark money, the anonymous political spending that is such a plague on our democracy, and we need to keep up our good bipartisan progress in two areas. One is opioids and the other is oceans. So, I think that's kind of a priority list for me depending on what seems feasible and what can

wobbling and fighting, there's actually a considerable array of issues that have not been weaponized politically and where Republicans and Democrats work together quite well. The last two topics that I mentioned, opioids and oceans, are two of those areas. Another one is budget reform, we have, I think, a very strong bipartisan substance in the select committee I serve on to try to try to reform the budget appropriations process, and while we should run out of time this year, I think next year we take the substance of that and put it into new legislation. There's going to be a bipartisan activity. So, there's actually a fair amount of bipartisanship that proceeds quietly and without much other note or rancor.

Carvalho: My last two questions are directed more towards about you personally with the Senate. My first question is: a couple months ago with the Kavanaugh hearings, those are over now, but you did ask him about some of the terms he used, what they meant. You received some praise for this, you received some flak for it. I do just want to ask your thoughts on that, and about how it was trying to be used against you back in the election against Flanders, and do you think Kavanaugh was actually telling the truth about that at all?

Whitehouse: So I can answer the second question first. I don't think there's anybody who believes he was telling the truth about that. I'd yet to hear one person believe that he was telling the truth when he defined those terms, and I think the reason that the reason the rightwing got angry about that was he got basically called out making stuff up while under oath as a candidate for the United States Supreme Court. So, I don't have a lot of regret over that, and indeed as I engage with Rhode Island voters through the campaign and even afterward, the longest single sentiment that I get is "thank you for what you did in the Kavanaugh hearing". So, I think there was kind of a rightwing meme that they tried to develop about this, but I don't think it's stuck. It certainly didn't hurt me in the election, and to the contrary, I think this is the thing upon which in recent weeks I've had more support and more praise than any other issue.

Carvalho: In regard to this interview, my last question is: so what is next for Sheldon Whitehouse. Now that you've won this election, what do you plan on doing next? Is it just running for Senate again in six years or- what's your next goal?

Whitehouse: I'll make the decision about running again closer to the next election that seems like a long way off. I have no ulterior motive in serving in the Senate for Rhode Island. I have no intention of the executive office, or judicial office, or anything else. I've now been around the Senate long enough so I think I've built up considerable goodwill and credibility and have shown that I can be an effective, bipartisan partner, as well as an effective partisan advocate when I need to be. So, I'm very satisfied that the Senate is going to be a successful place for me in the years ahead and I don't have any other aspirations.

Whitehouse: Barr is his last name from North Carolina. move at a given time.

Carvalho: My next question is: what is the agenda of the new Senate Democrats for the session and what is your own agenda? What do you plan to do on your own for this?

Paris erupts into national emergency as 'Yellow Vest Protests' are waged

For the fourth consecutive weekend, anti-government protestors angry with the French government's raising of taxes on gasoline and diesel fuel descended upon Paris. The protestors, many donning yellow reflector vests, gathered all over the country with a singular message to the government- they want President Emmanuel Macron to resign.

As more and more anti-Macron protestors gathered, the protests took a violent turn. Police estimated that as many as 2000 protestors were arrested, roughly 126 people were injured (including 39 police officers) and caused millions of dollars in damage across the city. As many as 8000 police officers were assigned to the protests, and as violence and vandalism ran rampant, officers began to use tear gas and fired rubber bullets into the crowd. Protestors had taken to torching cars in the streets, breaking the windows of storefronts, and even vandalizing famous landmarks such as the Arc de Triomphe.

Protestors interviewed by French news sources expressed a strong resentment of President Macron's growing silence to the sinking French economy. To many, the increasing taxes serve as another example that the administration appears to prioritize the needs of the wealthy and the elite while ignoring the needs of the middle class. In an interview with NPR's Eleanor Beardsley, one protestor named Marie Noelle Santer stated "we have a president who is arrogant and who has pushed us to the limit, abandoning the poor and favoring the rich. What's happening is an insurrection. It's a revolution." The growing animosity towards Emmanuel Macron comes roughly a year and a half after Macron was elected president in surprising fashion. As more and more French citizens struggle financially, many have begun to turn their anger to Macron himself with chants of "Macron Resign!" echoing throughout the streets of Paris.

President Donald Trump took to Twitter to give his opinion on the riots, writing "Very sad day & night in Paris. Maybe it's time to end the ridiculous and extremely expensive Paris Agreement and return money back to the people in the form of lower taxes?". Macron's recent tax increases on gasoline and diesel fuel had caused the national average price of gasoline to grow to the rough equivalent of \$5.54 per gallon for the 2018 average. Protestors are believed to be largely white middle-class citizens that traveled to Paris from all around the country to join in the riots and make their voices heard. Moreover, it isn't simply Macron's policies that have inspired record low approval ratings, but his "elitist personality" that many believe neglects the needs of the middle class.

Macron has been silent so far in the wake of the most violent riots that France has seen in decades, opting only to tweet out his recognition for the good work of the police forces over the course of the weekend. Macron is scheduled to make a statement the morning of December 10th and until then the country is waiting with hope that a dialogue can be opened such that these violent protests may finally come to an end.

We all love to complain about the "gross" food served at our Salmonson Dining Hall, but perhaps this new survey will change your perspective. According to a 2018 survey conducted by Temple University and the Wisconsin HOPE lab, hunger is a pervasive issue across many US college campuses that affects millions of college students. 43,000 students from 66 colleges participated in this survey resulting in a new concerning statistic; 36 percent of these students had trouble getting enough to eat daily.

While some students are lucky to have financial support from their parents to get them through college, many others do not. For example, Cornell student Samuel Isaiah Williams could not afford a meal plan due to rising tuition costs and unexpected health insurance fees. Instead, Mr. Williams scopes out different school events where there might be some free food. To some Cornell student's free food is just a bonus. But to Mr. Williams, it is often dinner. At open mic night, there might be some boxes of pizza, or at a dorm movie night some chicken tenders. He says that at times it is challenging to find food, but Mr. Williams takes anything he can get.

Mr. Williams grew up in Guyana's capital, Georgetown, until his family chose to emigrate to the US in 2008 in search of a better life. His parent's main income came from selling hats from a street vendor in Guyana but wanted their children to have better economic and educational opportunities. When they moved to the US, the Williams family of 13, shared a 2-bedroom apartment in Brooklyn. There he attended Benjamin Banneker Academy and graduated on the honor roll. He was accepted by several prestigious universities but had to make a difficult decision based on the financial aid packages offered to him. Making his final decision to attend Cornell University, the University covered all of his first-year costs. However, due to climbing tuition costs and changing health insurance policies, he was unable to afford a meal plan. Along with taking 5 classes a semester, Mr. Williams had a large workload and did not have time to get a part-time job outside of school. Instead, he relied on canned goods and free food at student events to be his main source of food.

Amazon's profitability skyrockets as holiday shopping hits its peak

The holiday season is upon us and it is business as usual for the online giant Amazon. com. The company recently reported a third-quarter 29% increase in revenues to 56.6 billion dollars, up from 43.7 billion dollars in the third quarter of 2017. Amazon has estimated that their fourth-quarter earnings will be in the range of \$66.5 billion to \$72.5 billion, which is shockingly a modest estimate for them as their fourth-quarter earnings for 2017 were around \$60.5 billion.



Juul: the past year and the future

Juul has become an extremely well-known trend recently especially among young adults. Concerns have been raised about the negative effects of smoking a Juul as it contains high levels of nicotine that have addictive qualities. In an attempt to curve teenage juuling, the FDA banned convenience stores and gas stations from selling flavors such as mango and nectar.

Fruity flavors are considered to be more attractive and kid-friendly. This flavor ban is a step in the right direction but young adults will still find other ways to get fruity flavors. Flavored products will still be sold in vape shops and online stores. The online stores do have strict age verification measures. The FDA's bans on Juul flavors is predicted to have negative effects on the Juul business.

One of the reason's that Juul is popular is due to its flavors. Consumers are attracted to the flavors offered by Juul as they are an alternative to regular vaping and cigarettes. Juul has controlled the majority of the e-cigarette market. These bans on Juul pods could be a good thing for other e-cigarette and vape companies as Juul most likely will take a hit.


Tobacco companies that manufacture their own vape will benefit as well and it is likely that tobacco stocks will see an increase in trading. As Juul continues to dominate the e-cigarette market and grows in popularity, it is reached a \$15 billion valuation. Interestingly enough, Juul was created by a Stanford graduate student as a part of their thesis. In 2007, two Stanford students wanted to create an e-cigarette that would satisfy consumers in similar ways to a cigarette. Their inspiration was the fact that both were avid smokers looking to create an attractive substitute for cigarettes. Juul labs generated \$224 million in retail sales over the past year. The retail price for a Juul is \$35 and a four pack of Juul pods cost \$16. The Juul brand sales blew up 621% year-over-year according to Nielsen data.

The Juul launched in 2015 in a USB drive shape and looks completely different than all other e-cigarettes. Most devices have a cap that needs to be unscrewed and the chamber inside will be filled with liquid.

The creation of Juul is a prime example of how assessing consumer needs before the consumer can recognize the need. The two Stanford students successfully created a quality substitute to smoking that was completely different than existing e-cigarettes available today

This highlights the importance of differentiation in business whether it is a product or service. It is necessary to add value through offering a new product or an existing product in a different way.

It will be interesting to see how the Juul company continues to adjust to the heightening concerns about its health effects. If Juul is able to continue to adapt its product it will most likely continue to be successful.

Puerto Rico's new tax break lures money as an expiration date looms

One of the biggest breaks created by last year's tax law sits in Puerto Rico, a hurricaneravaged island desperate for a recovery. But some residents fear tax history could repeat itself.

President Donald Trump's overhaul sets up "opportunity zones" in underdeveloped economic areas that try to lure investment with the promise of generous tax benefits. Almost all of Puerto Rico was deemed a zone, essentially creating a 3,500-square-mile tax haven that the island's governor hopes will bring more than \$600 million in new investment.

As of now though, the designation is set to expire after 10 years. If that sounds familiar, it's because Puerto Rico has been through this before. A previous corporate tax break led to a pharmaceutical boom, but when it phased out in 2006, the island saw dozens of manufacturers flee the island -- contributing to a fiscal crisis from which it's still recovering.

"Instead of leveraging that break to help local businesses stand on their own feet, we wasted it," said Carlos Serrano, a tax partner at Reichard & Escalera who works with the Puerto Rico Manufacturers Association.

Hurricane Maria exacerbated Puerto Rico's economic woes and devastated its infrastructure, causing an estimated \$90 billion in damage.

To jaded economists who watched the boom and bust, the new law could just be more false hope -- by giving tax breaks to wealthy real estate investors without fostering jobs-creating businesses.

"How do you build a plant that's going to produce something and then in 10 years pack up and leave?" says Zadia Feliciano, a professor at Queens College-City University of New York who has researched previous Puerto Rico tax breaks. Ten years "is not a long time for the kind of investment you have to make."

Puerto Rico has long used tax benefits to lure investment. New residents of Puerto Rico generally don't pay Puerto Rico taxes on passive income or federal income tax, spurring the creation of wealthy enclaves of mainlanders seeking the break. Hedge fund manager John Paulson in November at a conference said he was considering moving to Puerto Rico once his children leave for college.

The island used to have an even larger break for businesses. In the 1920s, Congress created a tax exemption for all income from non-U.S. sources as long as a company received at least 80 percent of its income from U.S. possessions such as Puerto Rico.

Revisions to the law in the 1970s and 1980s restricted it in a way that encouraged jobscreating businesses, and the pharmaceutical industry created thousands of jobs on the island. But between 1995 and 2005, Congress phased out the benefit completely.

Feliciano's research, which compared Puerto Rico to U.S. states that didn't experience the change, estimates that the elimination of the benefit had the effect of cutting manufacturing wages by almost 17 percent and the number of manufacturing businesses by as much as 28 percent.

Unlike when it eliminated the benefit, which caught many manufacturers off guard, Congress created opportunity zones with a built-in expiration date. So instead of setting the island up for a crash once the zones disappear, the tax law might discourage longterm, jobs-creating investments in the first place, according to Feliciano.

Under the opportunity zone provision, investors can take capital gains from asset sales and plow them into funds that buy real estate or invest in businesses in opportunity zones. In turn, they can defer taxes until 2026 and potentially reduce what they owe by as much as 15 percent. If they hold the investment for at least ten years, they can also avoid paying capital gains taxes on the fund's appreciation. The change is estimated to cost \$1.6 billion over a decade.

The zones' expiration dates means that most investors will be focused on buying real estate instead of putting money into new businesses. Giovanni Mendez, a tax attorney in Puerto Rico, said he knows of at least eight funds that are buying up real estate on the island. A New York-based fund, which he declined to identify, has earmarked \$100 million for opportunity zone investments in Puerto Rico.

"Commercial real estate is moving very fast," Mendez said. "There's sort of a frenzy because of this." The IRS recently proposed regulations about opportunity zones, which could also make investments in startups more difficult since a certain percentage of the business's gross income has to come from within the zone. The rules also specify that even if a zone loses its designation after 10 years, investors can generally keep their tax benefits through 2047.

The zones were tucked into last year's tax revamp and were one of the rare features of the law with bipartisan support. Still, critics have said the provision was written so broadly that savvy investors and real estate developers could exploit it for projects they would have done anyway. Treasury Secretary Steven Mnuchin earlier this year predicted the little-known break could attract as much as \$100 billion in investments in total.

Puerto Rico Governor Ricardo Rossello, who supports the island's zone designation, introduced legislation in November that's necessary to extend the capital gains tax breaks for investing in opportunity zones to Puerto Rico residents. The legislation, which is expected to be reintroduced next year, includes extra provisions like expedited permitting processes meant to entice development.

Matt Prober, a commercial real estate adviser and investor, said he and a team of other investors were motivated by the island's opportunity zone status to buy a 17,000-square-foot building in the capital city of San Juan that had been boarded up for about a decade. They bought it for \$600,000 and plan to invest twice as much in construction costs, eventually featuring a restaurant and four floors of office space.

Prober said private equity investors from the U.S. for the past several years had been slowly buying and rehabilitating properties, but with the limited window for opportunity funds, he thinks the pace will quicken. His own team of investors has raised \$25 million for a fund.

"I'm probably as optimistic as I've been for real estate in Puerto Rico in the last 10 years," Prober said, though he added that the short timeline for the break could limit its effectiveness. "I hope the government of Puerto Rico won't just see this as the one and only way out," Prober said. "There are other things they need to do to spur on development."

Google CEO makes a promise to be more transparent about China

Google would like you to know that it is transparent.

This was the mantra repeated over and over by Chief Executive Officer Sundar Pichai when queried by the House Judiciary Committee Tuesday. That was the word he used when asked about everything from the algorithms used to optimize search results to the location data its phones and apps beam back to third-party developers.

The pledge for transparency was most steadfast, however, when Pichai was asked about China. Google has faced a backlash since the reports first surfaced in August about a project known as "Dragonfly," a search engine for China that would help the government censor the web and track its users. "Right now we have no plans to launch in China," Pichai assured lawmakers. But if the company changes its mind, he said, "I will be fully transparent." Corporate pledges of transparency are commonplace (and commonly broken). But Google is a different story. Remember, the public found out about Dragonfly after Google employees leaked the story. As Pichai tried to address the matter internally, more accounts of the debate over Dragonfly made their way into the press. Hundreds of Google employees went public with an open letter urging their bosses to cancel the project. So when Pichai promises transparency, he doesn't really have much of a choice. In this sense, Google is like an elite NBA team: The star talent has more leverage than the managers. If employees decide they no longer want to work at Google, there are plenty of tech companies eager to poach them. So when they don't like something their employer is doing, they question authority. They protest. They leak. That said, Pichai should have had a better answer when it comes to Dragonfly. He could have more fully explained his own thinking about why Google is willing to explore getting back into the Chinese market despite its history there. (Google left China in 2010 after it discovered a hack of its source code and the data of Chinese dissidents).

He did say that Google's "core mission is to provide users with access to information." But he could have also made the case why it is worth taking a risk again in China, and what steps his company would take to protect its intellectual property and its customers' personal data from a voracious Chinese national security state.

Even with such safeguards, it is still not worth it for Google. Instead of exploring how to get back into a country that targets foreign concerns and compels them to abet a Big Brother state, he could redouble his company's efforts to "provide users with access to information" in India, Vietnam and Indonesia.

For now, it's worth taking Pichai at his word when he promises transparency with China. Even if he wanted to keep Google's deliberations secret, his engineers wouldn't let him.

San Diego State's Jalen McDaniels is sued for alleged filming, sharing of sex video

Jalen McDaniels, a sophomore forward on San Diego State's basketball team, has been sued in a Washington civil court for allegedly filming a sexual act with a female student in 2016 while they were seniors at Federal Way High School outside Tacoma, and then sharing it with friends through social media.

Joan Mell, the attorney who filed the civil suit Wednesday in King County Superior Court, said she expects to file another invasion of privacy suit next week against McDaniels and the school district involving a similar incident with a different woman.

Federal Way police investigated the cases twice, once in 2016 and again this fall, and last month recommended two counts of voyeurism against McDaniels. The King County prosecutor, however, declined to press charges, according to attorneys on both sides.

"Jalen is aware of this investigation," said Jeremy Warren, McDaniels' San Diego-based attorney. "In fact, it has gone on for a couple years. The police have looked at it twice, and the D.A.'s office has rejected any criminal charges. He looks forward to his day in court. Right now, he's focused on being the best student and human being he can be." SDSU issued a statement two hours after the suit was filed, indicating that McDaniels would remain in school and part of the basketball team. The decision, said a university source who was not authorized to speak publicly, was made by the athletic department in consultation with high-ranking officials in university administration. "San Diego State University and SDSU Athletics take all allegations of misconduct seriously," the statement said. "An investigation completed by local municipal authorities in Washington state ... resulted in no charges. At this time, there will be no change in the individual's status at the university. The university will continue to monitor the situation." Both women went public with their allegations in October and November but had not previously identified McDaniels, saying only it was a star basketball player on Federal Way High's 2016 state

championship team. The women held will impact him (through) the years, another news conference Wednesday afternoon with Seattle-area television stations to announce the civil suit, and this time named him.

The suit asks for damages "for severe emotional distress past and future" but does not specify monetary amounts.

'Jalen needs to figure out that women matter," said Mell, the attorney for the two women. "It's not about the money. If his paycheck to these women is 5 cents and he has to own the fact that it was wrong, good for him. Because that's what needs to be heard. He needs to acknowledge that you cannot do that, and no other woman should be vulnerable or victimized by Jalen McDaniels.

"If he says he recognizes that's wrong, he's going to get the benefit of not dragging everybody through a long, extended process and the damages are going to be a whole lot less.'

Gwen Gabert said McDaniels, using his mobile phone, filmed her performing a consensual sexual act in a car in January 2016 without her knowledge or permission, then distributed the video to basketball teammates via a group chat. Gabert reported it to Federal Way police three months later, but no charges were brought due to what authorities said was a lack of

maybe impact him forever, because of how serious it is - just have consequences.

"I did nothing wrong. I have consequences for the choice I made on my 18th birthday. I should have been able to make those choices and trust Jalen without having consequences that led me to almost take my life and still to this day be traumatized by what he did."

Thomas' tort claim requires that she wait 60 days before filing civil litigation against the school district. That waiting period expires Friday, and Mell said she has prepared a separate civil suit that names McDaniels, Collins and the school district.

At issue is a February 2016 meeting arranged by Thomas' father with Collins, both players and their fathers after basketball practice as Federal Way High was preparing to play in the state tournament. The Eagles would finish 28-0 and win Washington's 4A championship.

According to the police investigative report, both McDaniels and his teammate apologized, then deleted the video from their phones and instructed anyone else who received it to do so as well. The school district has since placed Collins, a member of the Federal Way Hall of Fame, on administrative leave.

Her investigation included interviews with several of McDaniels' former Federal Way basketball teammates. Some said they had viewed the video; others said they had not but heard about it. Castro was unable to obtain a copy of the video as evidence.

Voyeurism laws in Washington require proof that a video was created for purposes of sexual gratification. A new law targeting the disclosure of intimate images without consent was enacted in 2015 but has a twoyear statute of limitations, which has since expired in this case.

It is unclear whether McDaniels was technically a juvenile or adult at the time of both alleged incidents. Gabert said McDaniels filmed her on Jan. 26, 2016, which was her 18th birthday and five days before McDaniels turned 18. Thomas told police she first became aware of the video involving her on Feb. 13, after McDaniels had turned 18, but was uncertain when it was filmed.

Gabert's civil suit claims Federal Way police contacted SDSU police in September 2016 and requested they "secure" McDaniels' mobile phone, although it does not appear there was a seizure warrant. McDaniels, through an attorney, declined

probable cause.

Last October, another former Federal Way High student filed a \$3.5 million tort claim against Federal Way Public Schools, saying she told boys basketball coach

Jerome Collins about a similar incident and he failed to properly notify authorities.

Tally Thomas said McDaniels filmed her performing a sexual act on one of his teammates from a closet, then distributed it on his phone. Thomas, a star athlete at Federal Way High, received a softball scholarship to play at Stanford but has since left school.

Both Gabert, 20, and Thomas, 19, said they have received therapy for depression, anxiety, eating disorders and other health issues. Both also said they have attempted suicide.

Gabert saw Thomas' interview with a Seattle TV station in October and called her that same day. She hired Mell and decided to pursue a civil case.

"I want him to be held responsible for his actions," Gabert told the Union-Tribune by phone Wednesday afternoon, "and I want him to have something that

Collins was unavailable for comment and has declined to speak with other media outlets when contacted.

After interviewing Bryant Thomas, Tally's father, Federal Way police detective Heather Castro wrote in her report: "Mr. Thomas stated Tally told him repeatedly that she did not want to pursue criminal charges, because it could ruin (the players') lives. He stated he wanted to respect his daughter's wishes and supported her

The investigative report also says the players met with Thomas' mother to apologize, as well as with Thomas and Collins without parents present.

Castro's report says the basketball player who engaged in the sexual act with Thomas (and whose name was redacted) stated: "They decided it was over and they were going to move on with their lives. There was no talk about contacting police. They decided it was a family matter and they resolved it themselves."

After Thomas filed her tort claim in mid-October, a school district attorney reported the alleged incident to Federal April.

to cooperate, and the case was later dropped by Federal Way police.

The 6-foot-10 McDaniels had just arrived on campus and ultimately sat out as a redshirt that season. Steve Fisher, then the head coach, has subsequently said the team might have won "three or four" more games had McDaniels played.

McDaniels made his collegiate debut in 2017-18, starting the final 21 games of the season and averaging 10.5 points and 7.5 rebounds. He provisionally entered the NBA Draft last spring and worked out for more than 10 different teams before withdrawing and returning to SDSU.

This season, he is averaging 14.9 points and 7.8 rebounds for the Aztecs (5-4) through nine games.

McDaniels' younger brother, Jaden, is a currently a senior at Federal Way High and considered a top 5 recruit in the class of 2019. SDSU is among his five finalists, along with Kentucky, Texas, Washington and UCLA. He opted not to sign a national letter of intent in the November window, meaning his next opportunity to sign is

Q&A: UConn coach Geno Auriemma talks managing players and expectations

When coaches reach a certain level of success people want to peek into their minds and see the thinking, planning and strategizing - everything that went into building a winning program.

When I step into Geno Auriemma's office in the middle of November my goals are similar. He's led UConn to 11 national titles and produced some of the greatest women's basketball players ever. From Rebecca Lobo to Diana Taurasi to Maya Moore to Breanna Stewart, he's found a way of coaching that reaches a wide range of vastly different players.


Managing a group of people is a delicate, exhausting process that not everyone is good at. Everyone is different and responds to different leadership tactics. Over the years Auriemma has been described as being too hard on his players by some, while others say he knows exactly how to motivate each player.

I sat down with the UConn coach to get a glimpse into his thoughts on player management, from how he motivates players to how to deal with the lofty expectations that come with playing at UConn. The following is a transcript of that conversation that's been edited for clarity.

Q: When you're working with a lot of different personality types how do you go about choosing who to be more strict with and who to be less strict with?

A: "It's gotten harder and harder over the years to try to figure that out. I think the trick for any coach is to make sure the players understand we're being critical of that basketball play you just made, we're not being critical of you as a person. But, in today's world they have a very difficult time differentiating between the two so the older kids that have been around for a long time have come to understand what means what. And the younger players, they're constantly looking around going 'What does that mean?' And a lot of times it means exactly what it means. What I just said is what I mean, and it has nothing to do with you personally. But in the beginning it's hard for them to separate the two.

'Coaches walk a fine line - I know I do - between do you just let it go and sugarcoat it and then game reality sets in and they're not prepared? Or do you take a shot at it and take the chance that what if they don't respond properly and everybody on the outside world goes 'Oh, you're being too hard on them?' It's a hard game, and it's competition, and it's not for the faint of heart. So you're going to get toughened up How do you manage expectations? somehow. Either the kids are going to be hard on themselves and you can back off or they want to feel sorry for themselves and you have to step in and be hard on them. So the kids that are hard on themselves, I let them alone. They're putting the pressure on themselves that they need to put on themselves. But those guys that pretend 'Oh, I got this,' are the ones you've got to go like 'No, you don't."



really believe in using a lot of positive reinforcement in practice and pointing out each thing a player does right. How do you find a balance between that and criticism?

A: "I think that the reality is everybody likes to hear 'good job' when they've done something really well. Most good players know when they've done something really good because it feels good, they know it, everybody's reacting to it. And you say 'They also need positive affirmation of it.' Good, that's true. Here's the issue that coaches have to deal with right now: A kid makes 10 plays, four of them are really good, six are lousy. Today, a lot of these kids want a big hug and a kiss for doing those four things great. The other six? They want you to completely ignore them as if it never happened, and that's not the way in the real world. The real world is 'I have to fix those six things.' I already know the four things you did well so we've already established what you can do well four out of 10 times. What if those other six times happen in the last minute of a game? So those four things you did right are meaningless, aren't they? o we've got to find a balance always as coaches. How do we manage that? With each kid it's different, but at the same time how many different ways are there to prepare a kid to play under pressure?"


Q: You've won a lot over the years and your fans have gotten used to it. This season you've talked about the possibility of losing a game, which has some of them worried.

Q: There are some coaches who and complaining about 'We didn't win a national championship the last two years.' Ninety percent of the people, maybe more, they just follow the team and they're happy. They like to see us play well, they like to see us win, but they understand there's winning and losing and understand that we've lived in a fairytale world for some time. People lose more games in a week than we've lost in the last five years. That's not the real world. We've created a world that's not real, but yet we live in it and we created it. Anytime somebody complains I don't care how passionate you are go live in the real world and then you'll see how good you have it.

> So what ends up happening for us in our world here in these offices is unless somebody tells us 'Hey did you hear this or see that?' We have no idea. We have no idea. We are really good with our players about 'Hey, just tune out the stuff,' and

so we do the same thing. We manage the expectations of our team for that year. So this year we have certain expectations for our team, and last year was for that team, next year will be for next year's team, and it changes based on what we have. Obviously you want to win a national championship — that's every year — but some years it's more realistic than others. And we've always understood that, and we try to manage it accordingly and we try to manage what the kids go through. I think sometimes people think 'Oh they're college athletes so they're open to whatever criticism because they're public figures." I guess they are; I guess we all are. It's all part of playing at UConn. You're going to get a lot of attention when you win, you're going to get a lot of attention when you don't win. And you can't have one without the other."





A: "We've probably won more than we should've won for anybody's health. What ends up happening is - and this gets lost in the social media world - people get on social media and they go 'Oh my God, this is what the world thinks.' No it's not. Ninety percent of the world isn't putting their thoughts and comments on social media. They're not going on whatever sites





On the holiday classic, 'Baby, It's Cold Outside', getting banned on the radio

Redo the house race in North Carolina

The final undecided seat in the U.S. House of Representatives is now in the hands of the North Carolina Board of Elections and Ethics Enforcement. After refusing to certify the result in the state's 9th Congressional District — where Republican Mark Harris leads by just 905 votes — the board is now investigating allegations of illegal ballot harvesting, tampering with absentee ballots and a leak of early voting results.

The question for North Carolina election officials —and potentially for the new Democratic House majority —is what to do now. Between possibly fraudulent absentee ballots and ballots not cast, there's simply no way to know who actually won. Constitutionally, there is only one credible solution: The general election, and probably the primary, must be re-run in the 9th District.

The House of Representatives, part of the "people's branch," was designed by the framers to be the most democratically accountable part of the federal government. A person must win an election to serve in the House. By way of contrast, the electoral college selects the president and, under the original Constitution, state legislatures selected senators. The 17th Amendment changed Senate elections to a popular vote in 1913, but midterm vacancies can in most states still be filled by an appointee of a state's governor.

that a person who secured the most votes and otherwise met the minimum constitutional requirements of age, citizenship and residency could not be excluded from the House. Chief Justice Earl Warren explained that "a fundamental principle of our representative democracy is, in Hamilton's words, 'that the people should choose whom they please to govern them."

In other words, if a district's voters want to send a scoundrel to represent them, that is their constitutional prerogative —so long as the scoundrel was properly elected.

In North Carolina, the election board can order a new general election if it concludes that the goings-on in the 9th District "taint the result of the entire election and cast doubt on its fairness."

If they refuse, the House is not without recourse. The House Committee on Administration can investigate, and if it harbors doubts in the election's validity, it can (and should) simply declare the seat vacant. That would force North Carolina to hold a new election, including new primaries.

Allegations of tampering with absentee ballots demand a serious response. Even so, making early or absentee voting even more difficult -- in North Carolina or elsewhere -would be a misguided response. Making voting more difficult, through fewer polling stations that generate long waiting lines on election day, actually enables the type of ballot harvesting fraud alleged in this case. If one has to drive 20 miles and then wait for three hours to vote, of course you'd like that nice young woman to come pick up your absentee ballot at your house. When voting is simple, easy and quick, the opportunities for skullduggery shrink. Several western states, including California, Oregon, and Washington, have adopted reliable and easy vote-by-mail programs. In these jurisdictions there were more than a few very close contests, but no credible allegations of widespread election fraud. Moreover, enabling more citizens to vote in House elections would significantly enhance the body's democratic bona fides and better fulfill the framers' intentions. This is an important moment for American democracy. To certify either Republican Mark Harris or his Democratic opponent, Dan McCready, as the winner would be to seat a person whose legitimate election to the House is open to grave doubt. The people of the 9th District have a constitutional right to select a person of their own choosing to represent them. North Carolina needs to permit them to exercise this right in a free and fair election —even if that requires an expensive and time-consuming do-over.

No such provision exists for appointments to the House of Representatives. When a member of the House resigns or dies while in office, a special election must be held to fill the seat — even if this means that the people of a particular district must go without representation for weeks or even months as a result.

The imprimatur of direct democracy is so important, in fact, that a person duly elected to serve must be seated. The House has the constitutional authority to discipline or even expel a member, but only after seating him.

In the 1960s, the House refused to seat New York Rep. Adam Clayton Powell Jr., voting to "exclude" him because of alleged personal and financial misconduct. The House declared the seat vacant and a special election took place. The voters of Powell's district, by an overwhelming margin, again returned him to Congress and that time he was seated.

The exclusion issue, however, went to the Supreme Court. In 1969, the justices held

If a diplomat truly is, as the old saying goes, "an honest man sent abroad to lie for his country," then Secretary of State Mike Pompeo has earned his pay. His speech in Brussels on "Restoring the Role of the Nation-State in the Liberal International Order" deserves a State Department Distinguished Honor Award for Intellectual Dishonesty.

"Multilateralism has too often become viewed as an end unto itself," said Pompeo. "The more treaties we sign, the safer we supposedly are. The more bureaucrats we have, the better the job gets done." Maybe I ran in strange circles during my eight years in the State Department, but few of my colleagues were in thrall to such simplistic thinking.

Pompeo then hurled rhetorical grenades at a row of multilateral bunkers: United Nations peacekeeping missions don't work; the Organization of American States hasn't brought freedom to Cuba; the African Union doesn't advance the mutual interest of its members; the World Bank and International Monetary Fund just make things worse; the European Union puts the interests of its bureaucrats before those of its countries and citizens. Admittedly, each of those institutions is imperfect. But none lives down to the caricatures Pompeo made of them.

Finally, in his own Mount Suribachi moment, Pompeo brazenly planted the flag of American leadership on an international liberal order that this administration has worked harder to blow up than to build. Wisely, he beat a retreat after his speech, taking no questions.

So, let's look at his points one by one. In attacking multilateralism, Pompeo claimed that the Trump administration's mission is "to reassert our sovereignty ... and we want our friends to help us and exert their sovereignty as well." Trump himself played up this same theme at the United Nations General Assembly in September.

But it's not clear that multilateral agreements and institutions have actually done much to abuse U.S. sovereignty. The UN charter, for instance, clearly excludes intervention in any state's domestic affairs. The U.S. veto on the Security Council gives it an unassailable backstop. America has unrivaled voting power in the International Monetary Fund and the World Bank. Many

of the supposed threats to U.S. sovereignty that the Trump administration has cited have been either illusory - such as a hortatory compact on migration the U.S. pulled out of last year - or could be easily countered, such as a possible investigation by the International Criminal Court into U.S. actions in Afghanistan.

For its part, the Trump administration hasn't been shy about trespassing on other countries' sovereignty. Trump has threatened to invade Venezuela and to punish South Africa for its land-reform policies. By the end of 2017, he had also sanctioned nearly 1,000 individuals and entities. Apparently, there are limits to how much other countries can "exert their sovereignty" within their own borders if doing so goes against the interests of the U.S.

The liberal international order actually provides a legal basis for such interventions - if, that is, you're willing to uphold it and play by its rules. The UN Security Council has passed hundreds of Chapter VII resolutions authorizing action to "restore international peace and security." Many investigations and prosecutions by the ICC, to which all NATO members except

Turkey and the U.S. belong, have advanced many U.S. policy interests. Multilateral bodies also provide a forum for resolving lesser disputes. Trump's animus toward the World Trade Organization, for instance, ignores the better than average (and better than China) U.S. winning streak in trade cases.

Even in those situations where international rules may constrain future U.S. behavior, they reflect trade-offs that negotiators have weighed and accepted. As Secretary of State Dean Rusk said to Congress in 1965 about the thousands of treaties and agreements that the U.S. had inked in the previous two decades, "We are constantly enlarging our own freedom by being able to predict what others are going to do."


At their best, multilateral institutions allow their member states to leverage national power. Twice in the last decade, the U.S. Government Accountability Office has compared the cost of UN peacekeeping missions to U.S. boots on the ground and found them to be a much more cost-effective alternative. Fittingly, two days after Pompeo blasted his hosts at the EU for shortchanging the interests

of its members' citizens, news broke of a massive, multi-nation EU-coordinated raid on the 'Ndrangheta crime syndicate in Italy — the kind of bust that no country can mount on its own.

Do multilateral institutions need review, reform and renewal? Well, what institution doesn't? And as the largest funder from 2014 to 2016 for 24 out of 53 leading UN and non-UN multilateral institutions (compared with nine each for Japan and the U.K.), the U.S. has a strong interest in making sure they work effectively and advance the interests of member states.

But the way to do that isn't to browbeat them, or to take your ball and go home when things don't go your way. For all the weaknesses of the UN Human Rights Council, the U.S. withdrawal (Iceland took its place) won't make it better, and makes it even less likely that offenders will be held to account. Moreover, China and Russia are busy building their own multilateral bodies or suborning existing ones like Interpol.

Pompeo claimed that the U.S. wants to create international organizations "that deliver on their stated missions, and that create value for the liberal order and for the world." But the administration's drastic budget cuts to the State Department and international organizations (which a more multilaterally-minded Congress has blunted) and its preference for bilateral over multilateral deals suggest it would rather they withered on the vine. Equally toxic has been Trump's disdain for the work of experts and seasoned public servants - witness his recent repudiation of a searing U.S. government report on



climate change's economic impact.

One of my wonkiest jobs as a Foreign Service Officer at the U.S. Embassy in Tokyo was to cover Japan's conduct in commodities groups such as the International Tropical Timber Organization, the International Coffee Organization and the now-defunct International Natural Rubber Organization. I never became an expert, though I did come to understand why Japan has such good coffee. I did, however, develop a healthy respect for the wonks, nerds and gnomes who inhabit the multilateral garden, tending to their countries' national interests while advancing the greater common good. They need and deserve your support, Mr. Secretary, not your contempt.

Pompeo taking the Oath of Office (Getty Images)






